Background/History



- 2021
 - ENVS Chair requested policy recommendations from staff concerning gas-powered landscape equipment.
- 2022
 - Environmental Health Committee recommended phasing out gaspowered landscape equipment.
 - OEQS briefed ENVS Committee on landscaping equipment policy.
 - EVC provided formal recommendations to ENVS Committee
 - ENVS Chair requested landscape equipment transition plan by June 2023
- 2023
 - SB 1017 passed
 - Council approved \$750,000 for LET to focus on encouraging residents to transition to electric landscaping equipment.

Background/History

Program Cost Analysis

There are approximately 220,000 single-family residences in the City of Dallas. 40 Based on the residential survey results, approximately 92% of residents living in single-family homes perform their own lawn care at least some of the time. Using this data, approximately 201,000 homes in Dallas own at least some lawn equipment. Below is an assessment of estimated gas-powered equipment distribution among Dallas residents, recommended rebate amounts, and associated costs.

City of Dallas 2023 Heat Island Study Results

Introduction

In summer 2023, The City of Dallas and 18 other communities joined the National Oceanic and Atmospheric Administration (NOAA) to collect data to map where people are most at risk during extreme heat events. The Urban Heat Island (UHI) mapping campaign addresses extreme heat, the number one weather-related cause of death in the U.S. for the last three decades. Urban heat islands — areas with fewer trees and more pavement that absorbs heat — can be up to 20 degrees Fahrenheit hotter than nearby neighborhoods with more trees, grass, and less black asphalt.

On August 5, 2023, approximately 70 community volunteers, including City of Dallas Staff, City of Dallas residents, DFW residents and families, and college students, recorded ambient temperature and humidity data as they drove nine routes covering 103.3 square miles of the City. Volunteers mounted sensors onto their vehicles to capture data at three different times of the day – morning, afternoon, and evening. Volunteers took 60,040 measurements on campaign day, and the max differential temperature was 10 F. The maximum temperature recorded was 110.1 F.

The objectives of the study were to collect heat measurements across neighborhoods in the city, develop high resolution maps of air temperature and heat index, and ultimately better understand and address the risks from extreme heat.

Results

The hottest areas include:

- Love Field- Districts 6 and 2
- Medical District- District 2
- Uptown- District 14
- Oak Lawn- District 14
- Downtown- District 14
- Deep Ellum- District 2
- Design District- District 6
- West Dallas- District 6
- Bishop Arts- District 1
- Stemmons/Market Center- District 6

The hottest areas were also examined for environmental justice (EJ) concerns. The areas identified in bold contain EJ neighborhoods. This additional information is critical to better serve our communities, and data will be used to provide heat solutions in the City of Dallas.

SUBJECT City of Dallas 2023 Heat Island Study Results

This data will help us advance climate mitigation, climate adaptation, environmental quality, and environmental justice goals and actions under the CECAP and Racial Equity Plan. For example, data will support:

- CECAP Goal 1, 2
 - Prioritizing areas for weatherization and solar projects
- CECAP Goal 6
 - o Reduce the urban heat island effect
 - Increasing Green infrastructure and tree canopy
- CECAP Goal 7
 - o Increasing urban agriculture
 - o Increasing the use of other smart surfaces (e.g., light surfaces)

Next Steps:

The Office of Environmental Quality and Sustainability plans to map the remainder of the city in summer 2024.

SUBJECT Brownfields Redevelopment Program (BRP) Quarterly Update

Background

In May 2023, the US. Environmental Protection Agency (EPA) awarded \$1.5M in grant funding to the City of Dallas. The City received \$1M for a Revolving Loan Fund (RLF) Grant, and \$500K for a Community-wide Assessment (CWA) Grant. The RLF Grant provides funding for site cleanup and remediation, while the CWA Grant provides funding for site assessment and remediation planning.

The Brownfields Redevelopment Program (BRP) works with the EPA, City of Dallas, and community stakeholders to address environmental obstacles that can hinder community revitalization and development. The BRP aims to drive sustainable economic growth to ensure a safe, clean environment, and improve quality of life for Dallas residents, particularly those living in historically disadvantaged communities such as south Dallas, Fair Park, and MLK Corridor. All areas within the geographic boundary of Dallas will be considered for brownfields funding.

The EPA Cooperative Agreement for both grants was accepted and approved by Dallas City Council in November 2023.

BRP Quarterly Update:

EPA Funding Approvals

The BRP received EPA funding approvals for both Assessment Grants and Cleanup Grants.

- RLF Grant, in March 2024, the BRP received EPA funding approval to provide ABCA (Analysis of Brownfield Cleanup Alternatives), Section 106 Historical preservation study, and site cleanup and abatement for the historic Melissa Pierce School Project in Joppa. The ABCA and Section 106 study are currently underway. A community involvement plan for this project is currently being drafted per EPA guidelines and should be completed ahead of the commencement of site cleanup activities. This site will be revitalized into a multipurpose center for the Joppa community.
- Additional site nominations from prospective sites are expected in the coming months. A second site nomination from the Forest Forward District is currently under review.

SUBJECT

 CWA Grant, in February 2024, the BRP received EPA funding approval for the MLK Gateway Park to conduct Phase I ESA and Phase II ESA (if needed). Site assessment activities commenced in late March. Gateway Park will be revitalized into an interactive public park for the Fair Park neighborhood. Additional site nominations from prospective sites are expected in the coming months

Community Engagement

- Held 2 quarterly meetings with Brownfield Advisory Committee Members and RLF Committee Members for stakeholder feedback.
- 10 site visits and community engagement events in Fair Park, South Dallas, MLK Corridor, Forest District and Jeffries Meyers neighborhoods. A Brownfields Prospective site revitalization tour is planned for April 15, 2024. On demand site visits are provided to stakeholders upon request.

GIS Update

The BRP partnered with Groundworks USA to assist with mapping brownfield properties within Dallas city limits. The goal of this map is to track properties that have utilized the BRP EPA grants and their status. In addition, the map will include brownfield properties that have been assessed and/or remediated in previous years by the City of Dallas.

Website

The BRP is continuously building the brownfields website. Our focus is to build a public resource library that contains information regarding the basics of brownfields, common contaminants, effective remediation techniques, and other brownfields related information.

Training

The BRP is working on providing environmental and redevelopment training for our stakeholders that will serve as a supplement to the information on the website.

Additional opportunities

- The BRP partnered with Groundwork USA for free technical assistance and community engagement planning.
- The BRP is collaborating with the University of Texas at Dallas for the first ever Brownfield Capstone Program between UTD MPA Students, EPA, and the City. The Capstone students are working on the City of Dallas Brownfields Strategic Plan.
