**WHEREAS**, the Department of Aviation wants to provide passenger transportation service concessions at Dallas Love Field that include specific in-terminal customer service options inside of baggage claim and dedicated vehicle slots on the lower level outside baggage claim; and

**WHEREAS**, Alto Operations Texas LLC (“Alto”), a transportation for hire company permitted through the State of Texas as a Transportation Network Company, provides passenger transportation services at Dallas Love Field through application-based reservations, and through in-person arrangements at the baggage claim counter under a month-to-month lease agreement effective May 1, 2022; and

**WHEREAS**, Irving Holdings, Inc. (“Irving”), permitted through the City of Dallas under Chapter 47A of the Dallas City Code, has been operating at the airport as a transportation for hire company; and

**WHEREAS**, a Request for Competitive Sealed Proposals was issued for Transportation-For-Hire-Services, Solicitation Number BI23-00022276, which required, among other things adherence to applicable provisions of Chapter 47A (Transportation For Hire), as amended, and applicable provisions of Chapter 5 (Aircraft and Airports) of the Dallas City Code; and

**WHEREAS**, Alto and Irving were selected as the most advantageous proposers based on the procurement criteria; and

**WHEREAS**, Alto and Irving were the two proposers that were recommended for council approval to each be allocated two baggage claim counter locations and two associated vehicular curb locations under a concession contract for each entity; and

**WHEREAS**, Alto and Irving will assist passengers in obtaining their transportation needs from their counter location by either staffed or installed electronic application; and

**WHEREAS**, each concession contract will have a primary term of five (5) years with three (3) two-year renewal options, with an estimated revenue of 1) Alto Operations LLC - \$287,852.00; and 2) Irving Holdings, Inc. - \$222,000.00.

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:**

**SECTION 1.** That the City Manager is hereby authorized to execute two concession contracts, approved as to form by the City Attorney, each for a term of five (5) years, with three (3) two-year renewal options, with Alto Operations Texas LLC, with an estimated revenue of \$287,852.00 (VS85745), and Irving Holdings, Inc., with an estimated revenue of \$222,000.00 (VS93398), for the operation of transportation for hire services from designated curbside and indoor spaces at Dallas Love Field Airport, for a total estimated revenue of \$509,852.00.

**SECTION 2.** That the Chief Financial Officer is hereby authorized to receive funds in an estimated amount of \$509,852.00, Revenue Fund, Department AVI; Fund 0130; Unit 7709, Revenue Code 7814 from concession Contract No. AVI-2023-00022276.

**SECTION 3.** That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
