WHEREAS, on April 24, 2019, City Council authorized a professional services contract with Dannenbaum Engineering Company–Dallas, LLC for engineering services required to design and construct storm sewer infrastructure improvements at two locations, Throckmorton-Reagan and Rawlins-Douglas to Knight; and

WHEREAS, engineering evaluations have determined that it is necessary to upgrade existing storm sewer trunk lines, laterals, and inlets upstream of the target area to relieve localized flooding and property damage; and

WHEREAS, additional engineering services are required for hydraulic modeling, preliminary design, and the development of construction plans and specifications for upstream drainage improvements to resolve existing flooding issues; and

WHEREAS, Dannenbaum Engineering Company–Dallas, LLC, 3030 Lyndon B. Johnson Freeway Suite 910, Dallas, Texas 75234, has submitted an acceptable proposal to provide these engineering services; and

WHEREAS, Dallas Water Utilities recommends that Contract No. 19-081E be increased by \$407,282.00, from \$340,199.00 to \$747,481.00.

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the proposed Supplemental Agreement No. 1 to the professional services contract be accepted and that Contract No. 19-081E with Dannenbaum Engineering Company–Dallas, LLC, be revised accordingly.

SECTION 2. That the City Manager is hereby authorized to execute Supplemental Agreement No. 1 to the professional services contract with Dannenbaum Engineering Company–Dallas, LLC, approved as to form by the City Attorney, to provide additional engineering services required for hydraulic modeling, preliminary design, and the development of construction plans and specifications for drainage improvements at two locations, in an amount not to exceed \$407,282.00, increasing the contract amount from \$340,199.00 to \$747,481.00.

SECTION 3. That the Chief Financial Officer is hereby authorized to disburse funds in an amount not to exceed \$407,282.00 to Dannenbaum Engineering Company–Dallas, LLC, as follows:
