In accordance with the provisions of Section 51A-9.302 of the City of Dallas Development Code, please proceed with the process for the consideration of the street name change of 2100-2400 Block of Locust to Frank H. Henderson Drive.

Pastor Frank Henderson through the Southern Crest Full Gospel Baptist Church has been a beacon of light for this community for over 35+ years.

In his 35 + years of community service and as pastor at the Southern Crest Full Gospel Baptist Church to more than six thousand members with many ministers accepted their calling.

Under Pastor Henderson's leadership ten (10) nursing homes were adopted where ministers and deacons visit twice a month and minister to the residents.

It is bordered on the west side by Gladewater (intersection) where the 2200 block begins, and it ends at the 2400 block where it intersects with Aztec. Between the 2200 & 2300 blocks is Garrison St. and between the 2300 and 2400 blocks is Dalton St. The 2300 block is all church buildings on the north side and the south side of the 2300 block has 2 church owned parking lots with 3 private homes in between the 2 lots.
