### **BACKGROUND**

In anticipation of long-term pandemic expenses, the Dallas Police Department applied for additional funding in May 2020 to support future purchases of personal protective equipment (PPE) in FY21. The City of Dallas Police Department will use CESF funding for PPE (including gloves and masks), hand sanitizer, disinfectant cleaner, and antibacterial wipes for the Dallas Police Department. These purchases will help to limit the spread of bacteria and viruses such as COVID-19 in city facilities, and from person-to-person.
