SECTION 2. That the City Manager is hereby authorized to execute a construction contract with Ark Contracting Services, LLC., approved as to form by the City Attorney, for the installation of water, wastewater, and storm sewer mains at 23 locations, in an amount not to exceed \$13,034,855.00.
