Bryan's revised map of 63 acres of Dallas Land and Loan Company Addition No. 3, being the southeast corner of Lot 10, Block 191/3250 of said George J. Bryan's revised map of 63 acres of Dallas Land and Loan Company Addition No. 3, from which a 1/2 inch iron rod with yellow cap stamped "ROOME" found (controlling monument), bears South 89 degrees 19 minutes 13 seconds West, a distance of 93.59 feet, being the southeast corner of Lot 8, Block 23/3278 of Winnetka Heights Addition, an addition to the City of Dallas, Dallas County, Texas, according to the map recorded in Volume 1, Page 194, Map Records, Dallas County, Texas, and being the southwest corner of Lot 9, Block 191/3250 of said George J. Bryan's revised map of 63 acres of Dallas Land and Loan Company Addition No. 3, and lying on the north right-of-way line of said 10th Street;

THENCE North 00 degrees 39 minutes 10 seconds West, along the east line of said Lot 10, Block 191/3250 and along the west right-of-way line of said Polk Street, a distance of 194.50 feet to a 1/2 inch iron rod with 3-1/4 inch metallic disk stamped "WHIII & RPLS 5299" found for corner at the northeast corner of Lot 9D, Block 191/3250, of Winnetka Highlands Homestead Phase I, an addition to the City of Dallas, Dallas County, Texas, according to the map or plat thereof recorded in Instrument No. 201900216823, Official Public Records, Dallas County, Texas and being the southeast corner of said 20 foot Alley and the POINT OF BEGINNING;

THENCE South 89 degrees 19 minutes 13 seconds West, along the south right-of-way line of said 20 foot Alley, and along the north line of said Lot 9D, Block 191/3250, a distance of 92.17 feet to a 1/2 inch iron rod with 3-1/4 inch metallic disk stamped "WHIII & RPLS 5299" found for corner, being the southwest corner of said 20 foot Alley, and lying on the east line of Lot 5, Block 23/3278 of said Winnetka Heights Addition and being the northwest corner of said Lot 9D, Block 191/3250;

THENCE North 00 degrees 14 minutes 00 seconds West, along the west right-of-way line of said 20 foot Alley, and along the east line of said Lot 5, Block 23/3278 of Winnetka Heights Addition, a distance of 20.00 feet to a 1/2 inch iron rod with 3-1/4 inch metallic disk stamped "WHIII & RPLS 5299" found for corner, being the northwest corner of said 20 foot Alley, and lying on the east line of Lot 4, Block 23/3278 of said Winnetka Heights Addition, also being the southwest corner of Lot 11A, Block 191/3250 of said Winnetka Highlands Homestead Phase I;

THENCE North 89 degrees 19 minutes 13 seconds East, along the north right-of-way line of said 20 foot Alley, common with the south line of said Lot 11A, Block 191/3250 of said Winnetka Highlands Homestead Phase I, a distance of 92.02 feet to a 1/2 inch iron rod with 3-1/4 inch metallic disk stamped "WHIII & RPLS 5299" found, being the northeast corner of said 20 foot Alley and the southeast corner of said Lot 11A, Block 191/3250 of Winnetka Highlands Homestead Phase I, and lying on the west right-of-way line of said Polk Street;

THENCE South 00 degrees 39 minutes 10 seconds East, with the east line of said 20 foot Alley, along the west right-of-way line of said Polk Street, a distance of 20.00 feet to the POINT OF BEGINNING and containing 1,842 square feet or an 0.0423 acre of

land.
