Authorize one year contract, with one twelve-month renewal option contingent upon performance and subject to appropriation, with CitySquare, to implement Track 3 of the Homeless Solutions Strategy by providing move-in and rental assistance for eligible individuals and families in need of temporary assistance and mitigation funds to landlords that reserve units for eligible individuals and families experiencing homelessness ("the Landlord Subsidized Leasing Program") for the period October 1, 2020 through September 30, 2021 – Not to exceed \$1,300,000.00 – Financing: Operating Carryover

This program provides financial assistance for eligible homeless persons and risk mitigation funds for landlords, to address challenges faced by persons experiencing homelessness as they navigate the rental market. The project offers two-part assistance. Part one is the risk mitigation funds that will be paid to qualifying landlords which includes holding fees, damage claims, and vacancy loss. Part two is the Move-in assistance that will be paid on behalf of the tenant which includes security deposits and utility assistance as well as Rental assistance that is paid directly to landlord.

City Square will assume all rental payments and will provide case management and administrative staff for the Project.

- will provide 75 additional units of Supportive housing to the Dallas Homeless Response Systems inventory
- will place 25 homeless single females and 50 homeless families into housing
- Of the 75 homeless households placed into housing through the program 85% will remained housed for six months or more.
