WHEREAS, on August 11, 2010, City Council authorized a four-year master agreement for law enforcement equipment accessories for the Dallas Police Department with GT Distributors, Inc. in the amount of \$2,118,452 and C & G Police Supply dba C & G Wholesale in the amount of \$22,400, in a total amount not to exceed \$2,140,852, by Resolution No. 10-1940; and

WHEREAS, on July 25, 2014, Administrative Action No. 14-6313 authorized to extend the master agreement for two years with C & G Police Supply dba C & G Wholesale from August 10, 2014 to August 10, 2016, with zero cost, having no effect on the contract amount; and

WHEREAS, on July 25, 2014, Administrative Action No. 14-6315 authorized to extend the master agreement for two years with GT Distributors, Inc. from August 10, 2014 to August 10, 2016, with zero cost, having no effect on the contract amount; and

WHEREAS, on July 11, 2016, Administrative Action No. 16-6292 authorized to extend the master agreement for one year with C & G Police Supply dba C & G Wholesale from August 10, 2016 to August 10, 2017, with zero cost, having no effect on the contract amount; and

WHEREAS, on July 11, 2016, Administrative Action No. 16-6297 authorized to extend the master agreement for one year with GT Distributors, Inc. from August 10, 2016 to August 10, 2017, with zero cost, having no effect on the contract amount; and

WHEREAS, on March 24, 2017, Administrative Action No. 17-5741 authorized to extend the master agreement for one year with C & G Police Supply dba C & G Wholesale from August 10, 2017 to August 10, 2018, with zero cost, having no effect on the contract amount; and

WHEREAS, on March 24, 2017, Administrative Action No. 17-5742 authorized to extend the master agreement for one year with GT Distributors, Inc. from August 10, 2017 to August 10, 2018, with zero cost, having no effect on the contract amount.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That a master agreement for the purchase of law enforcement equipment for the Police Department is authorized with GT Distributors, Inc. (500130) in the estimated amount of \$1,457,858, CG Wholesale LLC (VC19024) in the estimated amount of \$288,000, Tactical Medical Solutions, Inc. dba Tramedic Solutions, Inc. (VS0000025312) in the estimated amount of \$182,000, Galls, LLC dba Red the Uniform Tailor (500101) in the estimated amount of \$101,505, and ProForce Marketing, Inc. dba ProForce Law Enforcement (VS0000041871) in the estimated amount of \$52,000, approved as to form by the City Attorney, for a term of four years, in a total estimated amount of \$2,081,363. The amount payable pursuant to this master agreement may exceed the estimated amount, but may not exceed the amount of budgetary appropriations for this master agreement during its term. The City Manager is further authorized, in the City Manager's sole discretion, to exercise an option to extend the agreement for six months by filing a notice of extension with the City Secretary's Office.

SECTION 2. That the Purchasing Agent is authorized, upon appropriate request and documented need by a user department, to issue a purchase order for law enforcement equipment for the Police Department. If a written contract is required or requested for any or all purchases of law enforcement equipment for the Police Department under the master agreement instead of individual purchase orders, the City Manager is hereby authorized to execute a contract, approved as to form by the City Attorney.

SECTION 3. That the Chief Financial Officer is hereby authorized to disburse funds in an estimated amount of at least \$2,081,363, but not more than the amount of budgetary appropriations for this master agreement during its term to GT Distributors, Inc, CG Wholesale LLC, Tactical Medical Solutions, Inc. dba Tramedic Solutions, Inc., Galls, LLC dba Red the Uniform Tailor, and ProForce Marketing, Inc. dba ProForce Law Enforcement from Master Agreement Contract No. DPD-2020-00014532.

SECTION 4. That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
