WHEREAS, on January 10, 2001, City Council authorized a master agreement with Dallas County governing future transportation major capital improvements projects between the City of Dallas and Dallas County by Resolution No. 01-0104; and

WHEREAS, on April 11, 2001, City Council authorized the submission of candidate projects, including the Camp Wisdom Road Project from Carrier Parkway to Farm-to-Market (FM) 1382 to Dallas County's Major Capital Improvement Program Second (2001) Call for Projects by Resolution No. 01-1219; and

WHEREAS, on April 13, 2011, City Council authorized a new ten-year Master Agreement governing Transportation Major Capital Improvement Program with Dallas County by Resolution No. 11-0927; and

WHEREAS, on January 27, 2016, City Council amended the City of Dallas Thoroughfare Plan to change the dimensional classification of Camp Wisdom Road within the city of Dallas from a standard six-lane divided roadway to a special four-lane undivided roadway with bicycle and pedestrian facilities by Resolution No. 16-0208; and

WHEREAS, on June 14, 2017, City Council authorized (1) a Project Specific Agreement with Dallas County for the design and construction of paving and drainage improvements on Camp Wisdom Road from Carrier Parkway to Farm-to-Market (FM) 1382; (2) reprogramming of available funds from the Merrifield Road from east of Mountain Creek Parkway to Grady Niblo Road Project (\$250,000.00) and the Ledbetter Drive Extension/Grady Niblo Road from Merrifield Road to Mountain Creek Parkway Project (\$1,050,000.00) for the Camp Wisdom Road from Carrier Parkway to FM 1382 Project; and (3) payment to Dallas County for the City's share of design and construction costs in an amount not to exceed \$1,300,000.00 by Resolution No. 17-0930; and

WHEREAS, Dallas County is the lead agency to administer the design and construction of the Camp Wisdom Road Project and has received the lowest responsive bid that is higher than the engineering's estimate; and

WHEREAS, it is now necessary to authorize the First Amendment to the Project Specific Agreement with Dallas County for the design and construction of paving and drainage improvements on Camp Wisdom Road from Carrier Parkway to FM 1382 to reflect the increase in the estimated total project cost from \$15,800,000.00 to \$26,641,056.00 and revise the funding participation; and

WHEREAS, the revised total project cost will be funded by the City of Grand Prairie (\$5,350,000.00), Dallas County (\$9,543,117.00), and Texas Department of Transportation (\$10,447,939.00), and the City of Dallas' share of project cost remains unchanged at \$1,300,000.00.

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the City Manager is hereby authorized to execute the First Amendment to the Project Specific Agreement with Dallas County for the design and construction of paving and drainage improvements on Camp Wisdom Road from Carrier Parkway to Farm-to-Market 1382, approved as to form by the City Attorney, to reflect the increase in the estimated total project cost from \$15,800,000.00 to \$26,641,056.00 and revise funding participation with no cost increase to the City of Dallas.

SECTION 2. That this contract is designated as Contract No. PBW-2021-00015385.

SECTION 3. That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
