WHEREAS, a lawsuit styled Ignacio Cuevas and Rita Cuevas, Individually and as Next Friend of M.C., a minor v. Darrell A. Gatson and City of Dallas, Cause No. DC-23-01480 was filed by the plaintiffs, Ignacio Cuevas and Rita Cuevas, individually and as next friend of M.C., a minor, seeking compensation from the City of Dallas for alleged bodily injuries and other damages sustained in an automobile collision on March 12, 2021, involving a Dallas Department of Sanitation Services employee operating a city-owned vehicle; and

**WHEREAS**, the plaintiff, Ignacio Cuevas, has agreed to a proposed settlement of his claims whereby the City will pay Ignacio Cuevas, RolleEaton Law, and all other persons having an interest in the settlement proceeds, the total amount of \$43,000.00; and

**WHEREAS,** the plaintiff, Rita Cuevas, has agreed to a proposed settlement of her claims whereby the City will pay Rita Cuevas, RolleEaton Law, and all other persons having an interest in the settlement proceeds, the total amount of \$48,000.00; and

**WHEREAS**, it is in the City's best interest to settle the claims of Ignacio and Rita Cuevas in this lawsuit.

Now, Therefore,

## BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

**SECTION 1.** That the proposed settlement of the claims filed by Ignacio Cuevas in the lawsuit styled <u>Ignacio Cuevas and Rita Cuevas</u>, <u>Individually and as Next Friend of M.C.</u>, <u>a minor v. Darrell A. Gatson and City of Dallas</u>, DC-23-01480, in an amount not to exceed \$43,000.00 is hereby approved.

**SECTION 2.** That the proposed settlement of the claims filed by Rita Cuevas in the lawsuit styled <u>Ignacio Cuevas and Rita Cuevas</u>, <u>Individually and as Next Friend of M.C.</u>, <u>a minor v. Darrell A. Gatson and City of Dallas</u>, DC-23-01480, in an amount not to exceed \$48,000.00 is hereby approved.

**SECTION 3.** That the Chief Financial Officer is hereby authorized to pay Ignacio Cuevas, RolleEaton Law, and all other persons having an interest in the settlement proceeds, the total amount of \$43,000.00 from the Liability Reserve Fund, Fund 0192, Department ORM, Unit 3890, Object 3521, Vendor MVORM001.

**SECTION 4.** That the Chief Financial Officer is hereby authorized to pay Rita Cuevas, RolleEaton Law, and all other persons having an interest in the settlement proceeds, the total amount of \$48,000.00 from the Liability Reserve Fund, Fund 0192, Department ORM, Unit 3890, Object 3521, Vendor MVORM001.

**SECTION 5.** That this resolution shall take effect immediately from and after its passage per the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
