Dustin Dillard, Danny Vasquez, Raymond Dominguez, Domingo Rivera, Kevin Mansell, Glenn Johnson, Criminal Investigative Unit, LLC, Civil Action No. 3:16-CV-03089-N was filed by plaintiffs Vicki Timpa, Individually and as Representative of the Estate of Anthony Timpa, and Cheryll Timpa, Individually and as Next Friend of K.T., a Minor Child, and whereas Plaintiff Joe Timpa intervened in said lawsuit; and whereas plaintiffs were seeking compensation from City employees Dustin Dillard, Raymond Dominguez, Kevin Mansell, and Danny Vasquez, for alleged injuries and other damages sustained during the seizure of Anthony Timpa on August 10, 2016; and

WHEREAS, Plaintiffs Vicki Timpa, Individually and as Representative of the Estate of Anthony Timpa, and Cheryll Timpa, as Next Friend of K.T., a Minor Child have agreed to a proposed settlement of their claims whereby the City will pay Vicki Timpa, Individually and as Representative of the Estate of Anthony Timpa, Cheryll Timpa, as Next Friend of K.T., a Minor Child, Geoff Henley, Henley & Henley, P.C., and all other persons having an interest in the settlement proceeds, the total amount of \$2,500,000.00 and

**WHEREAS,** it is in the best interest of the City to settle the claims of Vicki Timpa, Individually and as Representative of the Estate of Anthony Timpa, and Cheryll Timpa, as Next Friend of K.T., a Minor Child, in this lawsuit.

Now, Therefore,

## BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

**SECTION 1.** That the proposed partial settlement of the lawsuit styled <u>Vicki Timpa</u>, <u>Individually and as Representative of the Estate of Anthony Timpa</u>, <u>and Cheryll Timpa</u>, <u>Individually and as Next Friend of K.T., a Minor Child v. Dustin Dillard, Danny Vasquez</u>, <u>Raymond Dominguez</u>, <u>Domingo Rivera</u>, <u>Kevin Mansell</u>, <u>Glenn Johnson</u>, <u>Criminal Investigative Unit</u>, <u>LLC</u>, Civil Action No. 3:16-CV-03089-N, in an amount not to exceed \$2,500,000.00 is hereby approved.

**SECTION 2.** That the Chief Financial Officer is hereby authorized to pay Vicki Timpa, Individually and as Representative of the Estate of Anthony Timpa, and Cheryl Timpa, as Next Friend of K.T., a Minor Child, Geoff Henley, Henley & Henley, P.C., and all other persons having an interest in the settlement proceeds, the amount of \$2,500,000.00 from the Liability Reserve Fund, Fund 0192, Department ORM, Unit 3890, Object 3521, Vendor MVORM001.

**SECTION 3.** That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
