**WHEREAS**, Chapter 59 of the Texas Code of Criminal Procedure, entitled “Forfeiture of Contraband” provides for the forfeiture to the State of Texas of property determined to be contraband as defined therein; and

**WHEREAS**, Article 59.06 of Chapter 59 of the Texas Code Criminal Procedure (TCCP) authorizes local agreements between the attorney representing the state and law enforcement agencies to affect the disposition of forfeited contraband; and

**WHEREAS**, the [Office of the District Attorney for Kaufman County](#) represents the State of Texas in forfeiture proceedings involving contraband seized pursuant to Chapter 59 of the Texas Code of Criminal Procedure; and

**WHEREAS**, the Dallas Police Department and [Office of the District Attorney for Kaufman County](#) desire to enter into a local agreement regarding the disposition of contraband seized and forfeited under Chapter 59 of the Texas Code of Criminal Procedure; and

**WHEREAS**, Article 59.06 of Chapter 59 of the Texas Code of Criminal Procedure ~~has~~ authorizes~~d~~ the Dallas Police Department as the law enforcement agency and the [Office of the District Attorney for Kaufman County](#) as the attorney representing the state to execute this Agreement; and

**WHEREAS**, the terms of this Agreement shall apply only to those cases where~~in the~~ contraband is finally forfeited, and the cases are closed by the [Office of the District Attorney for Kaufman County](#) on or after the Effective Date of this [Interlocal](#) Agreement.

**Now, Therefore,**

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:**

**SECTION 1.** That the City Manager is hereby authorized to execute ~~this an i~~Interlocal ~~a~~Agreement between [Office of the District Attorney for Kaufman County](#), [State of Texas](#), ~~Criminal District Attorney’s Office~~ and the Dallas Police Department, [pursuant](#) to ~~identify the disposition of proceeds from contraband seized and forfeited under~~ Chapter 59 of the Texas Code of Criminal Procedure, [and to execute any and all documents required by thi](#) [Interlocal Agreement](#), ~~approved as to form by the City Attorney, with a term for this~~ [Interlocal Agreement of five years, approved as to form by the City Attorney](#), ~~and execute any and all documents required by the Interlocal Agreement.~~

**SECTION 2.** That the Chief Financial Officer is hereby authorized to receive and deposit proceeds through asset seizures and forfeitures under Chapter 59 of the Texas Code [of](#) Criminal Procedure in [the](#) Confiscated Monies-State Fund, Fund 0411, Department DPD, Unit 6367, Revenue Code 8473 to be used by the Dallas Police Department solely for law enforcement purposes in accordance with Chapter 59 of the Texas Code of Criminal Procedure.

**SECTION 4.** That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
