REQUEST: An application to change the portion of Jim Miller Road between Great Trinity Forest Way and Highland Road to “Santos Rodriguez Road”.

SUMMARY:

- City of Dallas received a City Council memorandum on September 29, 2023, to consider changing the name of a portion of Jim Miller Road between Great Trinity Forest Way and Highland Road to “Santos Rodriguez Road”.
- Notices were sent on December 15, 2023, to 340 property owners notifying them of the proposed street name change. Notification signs were put up on October 27, 2023, and the newspaper notice was published on December 17, 2023.
- The Subdivision Review Committee on Thursday November 16, 2023, by unanimous vote recommended denial of the Street Name Change NC234-001.

STAFF ANALYSIS:

“Section 51A-9.304. STANDARDS FOR STREET NAMES AND STREET NAME CHANGES” are attached at the end of this report.

Street Name Change: In terms of compliance with Division 51A-9.300 of the Dallas Development Code, staff observes the following:

Section 51A-9.304(a)(5) states “A street name may not contain more than 14 characters providing; however, that the street-type designation may be abbreviated to comply with this requirement.”

The proposed street name, “Santos Rodriguez Road” contains 19 characters. The street-type designation “Road” can be abbreviated to “Rd.” but “Santos Rodriguez Rd.” still contains 17 characters. The approval of this request will require a waiver of Section 51A-9.304(a)(5).

Section 51A-9.304(a)(1) states “A proposed label in a street name may not duplicate any existing label.”

The change of “Jim Miller Road” to “Santos Rodriguez Road” complies with Section 51A-9.504(a)(1) as there has been no other city street named or renamed “Santos Rodriguez Road”.

Section 51A-9.304(b)(1) “Except as provided in paragraph (2) a roadway must have only one name”.

(2) Different names must be given to the same roadway under the following conditions:

- A. If a minor roadway deviates from its predominant course at a 90-degree angle for a distance of more than 300 feet, a different name must be used for the predominant course and for each portion of the roadway deviating from the predominant course.
- B. If two segments of a minor roadway are separated by an intervening land use that prohibits vehicular passage, and if future connections of the street segments through the use is unlikely, the segments of roadway on each side of the intervening use must have different names.
- C. If a street is interrupted and offsets more than 150 feet at a cross street, different names must be given to the offset street segments.

The request is to change the portion of Jim Miller Road between Great Trinity Forest Way and Highland Road. Jim Miller Road is between Gayglen Drive and Lindbergh Drive. The portion of Jim Miller Road between Great Trinity Forest Way and Gayglen Drive, and Highland Road and Lindbergh Drive will not be changed. The approval of this request will require a waiver for Section 51A-9.304(b)(1).

Section 51A-9.304 (c)(1) A Historic Street name may not be changed.

Mr. Miller was a Dallas County Commissioner and for more than twenty years a prominent figure in Dallas County politics. The approval of this request will require a waiver for Section 51A-9.304(c)(1).

Section 51A-9.304(c)(2) states “A street name commemorating a person, or a historic site or area is prohibited until at least two years after the death of the person to be honored or the occurrence of the event to be commemorated.”

See the attached “Exhibit A” outlining the justification of this application. Santos Rodriguez passed away on July 24, 1973.

WAIVER ARE NEEDED FOR:

Section 51A-9.304(a)(5) “A street name may not contain more than 14 characters providing; however, that the street-type designation may be abbreviated to comply with this requirement.”

Section 51A-9.304(b)(1) “A roadway must have only one name”.

Section 51A-9.304 (c)(1) “A Historic Street name may not be changed.”



- **Street Name Coordinator:** No objection if certain conditions are met.
 - The proposed street name requires waiver in Development Code Section 51A-9.304(a)(5) which provides that a street name may not contain more than 14 characters.
- **Department of Transportation:** No objection if certain conditions are met.
 1. How will this proposed name change be funded? TRN does not fund allocated to fund this large of name change.
 - a) Suggest: Need to identify the funding source.
 - b) This is a rough estimate for this proposed change:
 - I. Highway Signs: Based on the cost estimate that TxDOT provided to change highway signs for Lamar to Botham Jean, which had 8 large signs and the cost estimate was \$362,000, the cost for Jim Miller which has 11 large signs across the various highways could be upwards of \$500,000. If this sign request was submitted by the City Council Office, then the expense is out of their budget. However, per the Ordinance if the request was from another entity; they're responsible for the cost. At this time, TxDOT can't provide an estimate for the signs needed for the Jim Miller name change due to the need of both interstate and frontage road signs which are categorized as Type O (small sign) or Type G (large sign). *Rough Estimate: 11 * \$45,250 estimate = \$497,750*

- II. There are at least three signalized intersections where the mast arm and poles would need to be modified to support the size and weight of the larger name blades (Elam, Forney, and Everglade). The cost to make the modifications at these intersections would be roughly \$900,000 to \$1.5 million. It is also uncertain if the larger name blade would even fit on a new mast arm at Jim Miller and Elam. *Rough Estimate: 3 signals * \$900,000 = \$2,700,000*
- III. Replacing name blades at the other signalized intersections (manufacturing and installing). There are approximately 22 overhead mast arm signs which are required for this name change. The signs can be fabricated at 24" x 96" as shown below. Per City Ordinance 31040, the cost per signalized mast arm blade is \$1,130. *Rough Estimate: 11* \$1,130 = \$24,860.00.*

- IV. Replacing name blades at side streets: At least 60 *minor street name blades* x \$233 *each* = \$13,980.00, per City Ordinance 31040

- V. **TOTAL COST (approximate) = \$3,236,600**

- 2. If pursued, the southern limit of the name change should be Grayglen Drive, not Great Trinity Forest Way and northern limit should be Highland Road. Otherwise, there will be two disconnected sections of Jim Miller: N Jim Miller Rd north of Highland Rd, and S Jim Miller Rd south of Great Trinity Forest Way.
 - a. The street naming regulations in the Code Sec. 51A-9.304(b) should be verified.
 - b. This modification would change the approximate estimate provided above.

- **Dallas Public Works:** No objection.
- **Park and Recreation:** No objection.
- **Dallas School District:** No objection.

STAFF RECOMMENDATION: Staff has no objection to the request to change the portion of Jim Miller Road between Great Trinity Forest Way and Highland Road to “Santos Rodriguez Road” provided that the required waivers are granted by City Council.

SUBDIVISION REVIEW COMMITTEE RECOMMENDATION: The Subdivision Review Committee on Thursday November 16, 2023, by unanimous vote recommended denial of the Street Name Change NC234-001.




Santos Rodriguez

In the early morning hours of July 24, 1973, 12-year-old Santos Rodriguez and his 13-year-old brother David, were pulled from their home without being given time to put on their shoes, handcuffed, and put inside a police car by two Dallas police officers. They were then driven to a vacant lot behind a gas station where a burglary had occurred earlier in the evening. There was no evidence and there was no warrant, there was only the officers' suspicion of their involvement.

Despite both boys denying any involvement in the burglary, Officer Darrell Lee Cain was determined to get a confession and proceeded to play Russian Roulette with a .357 Magnum revolver held just inches from Santos' head. When Santos refused to confess, Officer Cain pulled the trigger, clicking an empty chamber. He again threatened to shoot Santos if he didn't confess. When Santos replied, "I am telling the truth", Officer Cain again pulled the trigger, firing a live round into his head, penetrating his brain, and causing his death instantly. David, who was still handcuffed and unable to exit the vehicle told his brother, "You are going to be all right", as blood began to seep onto David's feet. Later, fingerprints found at the scene of the burglary could not be matched to either of the boys.

Santos' murder highlighted racial bias within the Dallas Police Department, sparked protests, and served as a catalyst for Mexican-American involvement in Dallas. The event led to massive changes in DPD policies and procedures, many designed to ensure that the way the brothers were picked up and interrogated would not happen again. Santos' death also shaped our city by spurring change that led to increased political representation and more Mexican-Americans on the police force, bringing the department closer to reflecting the ethnic makeup of the city.

Renaming Jim Miller Rd. to Santos Rodriguez Rd. will serve to honor Santos' life and remind us of the injustices of the past while keeping us vigilant for the future.

SECTION 51A-9.304. STANDARDS FOR STREET NAMES AND STREET NAME CHANGES:

(a) In general.

- (1) A proposed label in a street name may not duplicate any existing label.
- (2) A proposed street name may not be similar to an existing street name so that it creates confusion or an obstacle to the provision of emergency services.
- (3) If all of the standards in this section are met, a roadway that extends into the city of Dallas from a contiguous municipality must adopt the street name given the street by the contiguous municipality.
- (4) A street name that uniquely identifies a particular tract, tenant, or product name is prohibited.
- (5) A street name may not contain more than 14 characters providing, however, that the street-type designation may be abbreviated to comply with this requirement.
- (6) Hyphenated and apostrophied street names are prohibited.

(b) Number of names for a roadway.

- (1) Except as provided in Paragraph (2), a roadway must have only one name.
- (2) Different names must be given to the same roadway under the following conditions:
 - (A) If a minor roadway deviates from its predominant course at a 90-degree angle for a distance of more than 300 feet, a different name must be used for the predominant course and for each portion of the roadway deviating from the predominant course.
 - (B) If two segments of a minor roadway are separated by an intervening land use that prohibits vehicular passage, and if future connections of the street segments through the use is unlikely, the segments of roadway on each side of the intervening use must have different names.
 - (C) If a street is interrupted and offsets more than 150 feet at a cross street, different names must be given to the offset street segments.

(c) Historic street names.

- (1) A historic street name may not be changed.
- (2) A street name commemorating a person, or a historic site or area is prohibited until at least two years after the death of the person to be honored or the occurrence of the event to be commemorated.

(d) Street type and label designation.

- (1) A street name may not contain more than one street-type designation. For example, the street name "John Doe Place Road" is not permitted.

- (2) The designation of the street type must be based upon the features of the roadway, such as the traffic volumes carried by the roadway, its physical design and construction characteristics, and its role in the surrounding street network.
- (3) No street name may have more than two labels before the street-type designation.
- (e) Directional prefix and suffix.
 - (1) A directional prefix is permitted only when the roadway intersects one of the official baselines used by the city.
 - (2) A directional suffix is permitted as an indicator for address location.
- (f) Guidelines.
 - (1) A street name may be based upon physical, political, or historic features of the area.
 - (2) The name of a subdivision and names thematically related to the name of a subdivision may be given to a street within the subdivision.
- (g) Waiver.

The city council, by a three-fourths vote of its members, may waive any of the standards contained in this section when waiver would be in the public interest and would not impair the public health, safety, or welfare. (Ord. Nos. 19832; 23407)

Career.**

James T. (Jim) Miller, 59, former County Commissioner and for more than twenty years a prominent figure in Dallas County politics, died Saturday afternoon at a local hospital.

Mr. Miller had been in ill health since more than a year ago when he suffered a paralytic stroke. He became critically ill Saturday morning and was taken from his home to the hospital, where he died a short time later.

Mr. Miller was the son of Mr. and Mrs. John W. Miller, who settled in Dallas County in 1856. During his political career he was elected County Commissioner nine times, four successive times from District No. 1 and five successive times from District No. 2. His first election was in 1910 from District 1.

After eight years' service he retired from office and moved his home into District No. 2. After two years' residence as a private citizen he was again sent back to the Commissioners' Court. He remained in continuous service until 1931 when he retired from public life.

The building of the Houston street viaduct, the Criminal Courts Building, Records Building and the Trinity River reclamation project were among the major Dallas and Dallas County developments that were started during Mr. Miller's years as a member of the County Commissioners' Court. In addition to these he directed the building of many miles of roads.

Mr. Miller is survived by his wife, a son, James T. Miller Jr.; three brothers, W. M. Miller of Forney, J. H. Miller of Kaufman and J. C. Miller of Paris.

Funeral services will be conducted at 4 p. m. Monday at his home on Military drive, south of Orphans' Home road and near Parkdale Country Club. The Rev. Hal F. Buckner and Tobe Winn will officiate. Burial will be in Grove Hill Cemetery.

Pallbearers will be D. C. Motley, J. M. Evans, J. D. Carney, J. Waddy Tate, Emmett Florence, W. W. Caruth, Arch McNeal and Charles Ferguson.
