An ordinance providing for the closure and vacation of a portion of Cadillac and Chrysler Drives and Mildred, Roberta and Spivey Streets; along with portions of four alleys adjacent to City Blocks 1/5906, 2/5906, 3/5906, 4/5906, 1/5888 <sup>1</sup>/<sub>4</sub>, 2/5888 <sup>1</sup>/<sub>2</sub> and 3/5888 <sup>3</sup>/<sub>4</sub>, 1/6641, 14/6641 in the City of Dallas and County of Dallas, Texas; providing for the interdepartmental transfer of funds; providing for the terms, provisions and effective date of the closure and vacation made herein; and providing an effective date for this ordinance.

WHEREAS, the Park and Recreation Department has requested the closure and vacation of a portion of Cadillac and Chrysler Drives and Mildred, Roberta and Spivey Streets; along with portions of four alleys to construct Roland G. Parrish Park; and WHEREAS, the City Council of the City of Dallas, acting pursuant to law, is of the opinion that the best interest and welfare of the public will be served by closing and vacating a portion of Cadillac and Chrysler Drives and Mildred, Roberta and Spivey Streets; along with portions of four alleys adjacent to city-owned property in City Blocks 1/5906, 2/5906, 3/5906, 4/5906, 1/5888 ¼, 2/5888 ½ and 3/5888 ¾, 1/6641, 14/6641 to all vehicular traffic;

## Now, Therefore,

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

**SECTION 1.** That the tract of land described in Exhibit A, which is attached hereto and made a part hereof, be and the same is hereby vacated and closed insofar as the right, title and easement of the public to use said tract for vehicular purposes are concerned; subject, however, to the conditions hereinafter more fully set out.

**SECTION 2.** That the Chief Financial Officer is authorized to transfer the monetary consideration in the sum of **ELEVEN THOUSAND THREE HUNDRED TWENTY AND NO/100 (\$11,320.00) DOLLARS** for the Closure and Vacation Processing Fee of **ELEVEN THOUSAND ONE HUNDRED FIFTY AND NO/100 (\$11,150.00) DOLLARS**, for the Ordinance Publication Fee of **TWENTY AND NO/100 (\$20.00) DOLLARS** and the Recording Fee of **ONE HUNDRED FIFTY AND NO/100 (\$150.00) DOLLARS** from the Equity Fund, Fund 0722, Department PKR, Unit 2382, Object 3099 to the General Fund, Fund 0001, Department FRM, Balance Sheet 0519 and Department of Facilities and Real Estate Management shall be reimbursed for the cost of obtaining the legal description, appraisal and other administrative costs incurred. The reimbursement proceeds shall be deposited in General Fund, Fund 0001, Department FRM, Unit 1181, Object 5011 and any remaining proceeds shall be transferred to the General Capital Reserve Fund, Fund 0625, Department BMS, Unit 8888, Revenue Code 8416.

**SECTION 3.** That the closure and vacation provided for herein are made subject to all present zoning and deed restrictions, if the latter exist, and are subject to all existing easement rights of others, if any, whether apparent or non-apparent, aerial, surface, underground or otherwise, and are subject to existing and retained rights of the City to use the property described in Exhibit A for water, wastewater and drainage purposes and the presently existing facilities, if any, for all public utility and fiber optic franchisees, which facilities shall remain in place pursuant to the respective franchise agreements with those companies.

**SECTION 4.** That the closure and vacation provided for herein is made subject to public use for pedestrian traffic and shall remain open and accessible.

**SECTION 5.** That the City Secretary is hereby authorized and directed to certify a copy of this ordinance for recordation in the Deed Records of Dallas County, Texas, which certified copy shall be delivered to the Director of Department of Facilities and Real Estate Management, or designee.

**SECTION 6.** That this ordinance is designated for City purposes as Contract No. FRM-2025-00027455.
