BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the City Manager is hereby authorized to execute Supplemental Agreement No. 28 to exercise the renewal option to the service contract with Computronix (U.S.A.), Inc. (502997), approved as to form by the City Attorney, for a two-year service contract extension for continued use, maintenance, and support of the City's Permit One Stop Solution Engine (POSSE) Land Management System, in an amount not to exceed \$682,230.00, increasing the service contract from \$12,086,773.15 to \$12,769,003.15.

SECTION 2. That the Chief Financial Officer is hereby authorized to disburse funds in an amount not to exceed \$682,230.00 (subject to annual appropriations) to Computronix (U.S.A.), Inc. from Service Contract No. DSV-2016-00000880.
