WHEREAS, Weir's Plaza Owner, LLC, ("Developer") desires the development or redevelopment of property located at 4550 Travis Street, Dallas, Texas 75205 for a mixed-use office/retail development project, commonly known as Weir's Plaza ("Development Project"); and

WHEREAS, the Development Project contributes to the need for municipal infrastructure additions or improvements, namely two warranted traffic signals at the intersections of Cole Avenue at Armstrong Avenue and McKinney Avenue at Armstrong Avenue in the city of Dallas; and

WHEREAS, the City of Dallas, pursuant to Chapter 51A-1.109 of the Dallas City Code determines the city infrastructure has an estimated total cost of \$1,300,000.00 and made an apportionment determination in accordance thereof as to the Developer and the City's cost participation; and

WHEREAS, the impact created by the Development Project requires the installation of city infrastructure requiring the Developer to provide a proportionate share of the costs for the installation of city infrastructure in the amount of \$320,000.00; and

WHEREAS, the Developer agrees to provide its proportionate share towards the city infrastructure to address the municipal infrastructure needs created by its planned Development Project as determined by Section 51A-1.109 of the Dallas City Code.

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the City Manager is hereby authorized to execute an agreement with Weir's Plaza Owner, LLC, approved as to form by the City Attorney, for contribution of funds towards the warranted traffic signal installation at the intersections of Cole Avenue at Armstrong Avenue and McKinney Avenue at Armstrong Avenue in the city of Dallas, in an amount not to exceed \$320,000.00.

SECTION 2. That the City Manager is hereby authorized to increase appropriations in an amount not to exceed \$320,000.00 in the Transportation Special Projects Fund, Fund 0761, Department PBW, Unit X232, Object 4820.

SECTION 3. That the Chief Financial Officer is hereby authorized to receive and deposit funds in an amount not to exceed \$320,000.00 in the Transportation Special Projects Fund, Fund 0761, Department PBW, Unit X232, Revenue Code 8492.

SECTION 4. That the Chief Financial Officer is hereby authorized to disburse funds in an amount not to exceed \$320,000.00 from the Transportation Special Projects Fund, Fund 0761, Department PBW, Unit X232, Object 4820, Program TP25X232, Encumbrance/Contract No. PBW-2025-00028149.

SECTION 5. That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
