**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:**

**SECTION 1.** That the bids received for Group 7 for solid waste consulting services are hereby rejected.

**SECTION 2.** That the City Manager is hereby authorized to execute a service price agreement with Burns & McDonnell Engineering Company, Inc. (VS97425), Raftelis Financial Consultants, Inc. dba Raftelis (VS0000075029), MidAtlantic Solid Waste Consultants, LLC dba MSW Consultants (VC0000034715), Risa Fisher & Associates, Inc. (517301), Parkhill, Smith and Cooper, Inc. (VC14457), and Ensolum, LLC (VS99096), approved as to form by the City Attorney, for Groups 1 through 6 and 8 through 10 for solid waste consulting services for a term of three years, in the estimated amount of \$3,609,828.00. The amount payable pursuant to this service price agreement may exceed the estimated amount, but may not exceed the amount of budgetary appropriations for this service price agreement during its term. Payments made to Burns & McDonnell Engineering Company, Inc., Raftelis Financial Consultants, Inc. dba Raftelis, MidAtlantic Solid Waste Consultants, LLC dba MSW Consultants, Risa Fisher & Associates, Inc., Parkhill, Smith and Cooper, Inc., and Ensolum, LLC shall be based only on the amount of the services directed to be performed by the City and properly performed by Burns & McDonnell Engineering Company, Inc., Raftelis Financial Consultants, Inc. dba Raftelis, MidAtlantic Solid Waste Consultants, LLC dba MSW Consultants, Risa Fisher & Associates, Inc., Parkhill, Smith and Cooper, Inc., and Ensolum, LLC under the service price agreement. The City Manager is further authorized, in the City Manager's sole discretion, to exercise an option to extend the agreement for six months by filing a notice of extension with the City Secretary's Office.

**SECTION 3.** That the Chief Financial Officer is hereby authorized to disburse funds in an estimated amount of at least \$3,609,828.00 (subject to annual appropriations), but not more than the amount of budgetary appropriations for this service price agreement during its term to Burns & McDonnell Engineering Company, Inc., Raftelis Financial Consultants, Inc. dba Raftelis, MidAtlantic Solid Waste Consultants, LLC dba MSW Consultants, Risa Fisher & Associates, Inc., Parkhill, Smith and Cooper, Inc., and Ensolum, LLC from Service Price Agreement Contract No. SAN-2025-00026992.

**SECTION 4.** That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
