Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the bid submitted by Merrell Bros, Inc., in the amount of \$5,995,975.70, for doing the work covered by the plans, specifications, and contract documents, Contract No. 23-177, be accepted.

SECTION 2. That the City Manager is hereby authorized to execute a construction services contract with Merrell Bros, Inc., approved as to form by the City Attorney, for dredging at five locations: Acres/Grady Detention Basin, Bent Creek Detention Basin, Fox Hollow Lake, Twin Lakes, and Lone Star Detention Basin in Dallas, TX, in an amount not to exceed \$5,995,975.70.

SECTION 3. That the City Manager is hereby authorized to transfer funds in an amount not to exceed \$5,995,975.70 from the Storm Drainage Management Operating Fund, Fund 0061, Department SDM, Unit 4908, Object 3637 to the Storm Drainage Management Capital Construction Fund, Fund 0063, Department SDM, Unit 4793, Object 4599, ~~and to increase appropriations in an amount not to exceed \$5,995,975.70, as follows:~~
