### **SUBJECT** Proposed Naming of the West Dallas Lakes – The 3 Sisters Lakes

As you are aware, the City of Dallas and the U.S. Army Corps of Engineers (USACE) have been working toward and recently completed the construction of the Dallas Floodway Levee Raise and Flattening. As part of this work, the planned West Dallas Lakes area includes a series of three lakes that provide opportunities to build on the implementation of the Balanced Vision Plan near Westmoreland Road. Attached is an aerial image of these lakes.

Dallas is uniquely positioned to honor and recognize its Native American history through the naming of these lakes. In collaboration with local Native American leaders in the region, the following naming proposal is submitted for your consideration:

The 3 Sisters Lakes: NumuNahmi Lake (Comanche Nahmi Lake), Wichita ita:i?h Lake, and Lipan Apache Mbátí Lake. These names reflect the Native American word for "sister" from each respective tribe and honor their historical connection to the Dallas area. The naming also recognizes Native American tribes historically associated with the region, including Caddo, Comanche, Kiowa, Tawakoni, Wichita, Tonkawa, Waco, Lipan Apache, and Keechi.

Please add Waco and Keechi to the list of Native American tribes. Include the word "sister" in each lake name, and incorporate the Native language names for each, as each tribe has a distinct word for "sister." For Comanche, the word for sister is Nahmi, and the proposed lake name is NumuNahmi Lake (Comanche Nahmi Lake). For Wichita, the word for sister is ita:i?h (pronounced "ee-dotzh-ee"), and the lake would be named Wichita ita:i?h Lake. For Lipan Apache, the word for sister is Mbátí, and the lake name would be Lipan Apache Mbátí Lake.

**WHEREAS**, the U.S. Army Corps of Engineers signed the Modified Dallas Floodway Record of Decision, confirming the Balanced Vision Plan and including the West Dallas Lakes, was signed in April 2015: and

**WHEREAS**, the Supplemental Bi-Partisan Budget Act of 2018 (Public Law 115-123) funded the flood risk management of the Dallas Floodway; and

WHEREAS, the City of Dallas and the U.S. Army Corps of Engineers (USACE) have been working toward and recently completed the construction of the Dallas Floodway Levee Raise and Flattening. As part of this work, the planned West Dallas Lakes area includes a series of three lakes that provide opportunities to build on the implementation of the Balanced Vision Plan near Westmoreland Road; and

**WHEREAS**, Dallas is uniquely positioned to recognize our Native American history by naming these West Dallas Lakes; and

WHEREAS, in working with local Native American leaders in the region, it is proposed to name The 3 Sisters Lakes: NumuNahmi Lake (Comanche Nahmi Lake), Wichita ita:i?h Lake, and Lipan Apache Mbátí Lake. This naming honors Native American tribes historically associated with the Dallas area and surrounding region including Caddo, Comanche, Kiowa, Tawakoni, Wichita and Tonwaka.

### NOW, THEREFORE,

### BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS

Section 1. That The 3 Sisters Lakes be named: NumuNahmi Lake (Comanche Nahmi Lake), Wichita ita:i?h Lake, and Lipan Apache Mbátí Lake.

Section 2. That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
