WHEREAS, on June 9, 2021, the City Council authorized the adoption of the FY 2021-22 Consolidated Plan Budget by Resolution No. 21-0974; and

WHEREAS, on June 22, 2022, the City Council authorized the adoption of the FY 2022-23 Consolidated Plan Budget by Resolution No. 22-1024; and

WHEREAS, on June 14, 2023, the City Council authorized the adoption of the FY 2023-24 Consolidated Plan Budget, by Resolution No. 23-0765; and

WHEREAS, on February 28, 2024, the City Council authorized the construction services contract with XIT Paving & Construction, Inc. for the construction of the Five Mile Infrastructure Improvements Package A Project, in an amount not to exceed \$11,564,976.75, by Resolution No. 24-0327; and

WHEREAS, this action will authorize Contract Amendment No. 1 to the construction services contract with XIT Paving & Construction, Inc. for the construction of the Five Mile Infrastructure Improvements Package A Project in an amount not to exceed \$842,353.00 increasing the contract amount from \$11,564,976.75 to \$12,407,329.75.

Now, Therefore,
