THENCE Southeasterly with the south line of said Dart Corridor and with said curve turning to the right having the following functions, a delta angle of 07 deg. 50 min. 27 sec., a radius of 2815.00 feet, an arc length of 385.23 feet, a chord bearing of South 68 deg. 50 min. 30 sec. East, and a chord length of 384.93 feet to a 1/2" iron rod (set with cap "7 Range Surveying") in the southwest right-of-way of Cade Road for the northeast corner of the herein described tract and the P.C.

THENCE Southeasterly with the southwest right-of-way of Cade Road and with said curve turning to the left having the following functions, a delta angle of 30 deg. 49 min. 19 sec., a radius of 112.75 feet, an arc length of 60.65 feet, a chord bearing of South 27 deg. 39 min. 00 sec. East, and a chord length of 59.92 feet to a 1/2" iron rod (set with cap "7 Range Surveying") for an east corner of the herein described tract, being in the east line of said 10.07 acre tract and the west line of a certain called 34.125 acre tract described in a deed to Rylie Faith Family Academy as recorded in File No. 2000020, Page 3303, from which a 1/2" iron rod (found with cap "USA") in the paved surface of Cade Road and being the northeast

THENCE South 00 deg. 49 min. 54 sec. West with the common line of said 34.125 acre tract, a distance of 347.61 to a 3/8" iron rod (found) for the southeast corner of the herein described tract and an interior corner of said 34.125 acre tract;

THENCE North 72 deg. 26 min. 26 sec. West continuing with the common line of said 34.125 acre tract and the north line of a certain called 4.6109 acre tract described in a deed to Florentino Vela and Cristela Morales De Vela as recorded in File No. 201900173213, a distance of 1226.07 feet to a 1/2" iron pipe (found) for the southwest corner of the herein described tract, being the northwest corner of said 4.6109 acre tract, being in the east line of the aforementioned Fuentes


