WHEREAS, the City of Dallas has engaged Brown & Hofmeister, L.L.P., to provide legal counsel, advice and representation to the City of Dallas, Dallas Police Chief Edgardo "Eddie" Garcia, and former Dallas Police Chief Ulysha Reneé Hall, in connection with the lawsuit styled <u>Ray Jordan II et al. v. City of Dallas et al.</u>, No. 3:22-CV-1173-M; and

WHEREAS, on October 13, 2022, Administrative Action No. 22-6395, authorized a professional services contract with Brown & Hofmeister, L.L.P. to provide legal counsel, advice, and representation to the City of Dallas, Dallas Police Chief Edgardo "Eddie Garcia," and former Dallas Police Chief Ulysha Reneé Hall, in an amount not to exceed \$50,000.00; and

WHEREAS, on February 8, 2023, the district court dismissed the claims against Dallas Police Chief Edgardo "Eddie" Garcia in the lawsuit styled Ray Jordan II et al. v. City of Dallas et al., No. 3:22-CV-1173-M; and

WHEREAS, on July 17, 2023, Administrative Action No. 23-5877, authorized Supplemental Agreement No. 1 to the professional services contract with Brown & Hofmeister, L.L.P. for additional legal counsel, advice, and representation to the City of Dallas and former Dallas Police Chief Ulysha Reneé Hall, in an amount not to exceed \$50,000.00, from \$50,000.00 to \$100,000.00; and

WHEREAS, the professional legal services of Brown & Hofmeister, L.L.P. continue to be necessary.

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the City Manager is hereby authorized to execute Supplemental Agreement No. 2 to the professional services contract with Brown & Hofmeister, L.L.P., approved as to form by the City Attorney, to provide additional legal counsel, advice, and representation to the City of Dallas and former Dallas Police Chief Ulysha Reneé Hall, in connection with the lawsuit styled <u>Ray Jordan II et al. v. City of Dallas et al.</u>, No. 3:22-CV-1173-M, in an amount not to exceed \$75,000.00, increasing the contract amount from \$100,000.00 to \$175,000.00.

SECTION 2. That the Chief Financial Officer is hereby authorized to disburse funds in an amount not to exceed \$75,000.00 to Brown & Hofmeister, L.L.P. from Liability Reserve Fund, Fund 0192, Department ORM, Unit 3890, Object 3033, Encumbrance/Contract No. ATT-2022-00020531, Vendor 339582.

SECTION 3. That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
