~~**WHEREAS**, the City of Dallas owns land in southern Dallas known as West Trinity Heights Park (1.5 acres) located at 1900 Harlandale Avenue, which was acquired for park purposes and has been maintained as parkland; and~~

~~**WHEREAS**, the Dallas Water Utilities Department (DWU) has identified a portion of West Trinity Heights Park as necessary for a drainage easement for the public benefit, and DWU must acquire a drainage easement of approximately 24,204 square feet of land (0.56 acres) of land, by DWU for creek stormwater improvements, for such improvements, as shown on Exhibit A, and the Park and Recreation Board is agreeable to providing the property for this use; and~~

~~**WHEREAS**, the DWU is agreeable to designing and constructing its improvements such that the City's ability to make future improvements to the park shall not be impaired; and~~

~~**WHEREAS**, the Texas Parks and Wildlife Code, Chapter 26 (Section 26.001 through 26.004), requires that before a municipality may approve any program or project that requires the use or taking of any public land designated and used as parkland, the governing body of such public municipality must determine that there is no feasible and prudent alternative to the use or taking of such land, and that the program or project includes all reasonable planning to minimize harm to the remainder of the park; and~~

~~**WHEREAS**, prior to making this determination, notice must be given, and a public hearing be held relative to the proposed change of park use; and~~

~~**WHEREAS**, the City desires to rescind Resolution No. 24-1664, which authorized a public hearing to be held on December 11, 2024, said public hearing was not held due to a clerical error, and authorize a public hearing to be held on March 26, 2025; and~~

~~**WHEREAS**, the City Council desires to give notice and hold such hearing in accordance with the law with respect to the dedication of a portion of West Trinity Heights Park to DWU.~~

~~**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:**~~

~~**SECTION 1.** That the City Manager is hereby authorized to rescind Resolution No. 24-1664, previously approved on November 13, 2024, that authorized a public hearing to be held on December 11, 2024.~~

~~**SECTION 2.** That the Park & Recreation Department is hereby authorized and directed to advise in writing of such proposed use of the park property by delivering a notice for publishing to the official newspaper to be advertised once each week for three consecutive weeks, the last publication to be not less than one week nor more than two weeks before the date of the hearing, which shall be held in the City Council Chambers on March 26, 2025.~~

~~**SECTION 3.** That the approval of the aforementioned project by the City Council, at the close of said hearing, shall be construed as making the proper findings as to the use, taking, and conveyance of parkland, consistent with the Texas Parks and Wildlife Code and the Texas Local Government Code.~~

~~**SECTION 4.** That the Chief Financial Officer is hereby authorized to receive and deposit funds in an amount not to exceed \$740.90, paid by DWU for the cost of advertising the public hearing into Capital Gifts, Donation and Development Fund, Fund 0530; Department PKR; Unit 919A; Revenue Code 8428.~~

~~**SECTION 5.** This resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.~~
