~~**WHEREAS**, on March 7, 2012, the City Council authorized concessions contracts, with two one-year renewal options, for food and beverage services with Concessionaire at Dallas Love Field Airport by Resolution No. 12-0706; and~~

~~**WHEREAS**, on August 12, 2015, the City Council authorized the City Manager, to execute the First Amendment to the contract that allowed product pricing at street pricing plus 10 percent, established a minimum wage of \$10.37, and removed the shared cost provision of the contract by Resolution No. 15-1335; and~~

~~**WHEREAS**, on November 6, 2018, the City Council authorized the Second Amendment to the contract that added Space No. #C2086, a bar with limited food service, Dallas Cowboys Club, and a non-contiguous patio at Cantina Laredo by Resolution No. 18-1483; and~~

~~**WHEREAS**, on November 18, 2020, with the City Manager's approval, the contract was partially assigned Space No. #C2086 to Team Joint Venture, LLC; and~~

~~**WHEREAS**, on September 22, 2021, the City Council authorized the City Manager to execute a Third Amendment to the concession contract with Air Star Concessions, LTD (Campisi's, Cantina Laredo, Whataburger) food and beverage concessionaire at Dallas Love Field, approved as to form by the City Attorney, in order to (1) exercise both one-year renewal terms and (2) add a two extension years to the contract by Resolution No. 21-1509; and~~

~~**WHEREAS**, on December 8, 2021, the City Council authorized the City Manager to execute the First Amendment to Air Star Concessions, LTD. Food and Beverage Concession Contract at Dallas Love Field approved as to form by the City Attorney, in order to (1) exercise both one-year renewal terms; and (2) to add a two-year extension term to the contract by Resolution No. 21-1942; and~~

~~**WHEREAS**, Air Star Concessions, LTD has been an excellent operator, especially during the COVID-19 pandemic when airline traffic was significantly reduced, with drastic staffing reductions and sales lost. The concessionaire continued operations to service passengers and airport employees in a very trying climate.~~

~~**SECTION 1.** That the City Manager is hereby authorized to execute the Fourth Amendment to the concession contract with Air Star Concessions, LTD (Cantina Laredo, Campisi's Pizza, Whataburger), approved as to form by the City Attorney, for food and beverage concession services at Dallas Love Field Airport to exercise a seven-year renewal term to the contract.~~
