**WHEREAS**, on May 9, 2018, a Request for Qualifications was issued for Engineering and Landscape Architecture Consulting Services for Park Site Development Projects in the 2017 Bond Program; and

**WHEREAS**, on August 19, 2019, Jacobs Engineering Group, Inc. has submitted a proposal for schematic design, design development, construction documents, procurement and construction observation phases for Timberglen Trail – Phase 2, and schematic design, survey and route development for Timberglen Trail – Phase 3, in an amount not to exceed \$716,685.00; and

**WHEREAS**, on February 26, 2020, the City Council authorized a design contract with Jacobs Engineering Group, Inc., for schematic design, design development, construction documents, procurement and construction observation phases for Timberglen Trail – Phase 2, and schematic design, survey and route development for Timberglen Trail – Phase 3, in an amount not to exceed \$716,685.00, by Resolution No. 20-222; and

**WHEREAS**, on March 24, 2020, City of Dallas entered into an agreement with Jacobs Engineering Group, Inc. for architectural and engineering services for the Project; and

**WHEREAS**, this action will authorize Supplemental Agreement No. 1 to the professional services contract with Jacobs Engineering Group, Inc. to provide additional engineering design and consulting services for the Timberglen Trail Phase II Project located at 3900 Timberglen Road to Midway Road and from Moss Glen Park to the Preston Ridge Trail at Hillcrest Road and for environmental analysis including developing technical reports, archeological resource coordination and historical resources, boundary survey required as a part of Texas Department of Transportation (TxDOT) funding requirements in an amount not to exceed \$106,560.00, increasing the contract amount from \$716,685.00 to \$823,245.00.

**Now, Therefore,**

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:**

**SECTION 1.** That the President of the Park and Recreation Board and City Manager are hereby authorized to execute Supplemental Agreement No. 1 to the professional services contract with Jacobs Engineering Group, Inc. to provide additional engineering design and consulting services for the Timberglen Trail Phase II Project located at 3900 Timberglen Road to Midway Road and from Moss Glen Park to the Preston Ridge Trail at Hillcrest Road and for environmental analysis including developing technical reports, Archeological Resource Coordination and Historical resources, Boundary Survey required as a part of Texas Department of Transportation (TxDOT) funding requirements in an amount not to exceed \$106,560.00, increasing the contract amount from \$716,685.00 to \$823,245.00.
