**WHEREAS**, on April 24, 2025, the City Council authorized the adoption of the Dallas Public Library Strategic and Facilities Plan (Plan); and

**WHEREAS**, the Dallas Public Library has been an essential partner for Dallas Communities, supporting learning, inspiring curiosity and advancing lives for more than 120 years; and

**WHEREAS**, the Library Strategic and Facilities Plan is intended to serve as guiding principles to help the Library provide services and facilities that are responsive to community needs; and

**WHEREAS**, a vibrant, well-run Library system enhances the quality of life and economic outcomes of the community; and

**WHEREAS**, Downtown Dallas, Inc. Foundation's mission is to be the champion of a clean and safe Downtown and of the economic development and vibrancy of this community of diverse, unique neighborhoods; and

**WHEREAS**, the Library applied for a grant from Downtown Dallas Inc. Foundation for the creation of an engaging garden and patio space at J. Erik Jonsson Central Library; and

**WHEREAS**, Downtown Dallas Inc. Foundation awarded the Library a grant in the amount of \$150,000.00; and

**WHEREAS**, it is now necessary to accept and deposit these funds into the ~~Dallas Public Library Gifts & Donations Fund~~ Central Library Gift Fund and adjust expenditure and revenue appropriations accordingly.

**Now, Therefore,**

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:**

**SECTION 1.** That the City Manager is hereby authorized to accept a grant upon receipt from the Downtown Dallas Inc. Foundation, in the amount of \$150,000.00 for the creation of an engaging garden and patio space at J. Erik Jonsson Central Library and execute the grant agreement and all terms, conditions, and documents as required by the grant agreement, approved as to form by the City Attorney.

**SECTION 2.** That the Chief Financial Officer is hereby authorized to receive and deposit funds in an amount not to exceed \$150,000.00 in the ~~Dallas Public Library Gifts & Donations Fund~~ Central Library Gift Fund, Fund 0214, Department LIB, Unit X188, Revenue Code 8411

**SECTION 3.** That the City Manager is hereby authorized to establish appropriations in an amount not to exceed \$150,000.00 in the ~~Dallas Public Library Gifts & Donations Fund~~ Central Library Gift Fund, Fund 0214, Department LIB, Unit X188, Object 3099.

**SECTION 4.** That the Chief Financial Officer is hereby authorized to disburse funds in an amount not to exceed \$150,000.00 upon receipt from the ~~Dallas Public Library Gifts & Donations Fund~~ Central Library Gift Fund, Fund 0214, Department LIB, Unit X188, Object 3099.

**SECTION 5.** That this contract is designated as Contract No. LIB-2025-00028025

**SECTION 6.** That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
