REQUEST: An application for an amendment to Specific Use Permit No. 651 for a college on property zoned R-1/2ac(A) District.

SUMMARY: The purpose of the request to construct an additional building onsite [Richland College].

CPC RECOMMENDATION: **Approval**, subject to a revised site plan and conditions.

STAFF RECOMMENDATION: **Approval**, subject to a revised site plan and conditions.

BACKGROUND INFORMATION:

- The area of request is currently developed as Richland College, and consists of 33 buildings totaling 1,316,485 square feet.
- The current zoning is an R-1/2ac(A) Single Family District, with the college permitted with the SUP. A portion of the site is located within the floodplain.
- The applicant proposes to amend the site with the addition of a two-story building with approximately 152,000 square feet of floor area. The applicant also proposes to add 883 parking spaces for the proposed building.

Zoning History: There have been no new zoning cases in the area over the past five years.

Traffic:

The Engineering Division of the Sustainable Development and Construction Department has reviewed the request and determined that the proposed development will not have a negative impact on the surrounding street network.

COMPREHENSIVE PLAN:

The *forwardDallas! Comprehensive Plan* was adopted by the City Council in June 2006. The *forwardDallas! Comprehensive Plan* outlines several goals and policies which can serve as a framework for assisting in evaluating the applicant's request.

The proposed zoning request meets the following goals and objectives of the Comprehensive Plan:

LAND USE ELEMENT

GOAL 1.1 ALIGN LAND USE STRATEGIES WITH ECONOMIC DEVELOPMENT PRIORITIES

Policy 1.1.5 Strengthen existing neighborhoods and promote neighborhoods' unique characteristics. Acknowledge the importance of neighborhoods to the city's long-term health and vitality.

1.1.5.7 Ensure that neighborhoods are served by and accessible to neighborhood commercial areas, parks and open space, libraries, and schools.

Area Plans:

The District 10 Strategic Plan was approved in June 2006. Council District 10 is an area generally defined as Northeast Dallas and is bound by the Dallas City Limits to the north and east, Northwest Highway to the south, and U.S. Highway 75 and the White Rock Greenbelt to the west. The purpose of the Plan is to identify community needs and to develop recommendations to address these needs and community goals.

The plan consists of four goals:

1. Establish a plan for District 10 supporting the vision for Northeast Dallas communities;
2. Support development that promotes the community vision;
3. Encourage economic investment; and
4. Improve community infrastructure.

The proposed request supports goals 2 and 3 of the District 10 Strategic Plan.

Land Use Compatibility

The site is currently developed with Richland College. The applicant is proposing to construct a two-story structure. Per Sec. 51(A)-4.112(B)(2)(D), an R-1/2ac(A) Single Family District allows a college use by SUP. Uses within the vicinity include single family to the north, east, south, and west of the area of request. Multifamily uses are located northeast and south of the site. There are also commercial retail, restaurants, vehicle fueling station and a public school within the vicinity of the area of request.

The applicant is proposing a continuation of its existing use as a college but wants to construct a new building to allow for uses in conjunction with its current facilities. The proposed building and additional parking will be located within its current site, and Staff believes this will not have a negative effect on the surrounding land uses.

The general provisions for a Specific Use Permit in Section 51A-4.219 of the Dallas Development Code specifically state: (1) The SUP provides a means for developing certain uses in a manner in which the specific use will be consistent with the character of the neighborhood; (2) Each SUP application must be evaluated as to its probable effect on the adjacent property and the community welfare and may be approved or denied as the findings indicate appropriate; (3) The city council shall not grant an SUP for a use except upon a finding that the use will: (A) complement or be compatible with the surrounding uses and community facilities; (B) contribute to, enhance, or promote the welfare of the area of request and adjacent properties; (C) not be detrimental to the public health, safety, or general welfare; and (D) conform in all other respects to all applicable zoning regulations and standards. The request does not appear to have an adverse impact on the surrounding zoning and land uses.

Staff supports the request for because the request complies with all other zoning regulations and the addition to the site is not foreseen to be detrimental to surrounding properties. Staff is also in support of the applicant's request for a permanent time period, and this is consistent with the applicant's current specific use permit, which is for a permanent time period.

Parking:

The requirement for off-street parking for SUP No. 651 is one space per 25 square feet of classroom. Although the amount of classroom spaces has not been determined at this time, the applicant intends to provide 883 spaces for the proposed use, which would meet the requirements of SUP No. 651 if the maximum amount of classroom space was 22,075 square feet.

Landscaping

Landscaping will be in accordance with the landscaping requirements in Article X, as amended.

Market Value Analysis (MVA)

Market Value Analysis (MVA) is a tool to aid residents and policymakers in understanding the elements of their local residential real estate markets. It is an objective, data-driven tool built on local administrative data and validated with local experts. The analysis was prepared for the City of Dallas by The Reinvestment Fund. Public officials and private actors can use the MVA to target intervention strategies more precisely in weak markets and support sustainable growth in stronger markets. The MVA identifies nine market types (A through I) on a spectrum of residential market strength or weakness. As illustrated in the attached MVA map, the colors range from purple representing the strongest markets to orange, representing the weakest markets. While the area of request is uncategorized within an MVA cluster, the surrounding areas to east and south are within Category “D.” Areas to the west are within Category “F” and an area southwest of the site is within Category “E.”

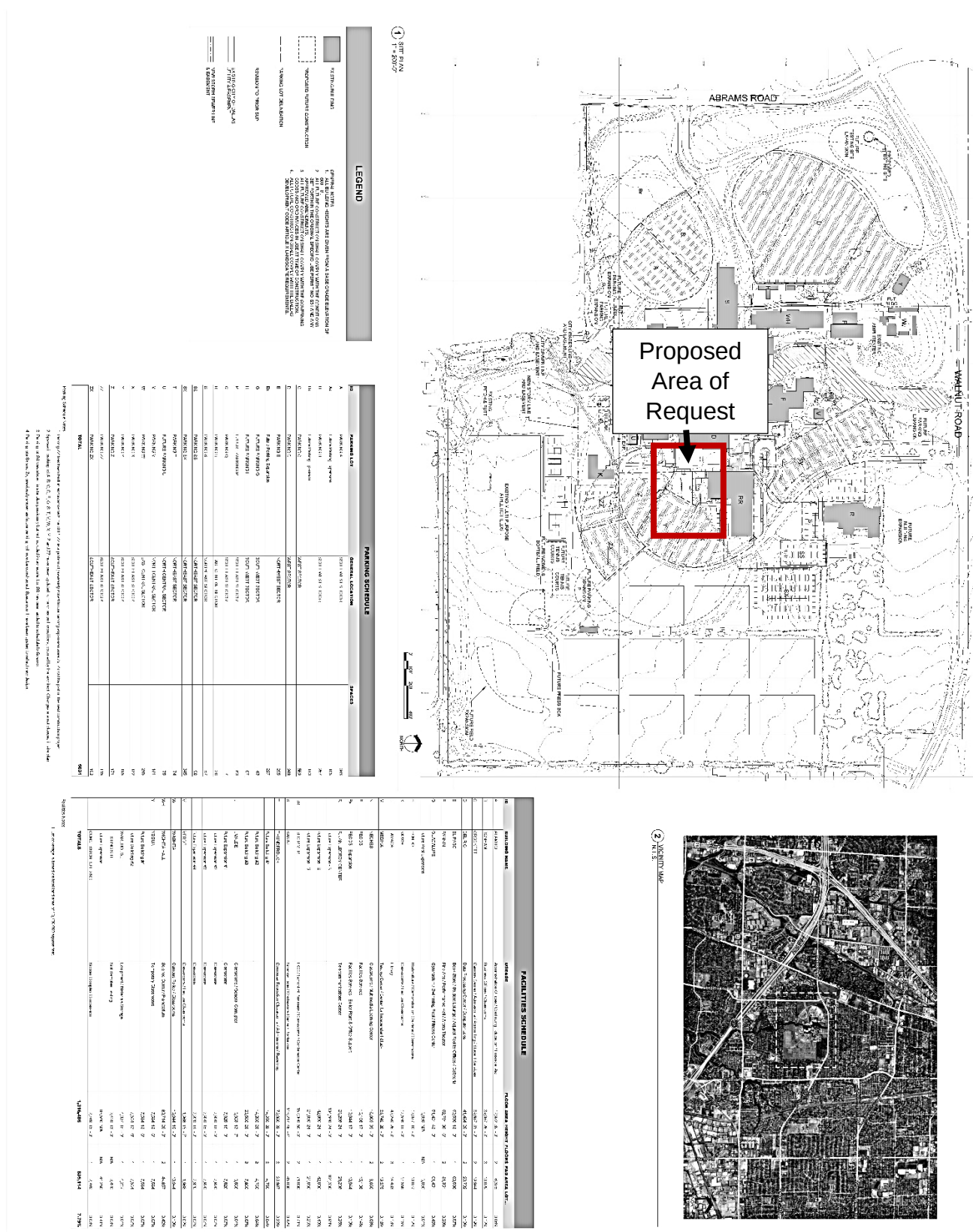

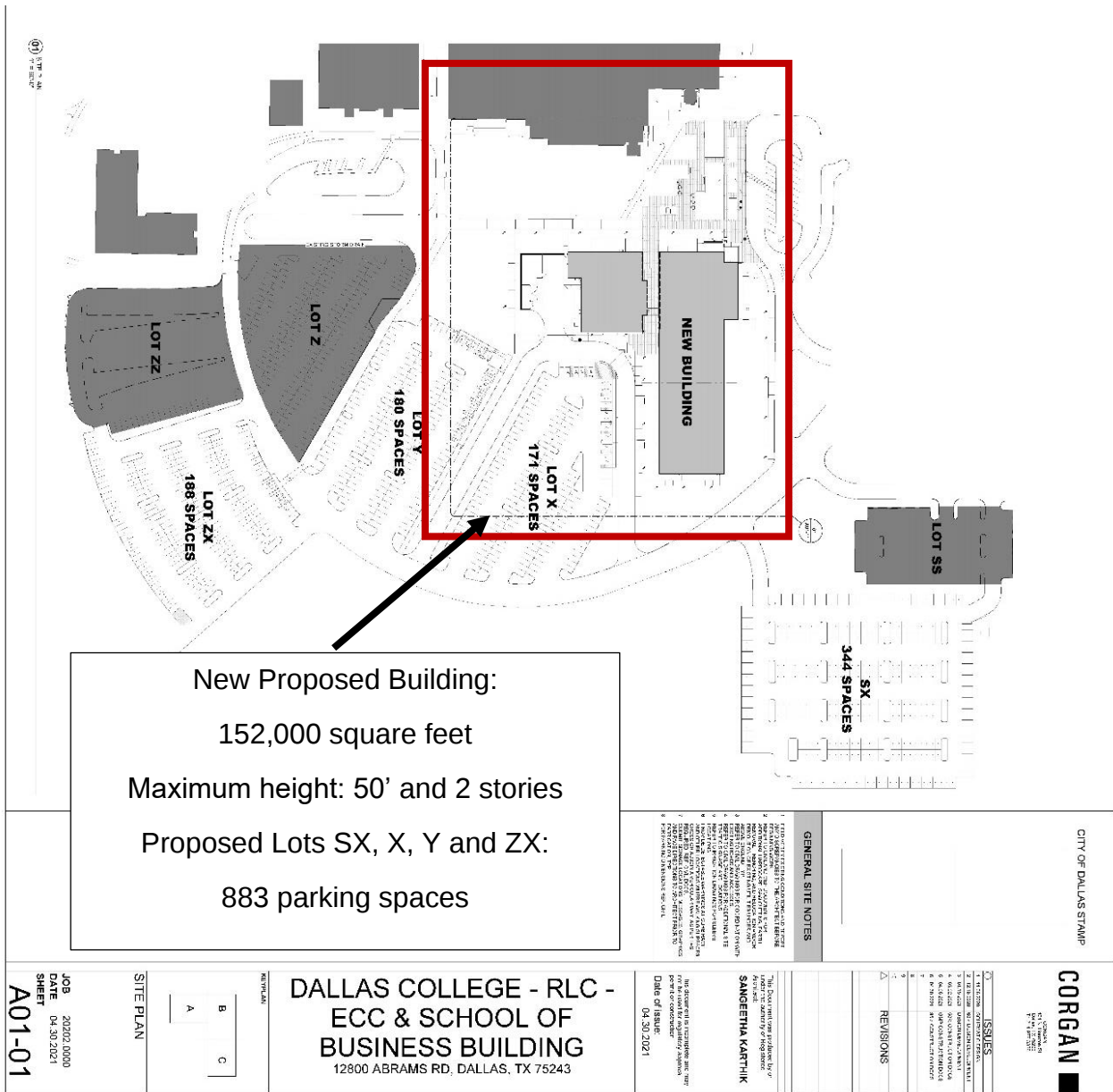
CPC RECOMMENDED SUP CONDITIONS

1. USE: The only use authorized by this specific use permit is a college or university.
2. SITE PLAN: Use and development of the property must comply with the attached site plan.
3. TIME LIMIT: This specific use permit has no expiration date.
4. HEIGHT: No structure may exceed 50 feet in height.
5. PARKING:
 - (a) Except as otherwise required in Subsection (b), off-street parking is one space per 25 square feet of classroom. If more than 10 off-street parking spaces are required for this use, handicapped parking must be provided pursuant to Section 51A-4.305.
 - (b) Parking, for the closed circuit television production facility must be provided as shown on the site plan attached to Ordinance No. _____ illustrating the center for telecommunications.
6. TIME LIMIT: This Specific Use Permit shall be on a permanent basis effective from the date of passage of the ordinance.
7. MAINTENANCE: The Property must be properly maintained in a state of good repair and neat appearance.
8. GENERAL REQUIREMENTS: Use of the Property must comply with all federal and state laws and regulations, and with all ordinances, rules, and regulations of the City of Dallas.

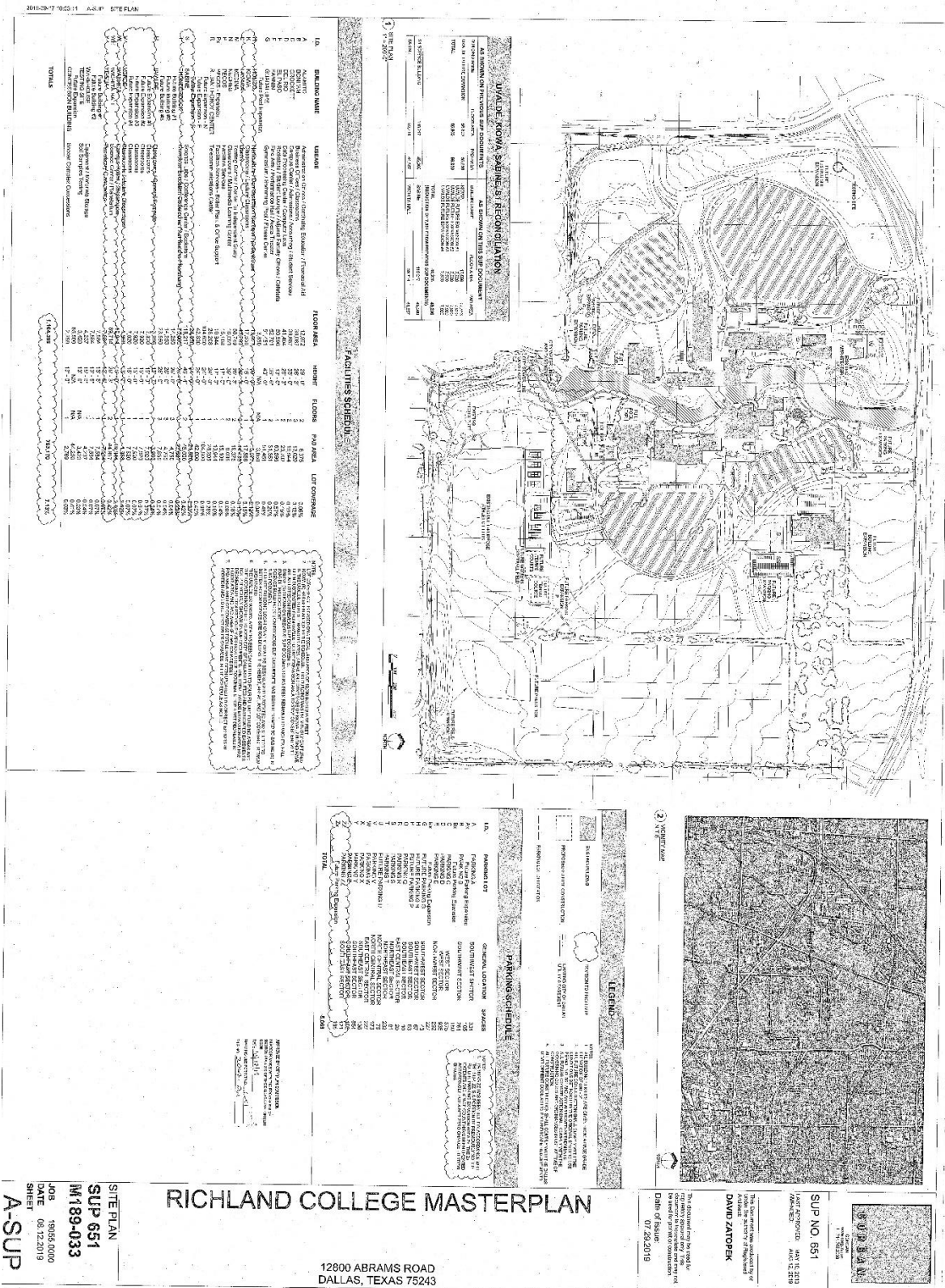

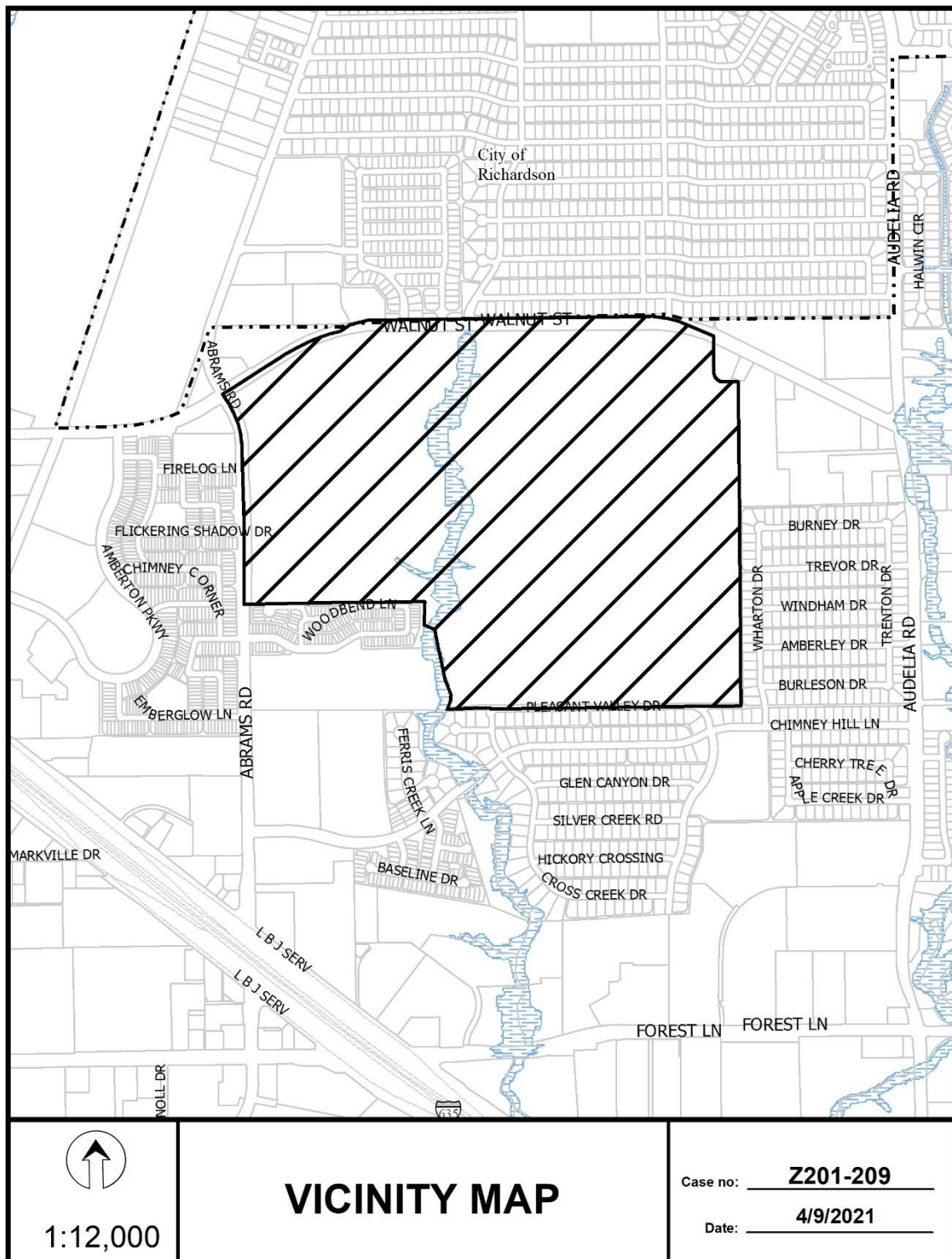


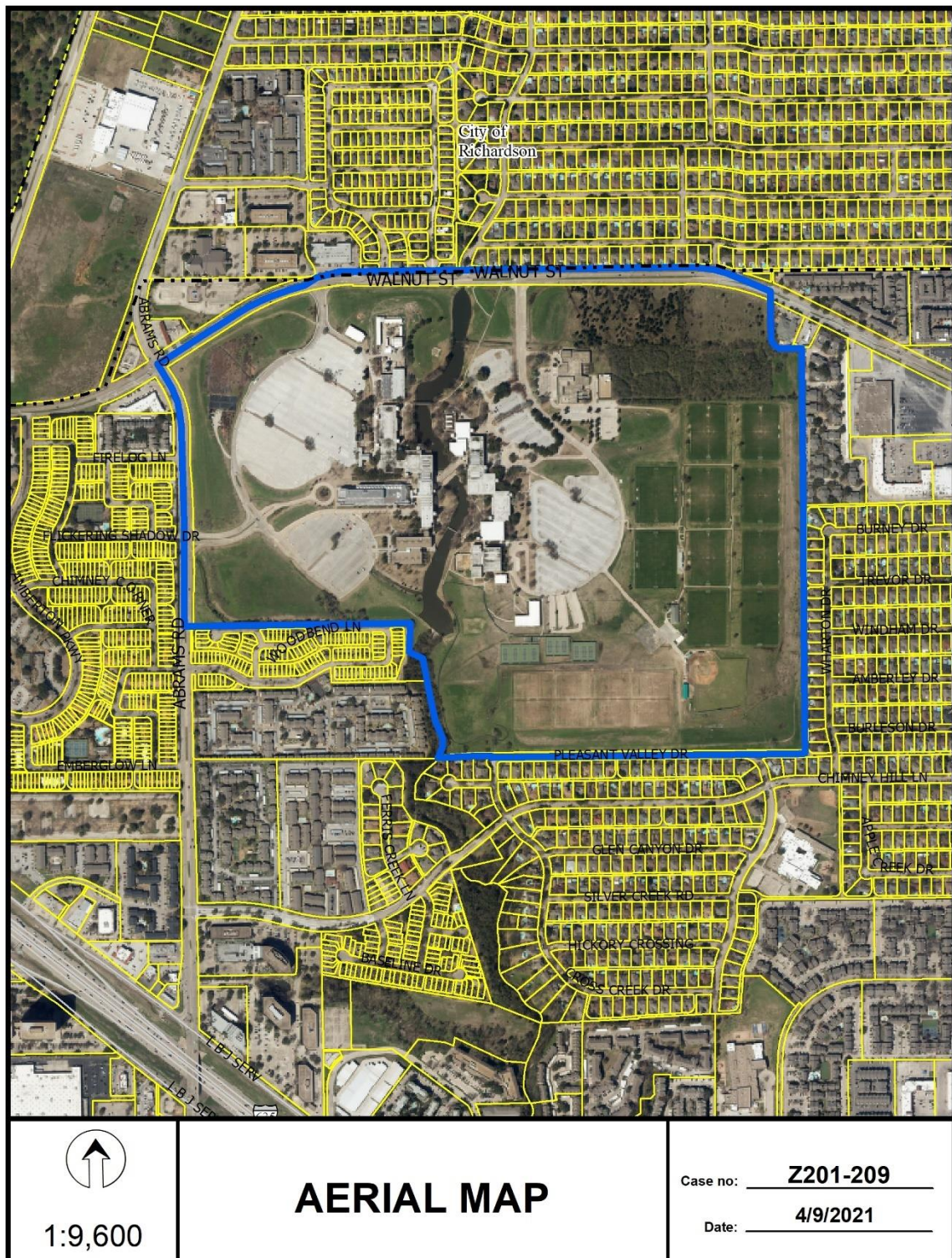
CPC RECOMMENDED SITE PLAN (ENLARGED)

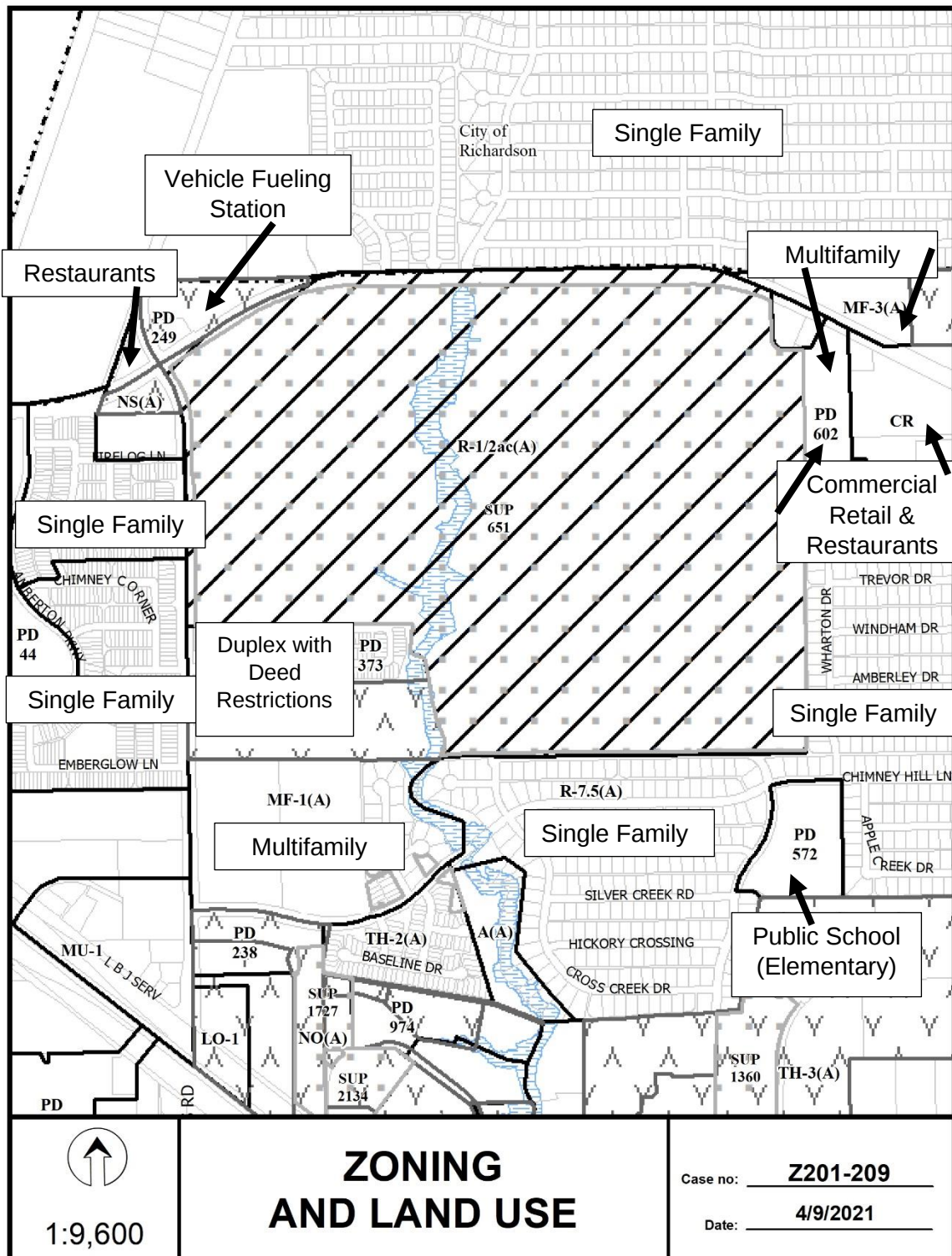


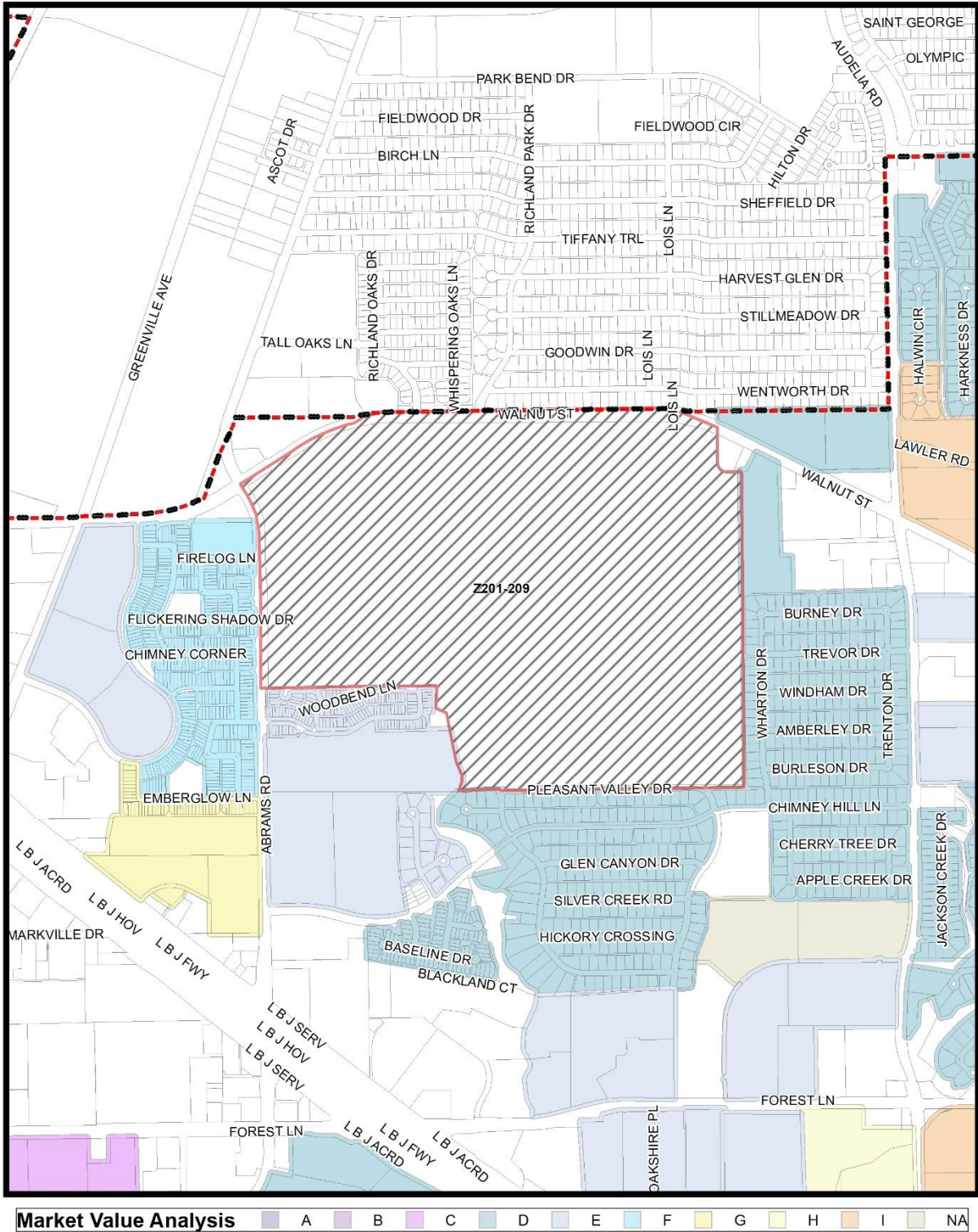
EXISTING SITE PLAN





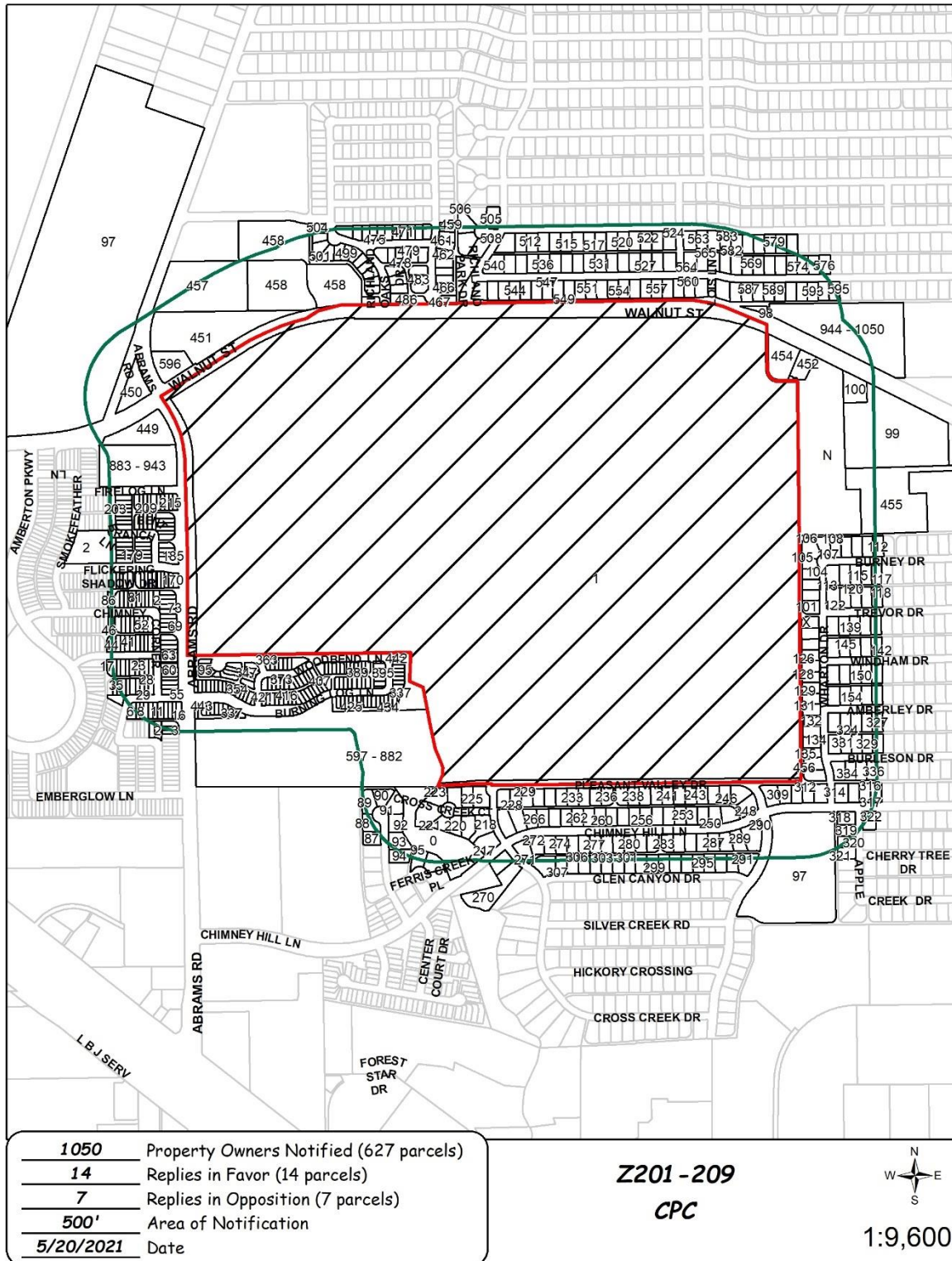
