WHEREAS, on April 26, 2017, City Council authorized a Memorandum of Understanding with Housing Forward f/k/a Metro Dallas Homeless Alliance (Housing Forward) for continued participation in the local Homeless Management Information System (HMIS), effective April 1, 2017, a Subscription Services Agreement with Pieces Technology, Inc., for use of the Pieces Iris software solution being implemented by Housing Forward as the new HMIS, effective April 1, 2017; and execution of any and all documents required for participation in the HMIS by Resolution No. 17-0713; and

WHEREAS, on February 26, 2020, City Council authorized a three-year contract with Housing Forward to administer the Dallas Homeless Response System Analysis and Reporting System, through the Homeless Management Information System in the city of Dallas, Texas from February 27, 2020 to February 26, 2023, by Resolution No. 20-0359; and

WHEREAS, on February 21, 2023, the City and Housing Forward executed Supplemental Agreement No. 1 to extend the initial term of the contract by three (3) months from February 27, 2023 to May 31, 2023, as authorized by Administrative Action No. 23-5380; and

WHEREAS, on December 22, 2023, the ratification of the services provided by Housing Forward for the period from June 1, 2023 through September 30, 2023 in the amount of \$50,000.00 was approved and authorized by Administrative Action No. 23-6734; and

WHEREAS, the ratification process is underway to pay any outstanding invoices for the services provided by Housing Forward for the period from October 1, 2023 to January 23, 2024; and

WHEREAS, the City Council finds there is a public purpose in providing for homeless management information system data management to assist persons experiencing homelessness as well as reduce the impact of homelessness in the City; and

WHEREAS, the City of Dallas seeks to enter into a thirty-two-month contract with Housing Forward f/k/a Metro Dallas Homeless Alliance for data services in support of the Homeless Response System.

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the City Manager is hereby authorized to execute a service price agreement with Housing Forward f/k/a Metro Dallas Homeless Alliance (517577), (Housing Forward), approved as a form by the City Attorney, for homeless management information system data management for the Office of Homeless Solutions for a term of thirty-two (32) months from January 24, 2024 through September 30, 2026, in an amount not exceed \$904,362.88. If the service was bid or proposed on an as needed basis, unit price basis for performance of specified tasks, payments made to Housing Forward shall be based only on the amount of the services directed to be performed by the City and properly performed by Housing Forward under the service price agreement.

SECTION 2. That the Chief Financial Officer is hereby authorized to disburse funds in an amount not to exceed \$904,362.88 (subject to annual appropriations) to Housing Forward from Service Price Agreement Contract No. OHS-2024-00023584.

SECTION 3. That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
