WHEREAS, the City of Dallas has identified the need to address severe erosion and stabilize eroded stream banks at five locations; and

WHEREAS, engineering services are required to evaluate options and develop construction documents and specifications for erosion control improvements at these locations; and

WHEREAS, Gresham Smith, 500 North Akard Street, Suite 3210, Dallas, Texas 75201, was selected as the most highly qualified proposer and has submitted an acceptable proposal to provide these engineering services.

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the proposal submitted by Gresham Smith, Contract No. SDM-2025-00027768, in the amount of \$349,317.50 be approved and the consultant be authorized to perform the required engineering services.

SECTION 2. That the City Manager is hereby authorized to execute a professional services contract with Gresham Smith, approved as to form by the City Attorney, to provide engineering services for the evaluation and design of erosion control improvements at five locations, in an amount not to exceed \$349,317.50.

SECTION 3. That expenditures made pursuant to this Resolution shall be made from lawfully available funds, including the General Obligation Commercial Paper Notes Series A and B (the "Commercial Paper Notes"), as amended, and any expenditures made pursuant to this Resolution from lawfully available funds shall be reimbursed from the proceeds of the Commercial Paper Notes or from the proceeds of general obligation bonds issued by the City up to the amount of expenditures authorized by this Resolution.

SECTION 4. That the Chief Financial Officer is hereby authorized to disburse funds, in an amount not to exceed \$349,317.50, to Gresham Smith, in accordance with the terms and conditions of the contract, as follows:
