Our vision is a community where everyone has safe, affordable housing and the tools to become self-reliant.



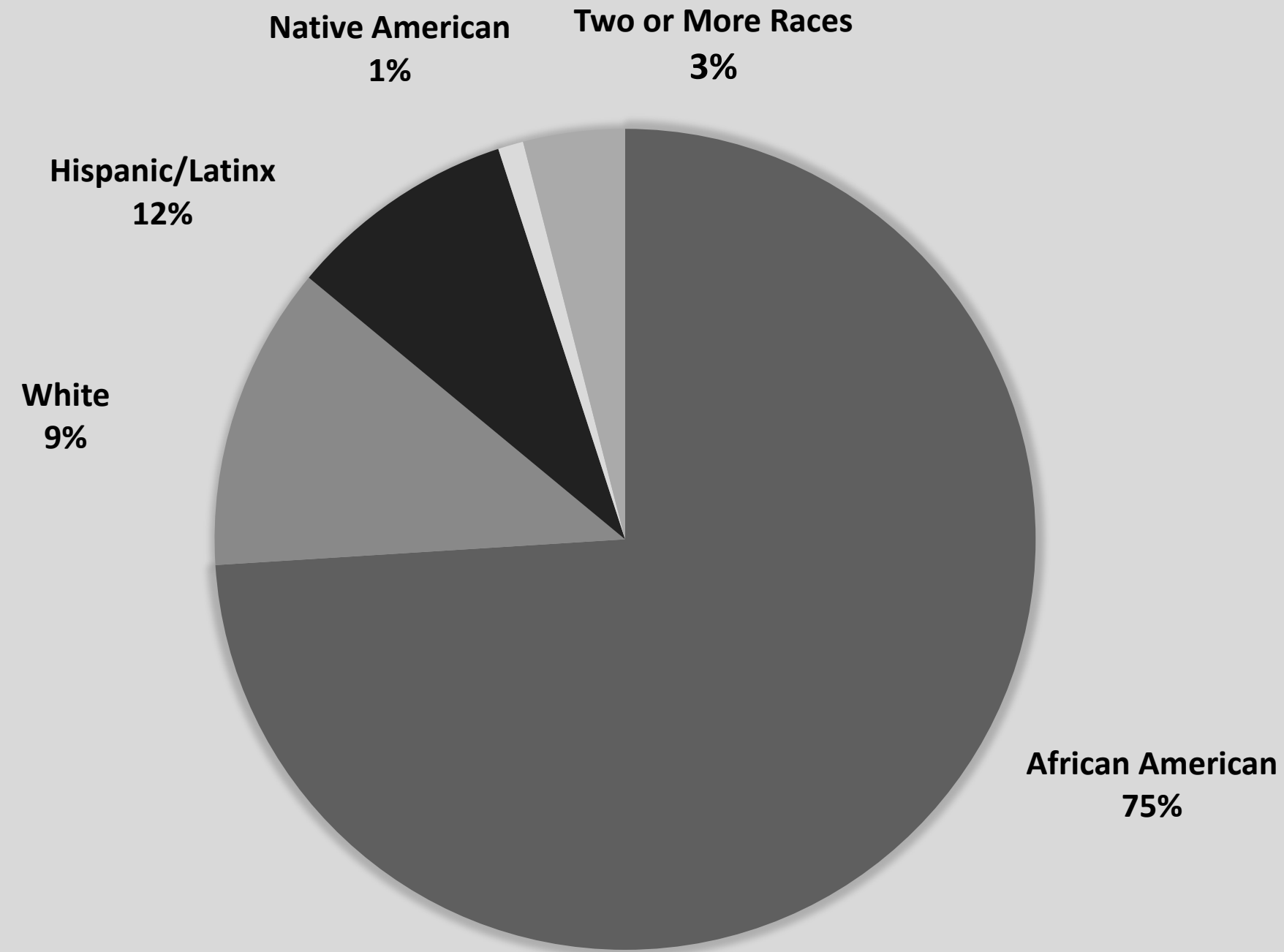

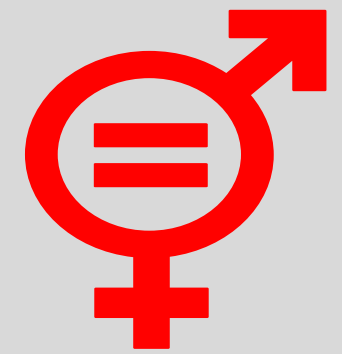

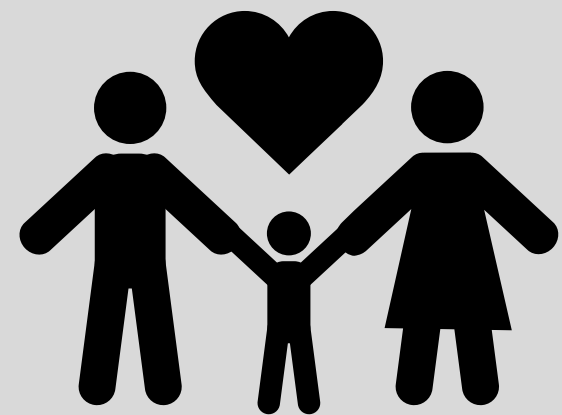

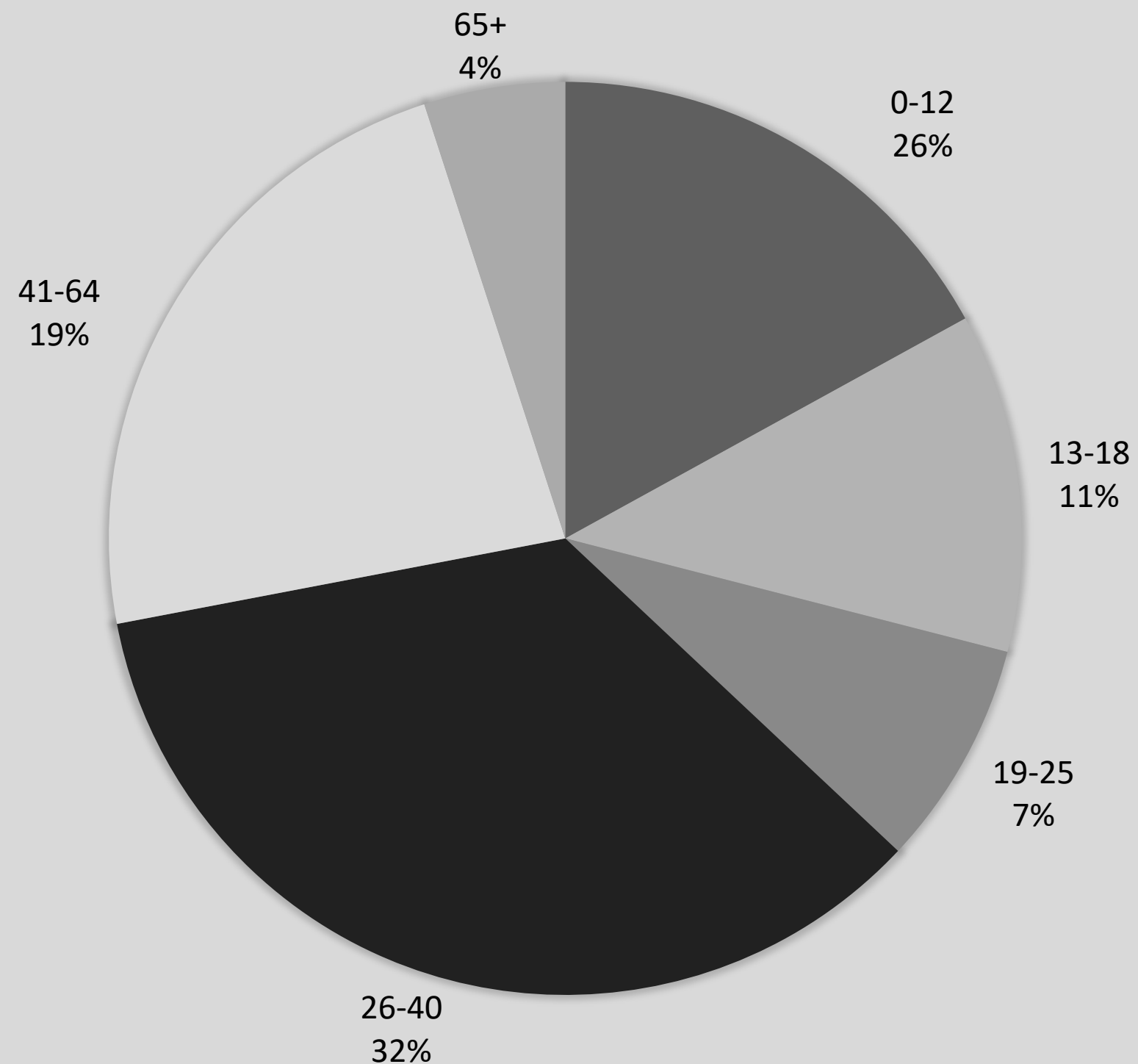

Under 1 Roof Housing Programs

Permanent Supportive Housing (PSH)

Combines rental/housing assistance with support services for individuals and families experiencing chronic homelessness or with disabling conditions such as physical, mental health, developmental disabilities, or substance abuse issues.

- HUD Unsheltered PSH - 75 households
- HUD Annual PSH - 25 households
- Dallas Housing Authority - 44 households

Rapid Rehousing (RRH)

Immediate assistance designed to help individuals and families exit homelessness quickly and return to permanent housing by providing short-term assistance, including financial help for rent and move-in costs, and case management services tailored to their needs.

- Street-to-Home Program - 75 households
- Youth Homeless Demonstration - 50 households
- HUD CoC Rapid Rehousing - 30 households
- City of Garland - 2 households



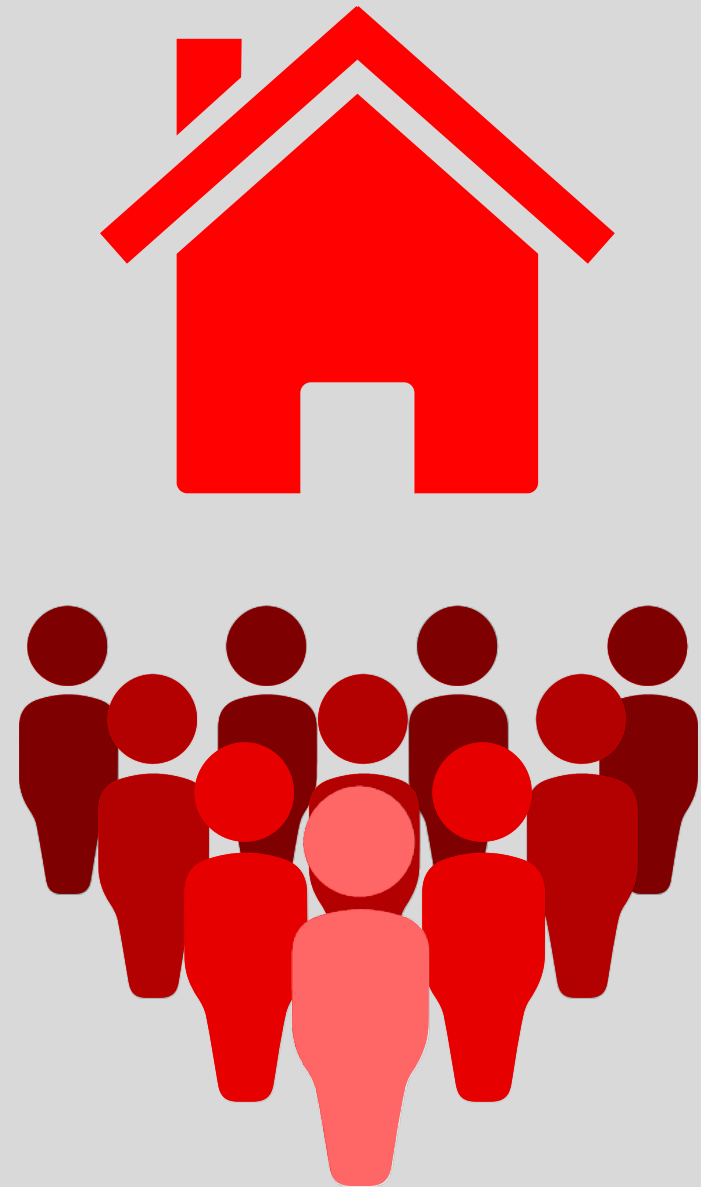
