WHEREAS, the Novel Coronavirus Disease 2019 ("COVID-19") pandemic has been declared a public health disaster; and

WHEREAS, the U.S. Department of the Treasury ("Treasury") has made funding available to the City of Dallas to cover expenses incurred due to the COVID-19 pandemic; and

WHEREAS, Coronavirus State Fiscal Recovery Fund by the U.S. Department of the Treasury Fund and the Texas office of the Governor has been made available for State Representative Yvonne Davis of District 111 ("District") in Texas to request as grant funding; and

WHEREAS, State Representative Davis was successful in securing a \$20,000,000.00 grant for the City of Dallas in areas within and around the District for housing and workforce development, parks and trails, libraries and cultural centers, and citizens health and physical development; and

WHEREAS, Representative Davis identified several future projects that can be aligned with the grant requirements; and

WHEREAS, Representative Davis desires to partner with the City of Dallas to execute those projects.

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the City Manager is hereby authorized to accept grant funds from the Texas Parks and Wildlife Department (TWPD) for the Coronavirus State and Local Fiscal Recovery Fund (CFDA / Assistance Listing No. 21.027, Federal Award Identification No. 2021-CS-21027,TPWD Contract No. CA-0003308, Project No. AR-000001) in the amount of \$20,000,000.00 for the purpose of housing and workforce development, parks and trails, libraries and cultural centers, and citizens health and physical development, for the period November 8, 2021 to May 31, 2024, and execute an agreement between the Texas Parks and Wildlife Department and the City of Dallas and all terms, conditions, and documents required by the agreement, approved as to form by the City Attorney.

SECTION 2. That the Chief Financial Officer is hereby authorized to receive and deposit grant funds in an amount not to exceed \$20,000,000.00 in the Texas Parks and Wildlife Coronavirus State and Local Fiscal Recovery Fund, Fund FC31, Department CMO, Unit 937G, Object 3099, Revenue Code 6506.

- **SECTION 3.** That the City Manager is hereby authorized to establish appropriations in an amount not to exceed \$20,000,000.00 in the Texas Parks and Wildlife Coronavirus State and Local Fiscal Recovery Fund, Fund FC31, Unit 937G, Department CMO, Object 3099.
- **SECTION 4.** That the Chief Financial Officer is hereby authorized to disburse funds in an amount not to exceed \$20,000,000.00 in the Texas Parks and Wildlife Coronavirus State and Local Fiscal Recovery Fund, Fund FC31, Department CMO, Unit 937G, Object 3099.
- **SECTION 5.** That when necessary, the City Manager or designee is authorized to execute contracts and agreements to commit and expend funds timely to execute projects while meetings federal and/or state requirements.
- **SECTION 6.** That the City Manager is hereby authorized to take all necessary actions to account for and report the use, including but not limited to creating additional funds/units, and transferring appropriations between funds/units as efforts continue and further information on eligible uses is released.
- **SECTION 7.** That the City Manager is hereby authorized to execute all documents and agreements necessary to administer the funds, including but not limited to agreement(s), approved as to form by the City Attorney.
- **SECTION 8.** That the City Manager is hereby authorized to reimburse to the granting agency any expenditures identified as ineligible. The City Manager shall notify the appropriate City Council Committee of expenditures identified as ineligible not later than 30 days after the reimbursement.
- **SECTION 9.** That the City Manager shall keep the appropriate City Council Committee informed of all final granting agency monitoring reports not later than 30 days after the receipt of the report.
- **SECTION 10.** That the City Manager or his designee is authorized to provide additional information, make adjustments, and take other actions related to the implementation of the grant as may be necessary to satisfy the Texas Park and Wildlife Department requirements.
- **SECTION 11.** That this contract is designated as Contract No. CMO-2022-00020202.
- **SECTION 12.** That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
