# Background/History



 In June, 2019, City Council approved a 5-year lease extension with the Dallas Theater Center (DTC) for the Kalita Humphreys Theater, which authorized DTC, to hire an independent thirdparty consultant to update the Master Plan for the site and historic building at DTC expense



# Background/History



- The Kalita Humphreys Theater is an important cultural asset in need of investment and repair:
  - Historic home of Dallas Theater Center (DTC) designed by Frank Lloyd Wright
  - No major capital investment since 1989
  - Opportunities for better connections to Katy
     Trail and surrounding neighborhoods



# **Purpose**



 Update the Committee on work completed prior to COVID-19 on Master Plan update

 Review terms for a necessary extension to the Kalita Humphreys Theater lease



# Work Completed by DTC:



- DTC worked diligently on this project from June 2019 until early March 2020:
  - Formed Steering Committee in line with Council recommendation, meeting with this group monthly
  - Conducted an RFQ and subsequent RFP, resulting in interviews with three firms in January 2020
  - Selected Diller Scofidio + Renfro (DS+R) and full team of consultants
  - Began first round of site tours and local meetings
  - Hosted first community meeting on Wednesday, March 4, 2020, attended by more than 200
  - Secured \$1.255M+ of estimated \$2M budget for project

# Impact of COVID on DTC and Master Plan



- The Dallas art institutions, including DTC, shuttered on March 13, 2020, and ultimately DTC had to cancel the remainder of the season
- DTC has yet to receive permission to resume in-person work from three critical unions:
   Actors Equity, United Scenic Artists (designers), and Society of Stage Directors and
   Choreographers
  - These groups evaluate a host of building features, operational protocols and COVID community spread and public health data
- DTC continues to support the community via virtual classes, the Public Works program and other outreach efforts, including production of 2,500 masks
- Fundraising efforts and support have allowed DTC to keep staff largely intact and in a position to return to production
- COVID health restrictions, which made team- and community-based design work challenging, and resulting economic stresses to DTC meant the Master Plan was paused



# **Recommended Extension**



- DTC believes that it will be able to resume the Master Plan work when:
  - It has returned to full operations for six months, meaning it can sell a full house of tickets, AND
  - Relevant unions have granted permission to return to inperson work.
- Upon restarting, DTC needs 10 months to complete the Master Plan work
- This revised timeline for the Master Plan work does not impact the overall 5-year term of the DTC Lease at the Kalita

SUBJECT Fair Park Children's Aquarium Interim Operating Funding for FY 2020-21

On the upcoming December 9, 2020 City Council agenda, Park & Recreation will request consideration of interim funding for the Fair Park Children's Aquarium in the existing contract with the Dallas Zoo. Staff is currently working with Fair Park First and the Dallas Zoo on a plan to allow the Aquarium to continue operations for an interim period of up to six months in order to facilitate the transition of the facility to a new operator. The estimated cost of this six-month transition plan is \$300,000. However, the goal is to accelerate the timeline and bring in the new potential operator in three months.

In order to accomplish this, staff will first reprogram Council District 7 equity funds in the amount of \$300,000 so that the Dallas Zoo can continue to maintain the facility and aquatic life currently housed in the Aquarium. Next, staff will work with Fair Park First to structure an amendment to their contract to add the Aquarium Building, which will allow Fair Park First to negotiate a proposal and agreement with a new potential operator. It is anticipated that the contract amendment will come before the Park and Recreation Board and City Council in the December 2020/January 2021 timeframe. Additional background is provided below.

## Background

The Fair Park Children's Aquarium, managed by the Dallas Zoo, opened 2010 and has hosted an average of 114,000 visitors annually in recent years. The Aquarium was partially funded by the Park and Recreation Department through the Dallas Zoo contract (approximately \$300,000 per year). Due to budget reductions and ongoing losses in operations, the Aquarium was to cease operations in FY20-21.

## SUBJECT Short-Term Rentals (STR) Task Force Update

For your information, this memorandum provides an update on the Short-Term Rentals (STR) Task Force created by this Committee to recommend regulations to mitigate impacts to neighborhood quality of life.

The task force is on-target to complete its recommendations by December 2020. Based on the Committee's recommendations in early 2021, staff will develop a forecast of the timeline for City Council adoption and implementation of any new regulations.

At its most recent meeting last week, the task force reviewed maps showing STR properties, associated calls for service and complaints, and other pertinent data. Additionally, the task force began the process of drafting recommendations for a final vote at its upcoming meeting in December.

Additionally, a staff team continues to focus on shorter-term, targeted compliance and enforcement measures against several STR properties with chronic quality of life complaints. Staff will be providing regular updates to councilmembers with targeted properties and a follow-up to Committee by December 2020.



## **BRIEF BACKGROUND:**


