WHEREAS, the City of Dallas has identified the need to provide flood management and storm drainage system improvements at 4 locations in the El Tivoli Neighborhood along Plymouth Road; and

WHEREAS, engineering services are required for the investigation, preliminary design, and development of construction plans and specifications to improve storm drainage infrastructure in the El Tivoli Neighborhood along Plymouth Road; and

WHEREAS, Lockwood, Andrews & Newnam, Inc., 8350 North Central Expressway, Suite 1400, Dallas, Texas 75206, has submitted an acceptable proposal to provide these engineering services.

Now, Therefore,

SECTION 3. That the Chief Financial Officer is hereby authorized to disburse funds in an amount not to exceed \$616,214.00 to Lockwood, Andrews & Newnam, Inc., in accordance with the terms and conditions of the contract, as follows:
