WHEREAS, on June 14, 2023, the City Council authorized an interlocal agreement with Dallas Area Rapid Transit (DART) for the distribution of up to \$80,000,000.00 in funding from DART which consists of the City's portion of (i) excess sales tax funds from DART of \$72,000,000.00 and (ii) additional Regional Transportation Council funds of approximately \$8,000,000.00, all to be used to complete projects eligible for this funding that will benefit DART's Public Transportation System or provide Complementary Transportation Services located in Dallas by Resolution No. 23-0822; and

WHEREAS, on June 26, 2024, the City Council authorized a professional engineering services contract with WSB, LLC for traffic signal design services for the following four intersections selected as part of the 2023 DART Public Transportation Improvement Program: Brookriver Drive at West Mockingbird Lane; Park Lane at Caruth Plaza; Abrams Road at Flickering Shadow Drive; and Ferguson Road at Millmar Drive, in an amount not to exceed \$400,081.00, by Resolution No. 24-0931; and

WHEREAS, on March 14, 2025, the City of Dallas Office of Procurement Services publicly advertised for competitive bids for CIZ25-TRN-3158 – DART Signals Group 4B to reconstruct two traffic signals at the intersections of Brookriver Drive at West Mockingbird Lane and Ferguson Road at Millmar Drive; and

WHEREAS, on April 4, 2025, the City of Dallas Office of Procurement Services received three bids for the project, listed as follows.

SECTION 1. That the City Manager is hereby authorized to execute a construction services contract with Roadway Solutions, Inc., lowest responsible bidder of three, approved as to form by the City Attorney, for the DART Signals Group 4B Project to reconstruct two traffic signals at the intersections of Brookriver Drive at West Mockingbird Lane and Ferguson Road at Millmar Drive, in an amount not to exceed \$944,907.50.

SECTION 2. That the Chief Financial Officer is hereby authorized to disburse funds in an amount not to exceed \$944,907.50 to Roadway Solutions, Inc., in accordance with the terms and conditions of the agreement, from the DART Transportation Projects Fund, Fund TN20, Department PBW, Unit X029, Object 4820, Program TP23X029, Encumbrance/Contract No. PBW-2025-00027672, Vendor 502110.
