**WHEREAS,** on June 13, 2018, the City Council authorized a contract with Hammett Excavation Inc. for the construction of two Municipal Waste Cells for a total of 52 acres, cells 6B2 and 7, with composite liner and leachate collections systems, McCommas Bluff Landfill; and site improvements that included, new waste cell access roads and environmental enhancements by Resolution No. 18-0817.; and

WHEREAS, on April 5, 2024, two bids were received and opened for construction of two Municipal Waste Cells for a total of 57acres, Cell 7A and 7B, at the McCommas Bluff Landfill; and site improvements that included upgraded drain pumps, control panels, electric services, and discharge systems, as follows:

WHEREAS, the bid submitted by Hammett Excavation, Inc., being the lowest responsible bidder, in the amount of \$11,150,266.08 for Base Bid, to include Alternate Nos. 1 and 2 in the amount of \$3,371,362.64\_ is the lowest bid received.

Now, Therefore,

## BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

**SECTION 1.** That the City Manager is hereby authorized to execute a <u>construction</u> <u>services</u> contract with Hammett Excavation Inc., approved as to form by the City Attorney, for the construction of two Municipal Waste Cells for a total of 57 acres, Cell 7A and 7B, at the McCommas Bluff Landfill; and site improvements that include upgraded drain pumps, control panels, electric service, and discharge systems, in an amount not to exceed \$14,521,628.72.

**SECTION 2.** That the Chief Financial Officer is hereby authorized to disburse funds in an amount not to exceed \$14,521,628.72 to Hammett Excavation, Inc. from the Sanitation Capital Improvement Fund, Fund 0593, Department SAN; Unit PB01, Object 4599, Encumbrance/Contract No. CX-SAN-2024-00024886, Vendor VS0000075903, Program SANCELL7A7B.

**SECTION 3.** That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
