

## ORDINANCE NO. \_\_\_\_\_

An ordinance amending Chapter 28, “Motor Vehicles and Traffic,” of the Dallas City Code by amending Sections 28-44, 28-50, and 28-59; designating speed regulations on streets other than expressways and freeways; designating school traffic zones; designating one-way streets and alleys; providing a penalty not to exceed \$200; providing a saving clause; providing a severability clause; and providing an effective date.

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That Section 28-44, “Streets Other than Expressways and Freeways,” of Division 2, “Speed Regulations,” of Article VI, “Operation of Vehicles,” of Chapter 28, “Motor Vehicles and Traffic,” of the Dallas City Code is amended by alphabetically adding and deleting the following described streets where the speed of motor vehicles is limited as follows:

**ADDITIONS**

<u>STREET</u>	<u>BLOCK(s)</u>	<u>SPEED(MPH)</u>
“Elsie Faye Heggins Street	Botham Jean Boulevard to Spring Avenue	35”

**DELETIONS**

<u>STREET</u>	<u>BLOCK(s)</u>	<u>SPEED(MPH)</u>
“Elsie Faye Heggins Street	Lamar Street to 500 feet South of Lyons Street	35”

SECTION 2. That Subsection (c) of Section 28-50, “Speed in School Zones; Signs; Designated Streets,” of Division 2, “Speed Regulations,” of Article VI, “Operation of Vehicles,” of Chapter 28, “Motor Vehicles and Traffic,” of the Dallas City Code is amended by alphabetically adding and deleting the following described streets designated as school traffic zones where the speed of motor vehicles is limited to 20 miles per hour:

“N. Jim Miller Road	1400-1600	220’ S. of Seco Boulevard to 150’ S. of Umphress Road
S. Vernon Avenue	2000-2500	510’ N. of W. Illinois Avenue to 90’ S. of Ferndale Avenue”

#### **DELETIONS**

<u>STREET</u>	<u>BLOCK(s)</u>	<u>EXTENT</u>
“Alpha Road	7500-7600	270’ W. to 270’ E. of Meandering Way
Dallas North Tollway west service road		220’N. of Wycliff Avenue to Wycliff Avenue
N. Jim Miller Road	1400-1600	500’S. of Umphress Road to 300’S. of Seco Boulevard
Meandering Way	13400-13700	Purple Sage Road to 180’N. of Peyton Drive
Spring Grove Avenue	13400-13600	150’W. of Meandering Way to 200’E. of Knollwood Drive
Vernon Avenue	2000-2300	100’S. of Ludlow Street to 150’S. of Ferndale Avenue
Wycliff Avenue	2500-2800	75’W. of Hartford Street to 350’E. of Maple Avenue”

SECTION 3. That Section 28-59, “One-Way Streets and Alleys,” of Article VII, “One-Way Streets and Alleys,” of Chapter 28, “Motor Vehicles and Traffic,” of the Dallas City Code is amended by adding the following described street to be designated as a one-way street where a vehicle shall move only in the direction indicated, when signs indicating the direction of traffic are erected at each intersection:

**ADDITIONS**

<u>STREET</u>	<u>EXTENT</u>	<u>DIRECTION</u>
“N. Denley Drive	E. 8th Street to E. 9th Street	South”

SECTION 4. That a person violating a provision of this ordinance, upon conviction, is punishable by a fine not to exceed \$200.

SECTION 5. That Chapter 28 of the Dallas City Code shall remain in full force and effect, save and except as amended by this ordinance.

SECTION 6. That any act done or right vested or accrued, or any proceeding, suit, or prosecution had or commenced in any action before the amendment or repeal of any ordinance, or part thereof, shall not be affected or impaired by amendment or repeal of any ordinance, or part thereof, and shall be treated as still remaining in full force and effect for all intents and purposes as if the amended or repealed ordinance, or part thereof, had remained in force.

SECTION 7. That the terms and provisions of this ordinance are severable and are governed by Section 1-4 of Chapter 1 of the Dallas City Code, as amended.

SECTION 8. That this ordinance shall take effect immediately from and after its passage and publication in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so ordained.
