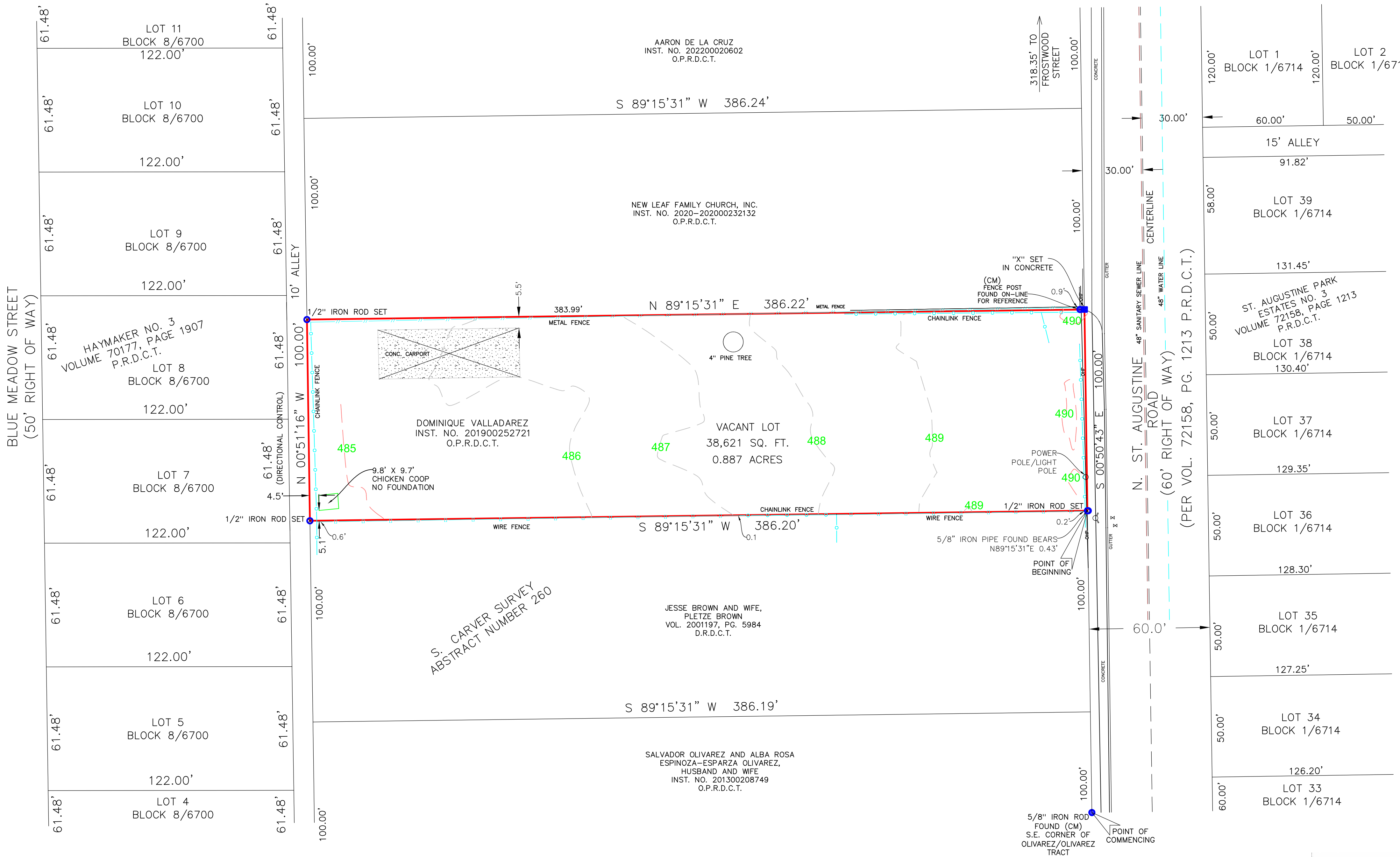


VICINITY MAP (NTS)

AUGUSTINE ROAD AND BEING THE SOUTHEAST CORNER OF THAT TRACT OF LAND CONVEYED TO SALVADOR OLIVAREZ AND ALBA ROSA ESPINOZA-ESPARZA, HUSBAND AND WIFE, BY DEED RECORDED IN INSTRUMENT NUMBER 201300208749, DEED RECORDS, DALLAS COUNTY, TEXAS;

THENCE NORTH 00 DEGREES 50 MINUTES 43 SECONDS WEST, ALONG THE WEST LINE OF SAID N. ST. AUGUSTINE, A DISTANCE OF 200.23 FEET TO A 1/2" IRON ROD SET, SAID ROD BEING THE NORTHEAST CORNER OF THAT TRACT OF LAND CONVEYED TO JESSE BROWN AND WIFE, PLETZE BROWN, BY DEED RECORDED IN VOLUME 2001197, PAGE 5984, DEED RECORDS, DALLAS COUNTY, TEXAS AND THE POINT OF BEGINNING ON THAT TRACT HEREIN DESCRIBED;

THENCE SOUTH 89 DEGREES 15 MINUTES 31 SECONDS WEST, ALONG THE NORTH LINE OF SAID BROWN TRACT, A DISTANCE OF 386.20 FEET TO 1/2" IRON ROD SET FOR CORNER, SAID ROD BEING IN A 10' ALLEY;

THENCE NORTH 00 DEGREES 51 MINUTES 16 SECONDS WEST, ALONG THE EAST LINE OF SAID 10' ALLEY, A DISTANCE OF 100.00 FEET TO A 1/2 INCH IRON ROD SET, SAID ROD BEING THE SOUTHWEST CORNER OF THAT TRACT OF LAND CONVEYED TO NEW LEAF FAMILY CHURCH, INC., BY DEED RECORDED IN INSTRUMENT NUMBER 2020-202000232132, DEED RECORDS, DALLAS COUNTY, TEXAS;

THENCE NORTH 89 DEGREES 15 MINUTES 31 SECONDS EAST, ALONG THE SOUTH LINE OF SAID NEW LEAF FAMILY CHURCH TRACT, PASSING AT A DISTANCE OF 383.99 FEET TO A FENCE POST FOUND ON LINE FOR REFERENCE, CONTINUING A TOTAL DISTANCE OF 386.22 FEET TO AN "X" SET IN CONCRETE FOUND, SAID "X" SET BEING THE SOUTHEAST CORNER OF SAID NEW LEAF FAMILY CHURCH TRACT AND BEING IN THE WEST LINE OF AFORESAID N. ST. AUGUSTINE ROAD;

THENCE SOUTH 00 DEGREES 50 MINUTES 43 SECONDS EAST, ALONG THE WEST LINE OF SAID N. ST.AUGUSTINE ROAD, A DISTANCE OF 100.00 FEET TO THE POINT OF BEGINNING AND CONTAINING 38,621 SQUARE FEET OR 0.887 ACRES OF LAND.

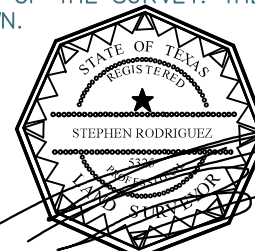
