**WHEREAS**, on January 25, 2023 the City Council authorized execution of a reimbursement agreement with the Dallas Museum of Art, approved as to form by the City Attorney, for professional de-installation, moving, storage, and reinstallation of artwork in the from the Reeves Galleries of the Dallas Museum of Art, to enable facilities repair following the 2022 Severe Weather and Flooding event for the term beginning September 1, 2022, in an amount not to exceed \$595,700.00, by Resolution No. 23-0182; and

**WHEREAS**, the City of Dallas has a contract agreement with the Dallas Museum of Art related to the construction and operation of the Dallas Museum of Art located at 1717 North Harwood Street; and

**WHEREAS**, the Governor of the State of Texas declared Dallas County a natural disaster area on August 23, 2022 pursuant to State Law; and

**WHEREAS**, the City of Dallas, experienced property damage at the Dallas Museum of Art in the Reeves Galleries caused by the severe weather and flood events on August 21, 2022 and August 22, 2022; and

**WHEREAS**, the City of Dallas has determined that a need exists to repair damaged city facilities that are insured, and which include the Dallas Museum of Art, and the City must respond to prevent a public health safety hazard; and

**WHEREAS**, the necessary artwork de-installation, storage, and re-installation by the Dallas Museum of Art is to be conducted at the direction of the City of Dallas and the City will only reimburse the Dallas Museum of Art City for services properly performed pursuant to a reimbursement agreement and eligible for insurance payout.

**Now, Therefore,**

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:**

**SECTION 1.** That the City Manager is hereby authorized execute Supplemental Agreement No. 1 to the reimbursement agreement to increase funds with the Dallas Museum of Art, approved as to form by the City Attorney, for professional de-installation, moving, storage, and reinstallation of artwork in the from the Reeves Galleries of the Dallas Museum of Art, to enable facilities repair following the 2022 Severe Weather and Flooding event for the term beginning September 1, 2022, in an amount not to exceed \$150,196.00, from \$595,700.00 to \$745,896.00.

**SECTION 2.** That the Chief Financial Officer is hereby authorized to disburse funds in an amount not to exceed \$150,196.00 to Dallas Museum of Art in accordance with the terms and conditions for the contract from 2022 Severe Weather and Flooding Fund, Fund 0790, Department BMS, Unit 2394, Object 3099, Encumbrance/Contract No. CX-OCA-2023-00021052, Vendor 188483.

**SECTION 3.** That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
