**WHEREAS**, bid specifications were developed and publicly advertised for competitive bids associated with 2023 Annual Street Maintenance Improvement Contract; and

**WHEREAS**, on September 22, 2021, City Council authorized the final reading and adoption of the appropriation ordinance for the FY 2021-22 City of Dallas Operating, Capital, and Grant & Trust Budgets, which included the ARPA Funds from the U.S. Department of Treasury for the Coronavirus Local Fiscal Recovery Funds, by Resolution No. 21-1590; and

**WHEREAS**, on October 12, 2022, two bids were received for the 2023 Annual Street Maintenance Improvement Contract; and

**WHEREAS**, on January 11, 2023, the City Council authorized a construction contract with Texas Materials Group, dba TexasBit, a CRH company, for the 2023 Annual Street Maintenance Improvement Contract, in an amount not to exceed \$48,906,741.15, by Resolution No. 23-0114; and
