WHEREAS, on June 24, 2020, the City Council authorized acceptance of the 2020-21 Veterans Treatment Court Grant from the Texas Veterans Commission (TVC) Fund for Veterans' Assistance for continuation of the South Oak Cliff Community Court to include the South Oak Cliff Veterans Treatment Court Project for the period July 1, 2020 through June 30, 2021; the establishment of appropriations in an amount not to exceed \$100,000.00 in the 2020-21 Veterans Treatment Court Grant Fund; the receipt and deposit of funds in an amount not to exceed \$100,000.00 in the 2020-21 Veterans Treatment Court Grant Fund; and execution of the grant agreement and all terms, conditions, and documents required by the grant by Resolution No. 20-0964; and

WHEREAS, on June 23, 2021, the City Council authorized the acceptance of the 2021-22 Veterans Treatment Court Grant in the amount of \$50,000.00 from the TVC Fund for Veterans' Assistance for continuation of the South Oak Cliff Community Court to include the South Oak Cliff Veterans Treatment Court Project for the period July 1, 2021 through June 30, 2022; establishment of appropriations in an amount not to exceed \$50,000.00 in the 2021-22 Veterans Treatment Court Grant Fund; the receipt and deposit of funds in an amount not to exceed \$50,000.00 in the 2021-22 Veterans Treatment Court Grant Fund; and execution of the grant agreement and all terms, conditions, and documents required by the agreement by Resolution No. 21-1150; and

WHEREAS, on June 22, 2022, the City Council authorized the acceptance of the 2022-23 Veterans Treatment Court Grant in the amount of \$50,000.00 from the TVC Fund for Veterans' Assistance for continuation of the South Oak Cliff Community Court to include the South Oak Cliff Veterans Treatment Court Project for the period July 1, 2022 through June 30, 2023; establishment of appropriations in an amount not to exceed \$50,000.00 in the 2022-23 Veterans Treatment Court Grant Fund; the receipt and deposit of funds in an amount not to exceed \$50,000.00 in the 2022-23 Veterans Treatment Court Grant Fund; and execution of the grant agreement and all terms, conditions, and documents required by the agreement by Resolution No. 22-0940; and

WHEREAS, on June 28, 2023, the City Council authorized the acceptance the 2023-24 Veterans Treatment Court Grant in the amount of \$50,000.00 from the TVC Fund for Veterans' Assistance for continuation of the South Oak Cliff Community Court to include the South Oak Cliff Veterans Treatment Court Project for the period July 1, 2023 through June 30, 2024; establishment of appropriations in an amount not to exceed \$50,000.00 in the FY23-24 South Oak Cliff Veterans Treatment Court Fund; receipt and deposit of funds in an amount not to exceed \$50,000.00 in the FY23-24 South Oak Cliff Veterans Treatment Court Fund; and execution of the grant agreement and all terms, conditions and documents required by the agreement by Resolution No. 23-0865; and

WHEREAS, on June 26, 2024, the City Council authorized the acceptance of the TVC Fund for Veterans' Assistance (Grant No. VCT24-V-023) in the amount of \$50,000.00 for continuation of the South Oak Cliff Community Court to include the South Oak Cliff Veterans Treatment Court Project for the period July 1, 2024 through June 30, 2025; establishment of appropriations in an amount not to exceed \$50,000.00 in the 2024-2025 TVC-Veteran Treatment Court Grant Fund; receipt and deposit of funds in an amount not to exceed \$50,000.00 in the 2024-2025 TVC-Veteran Treatment Court Grant Fund; and execution of the grant agreement with the Texas Veterans Commission and all terms, conditions and documents required by the agreement by Resolution No. 24-0907; and

WHEREAS, the City of Dallas seeks to continue the South Oak Cliff Veterans Treatment Court Program at the South Oak Cliff Community Court that will incorporate alcohol/drug treatment, recovery support services, general support services, screening, assessment, case management, outreach, and program coordination specifically for veterans; and

WHEREAS, TVC's Fund for Veterans' Assistance has awarded the City two grants with the project period from July 1, 2025, to August 31, 2026; and

WHEREAS, TVC's Fund for Veterans' Assistance has made grant funds available during the 2025-26 fiscal year and partially during the 2024-25 fiscal year to offer veterans participating in the South Oak Cliff Veterans Treatment Court with direct services, including housing, utility, and transportation assistance. Additionally, the funds offered through TVC's General Assistance Program will provide housing, utility, and transportation assistance to veterans regardless of whether they have a municipal citation; and

WHEREAS, the grant funding would benefit the City in its endeavor to reduce crime, help affected veterans with mental health, drug, and alcohol recovery, increase self-sufficiency, and improve the quality of life; and

WHEREAS, the City finds it in the best interest of the City's residents that the grant funds be accepted for the 2025-2026 fiscal year and partially during the 2024-25 fiscal year; and

WHEREAS, the City agrees that in the event of loss or misuse of the grant funds, the City will return the funds identified as ineligible to the Texas Veterans Commission; and

WHEREAS, the City designates the City Manager or her designee as the grantee's authorized official, who has the power to apply for, accept, reject, alter, or terminate the grant on behalf of the City.

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

- **SECTION 1.** That the City Manager is hereby authorized to: **(1)** accept two grants from the Texas Veterans Commission Fund for **(a)** the TVC Veteran Treatment Court Program (Grant No. VTC25-V-003) in the amount of \$50,000.00 for continuation of the South Oak Cliff Community Court Program; and **(b)** the TVC General Assistance Program (Grant No. GEN25-F-056) in the amount of \$180,000.00 to further support veterans and their families, for the period July 1, 2025 through August 31, 2026; and **(2)** execute the grant agreements with the Texas Veterans Commission and all terms, conditions, and documents required by the agreements, approved as to form by the City Attorney.
- **SECTION 2.** That the City Manager is hereby authorized to establish appropriations in an amount not to exceed \$50,000.00 in the TVC FY25-26 Veteran Treatment Court Grant Fund, Fund S442, Department ATT, Unit 683S, various Object Codes per the attached Schedule and in an amount not to exceed \$180,000.00 in the TVC FY25-26 General Assistance Program Grant Fund, Fund S441, Department ATT, Unit 683R, Object 3070.
- **SECTION 3.** That the Chief Financial Officer is hereby authorized to receive and deposit funds in an amount not to exceed \$50,000.00 in the TVC FY25-26 Veteran Treatment Court Grant Fund, Fund S442, Department ATT, Unit 683S, Revenue Code 6516 and in an amount not to exceed \$180,000.00 in the TVC FY25-26 General Assistance Program Grant Fund, Fund S441, Department ATT, Unit 683R, Revenue Code 6516.
- **SECTION 4.** That the Chief Financial Officer is hereby authorized to disburse grant funds in an amount not to exceed \$50,000.00 from the TVC FY25-26 Veteran Treatment Court Grant Fund, Fund S442, Department ATT, Unit 683S, various Object Codes per the attached Schedule and in an amount not to exceed \$180,000.00 from the TVC FY25-26 General Assistance Program Grant Fund, Fund S441, Department ATT, Unit 683R, Object 3070.
- **SECTION 5.** That the City Manager is hereby authorized to reimburse the Texas Veterans Commission Fund for Veterans' Assistance of any expenditure identified as ineligible. The City Manager shall notify the appropriate City Council Committee of expenditures identified as ineligible not later than 30 days after the reimbursement.
- **SECTION 6.** That the City Manager shall keep the appropriate City Council Committee informed of all final granting agency monitoring reports not later than 30 days after the receipt of the report.
- **SECTION 7.** That the contract for the Veteran Treatment Court Program (Grant No. VTC25-V-003) is designated as Contract No. ATT-2025-00028431.
- **SECTION 8.** That the contract for the General Assistance Program (Grant No. GEN25-F-056) is designated as Contract No. ATT-2025-00028432.
- **SECTION 9.** That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
