Rules of Courtesy

City Council meetings bring together citizens of many varied interests and ideas. To insure fairness and orderly meetings, the Council has adopted rules of courtesy which apply to all members of the Council, administrative staff, news media, citizens and visitors. These procedures provide:

- That no one shall delay or interrupt the proceedings, or refuse to obey the orders of the presiding officer.
- All persons should refrain from private conversation, eating, drinking and smoking while in the Council Chamber.
- Posters or placards must remain outside the Council Chamber.
- No cellular phones or audible beepers allowed in Council Chamber while City Council is in session.

"Citizens and other visitors attending City Council meetings shall observe the same rules of propriety, decorum and good conduct applicable to members of the City Council. Any person making personal, impertinent, profane or slanderous remarks or who becomes boisterous while addressing the City Council or while attending the City Council meeting shall be removed from the room if the sergeant-at-arms is so directed by the presiding officer, and the person shall be barred from further audience before the City Council during that session of the City Council. If the presiding officer fails to act, any member of the City Council may move to require enforcement of the rules, and the affirmative vote of a majority of the City Council shall require the presiding officer to act." Section 3.3(c) of the City Council Rules of Procedure.

Handgun Prohibition Notice for Meetings of Governmental Entities

"Pursuant to Section 46.03, Penal Code (places weapons prohibited), a person may not carry a firearm or other weapon into any open meeting on this property."

Subject Properties



- Vacant and abandoned properties



Current Conditions



UNT Blight Study June 2023:

- The number of “blighted” census tracts fell from 51 census tracts in 2011 to 31 tracts in 2021.
- 2011 – Dallas had 28,819 vacant residential parcels – 7.95% of all parcels that were zoned residential.
- 2021 – 73.8% of these properties continued to remain vacant.
- Of those redeveloped by 2021 – about 99.3% were occupied by a single-family home.



Current Enforcement Options



- Escalated enforcement
- Foreclosure
- While these are significant tools, they are not without limitations.



Purpose



- To inform the committee about a tool available to Texas home-rule cities as they revitalize abandoned and vacant properties.



Section 214.0031 of the Tex. Loc. Gov't Code



State law allows a city or an **eligible nonprofit housing organization** to file lawsuits against owners of properties that are not in substantial compliance with city code.

The ordinances must relate to:

- 1) the prevention of substantial risk of injury to any person; or
- 2) the prevention of an adverse health impact to any person.





- A non-profit organization may be certified if:
 - 1) it has record of community involvement;
and
 - 2) the certification furthers the city's goal to rehabilitate hazardous properties.



Court Action



- The non-profit organization would have the authority to file a lawsuit to seek a court order:
 - To require the property owner to make repairs; or
 - To appoint a receiver to take control of the property and make the repairs.
- Owner-Occupied Exemption



Similar Authority



- Chapter 125 of the Texas Civil Practice and Remedies Code authorizes **an individual**, the attorney general, or a district, county, or city attorney to file a suit to enjoin and abate a common nuisance.



Other Jurisdictions



Cities and states across the country are utilizing similar process:

- Philadelphia, Pennsylvania
- Baltimore, Maryland
- Memphis, Tennessee
- Holyoke, Massachusetts



Operational Impact



- Expands the city's capacity to hold property owners accountable
- Increases the city's single-family housing stock
- No additional costs
- Empowers residents and stakeholders



Proposed Process



1. Requests submitted to the CAO.
2. City staff evaluates the request.
3. Certificate of eligibility is issued.
4. CAO tracks subsequent enforcement.



Next Steps



- Continue educating residents and non-profit organizations.
- Start reviewing and certifying organizations.
- Provide updates to QOL committee.

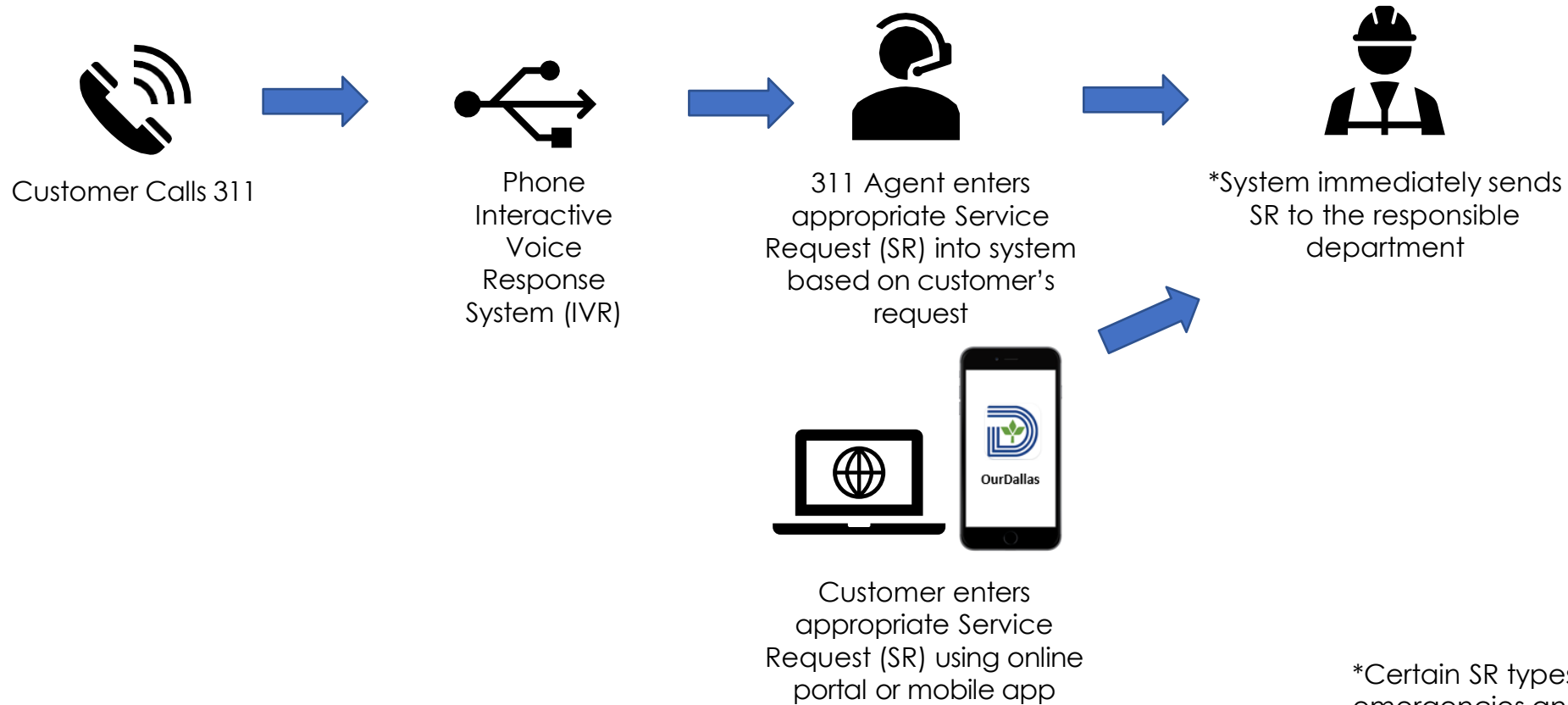


Dallas 311 (311) serves as a vital resource for residents to connect with their city for non-emergency services.

 - Service request system and mobile app administration



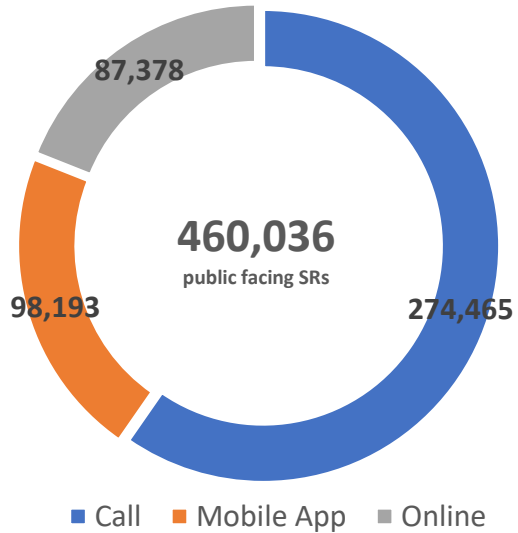

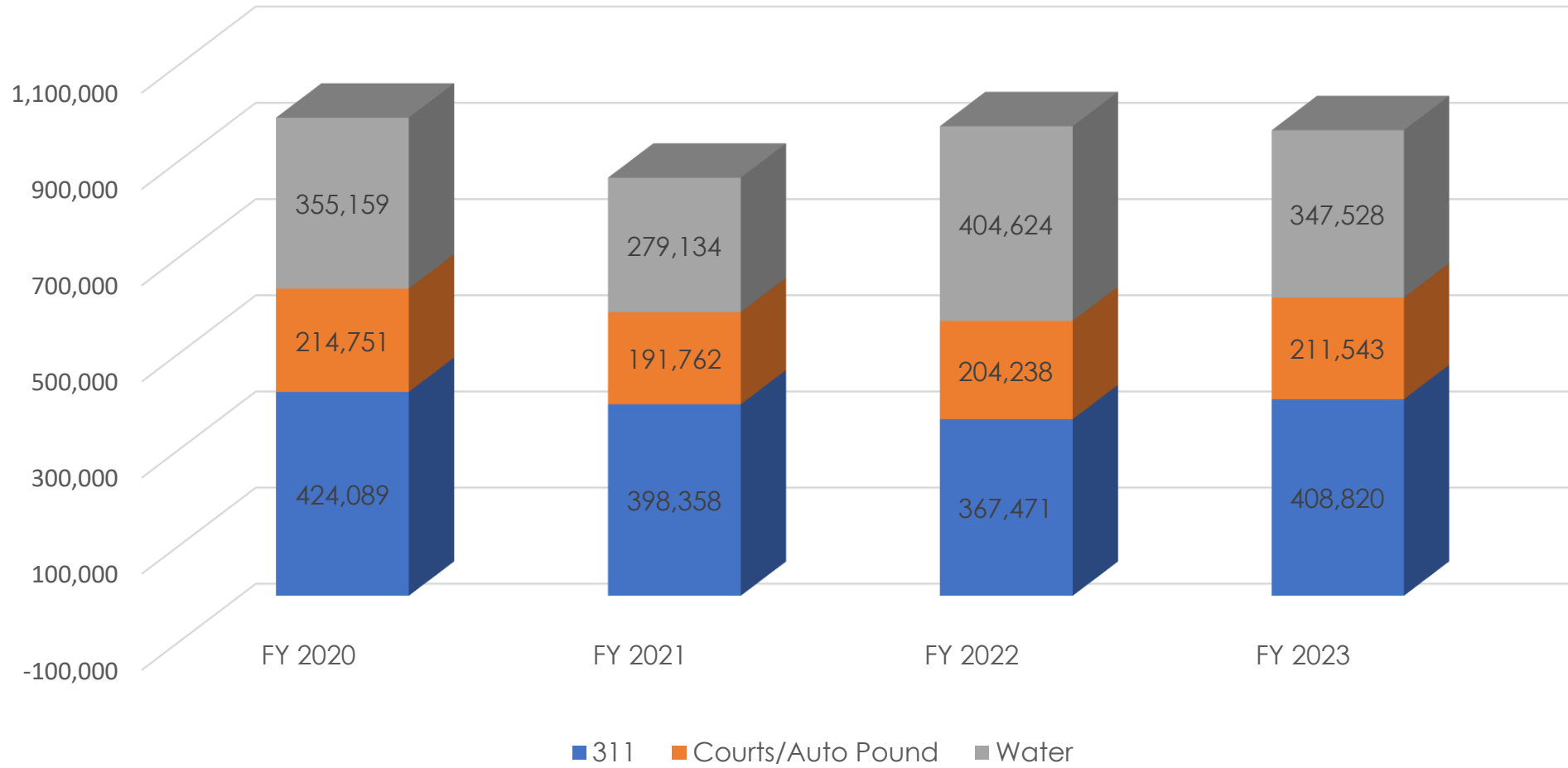

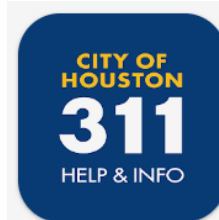

Fluoridation

Unnecessary, Unproven, and Unsafe!

Fluoride's Developmental Neurotoxicity: Lower IQ

“An increase of 0.5 mg/L in water fluoride concentration (approximately equaling the difference between fluoridated and non-fluoridated regions) corresponded to a 9.3- and 6.2-point decrement in Performance IQ among formula-fed.”

Overall, IQ scores dropped “6-7 points”

CDC Oral Health Survey – 3rd Graders

▶ STATES WITH LOWEST CHILDHOOD DECAY:

New Hampshire – 35% decay rate

Vermont – 37% decay rate

▶ BOTH ARE 2 OF THE LEAST FLUORIDATED IN THE COUNTRY! (43rd and 39th respectively)

▶ DECAY IN STATES WITH HIGHEST FLUORIDATION RATE:

Wash DC - 60% decay rate (100% fluoridated)

Kentucky - 60% decay rate (99.8% fluoridated)

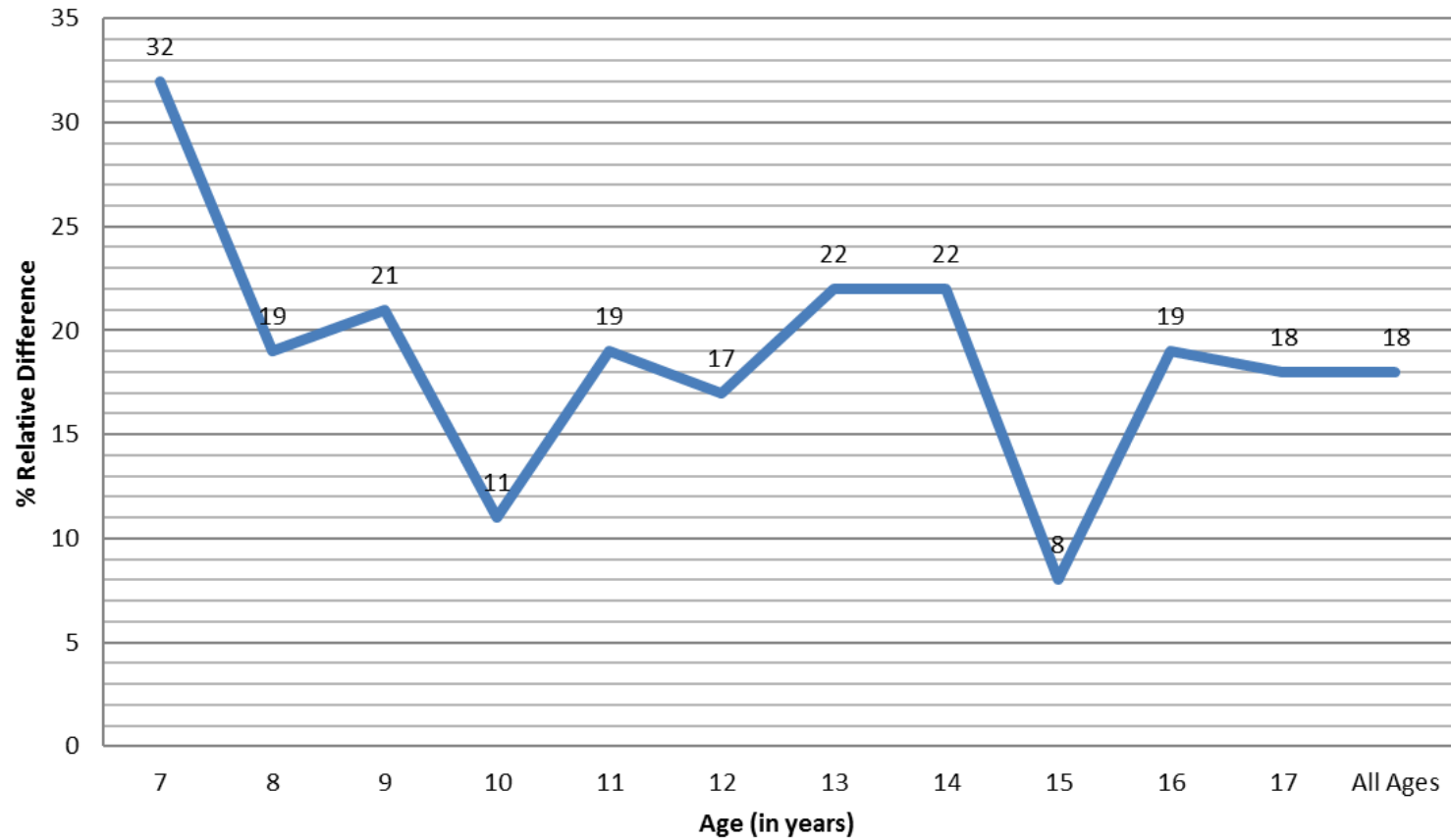

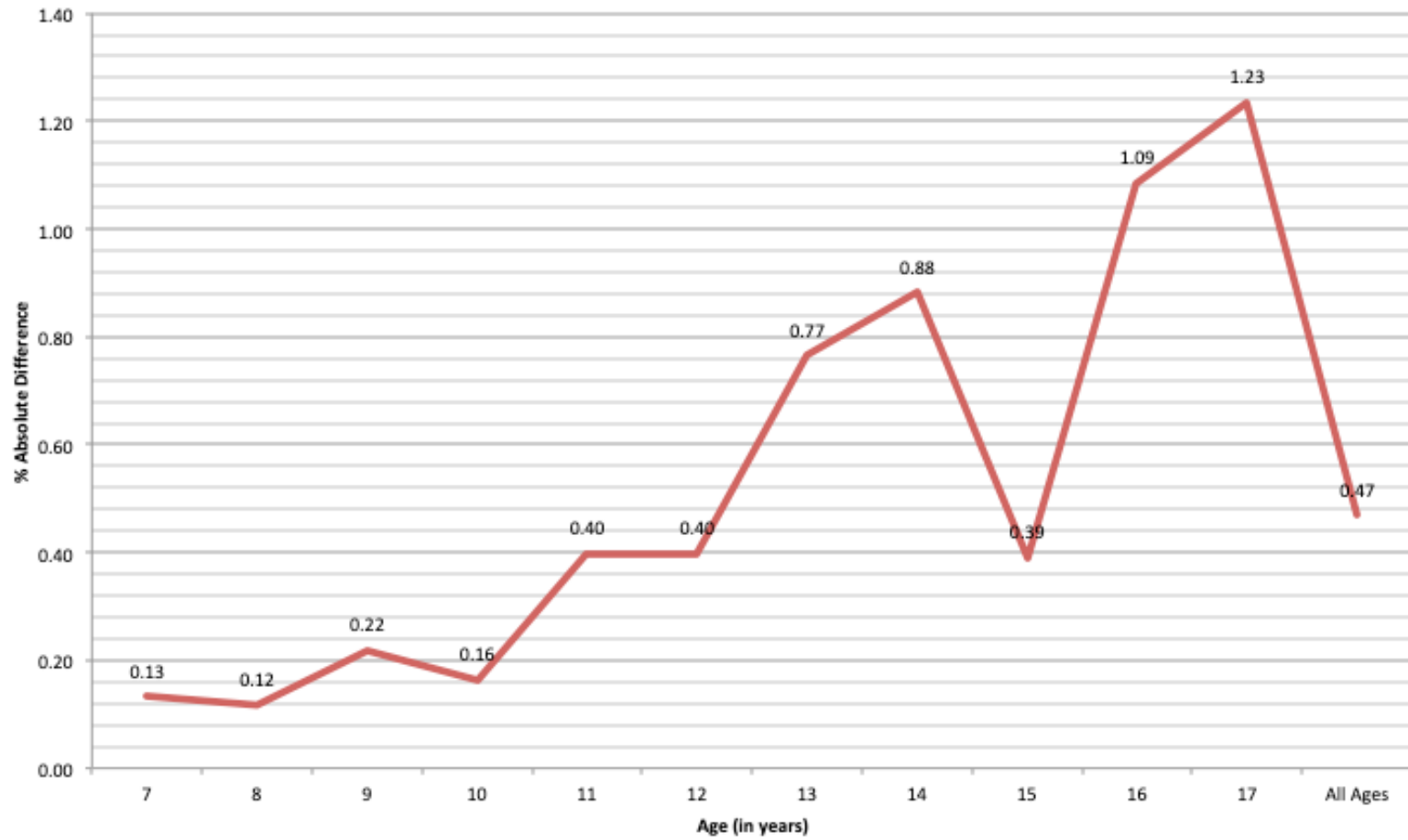
National Institute of Dental Research 1986/87 Landmark Study – Findings?

- ▶ **Carlos and Brunelle** – DMFS (128 tooth surfaces)
 - ▶ 0.6 tooth surfaces amounts to an Absolute difference of less than 1% of the 100-plus tooth surfaces in a child’s mouth. (They touted an 18% difference in decay rates based on a RELATIVE difference quotient)
- ▶ **Yiamouyiannis** – DMFT (28 teeth)
 - ▶ Relative difference of 4%. Absolute difference of less than 1/10th of a tooth.

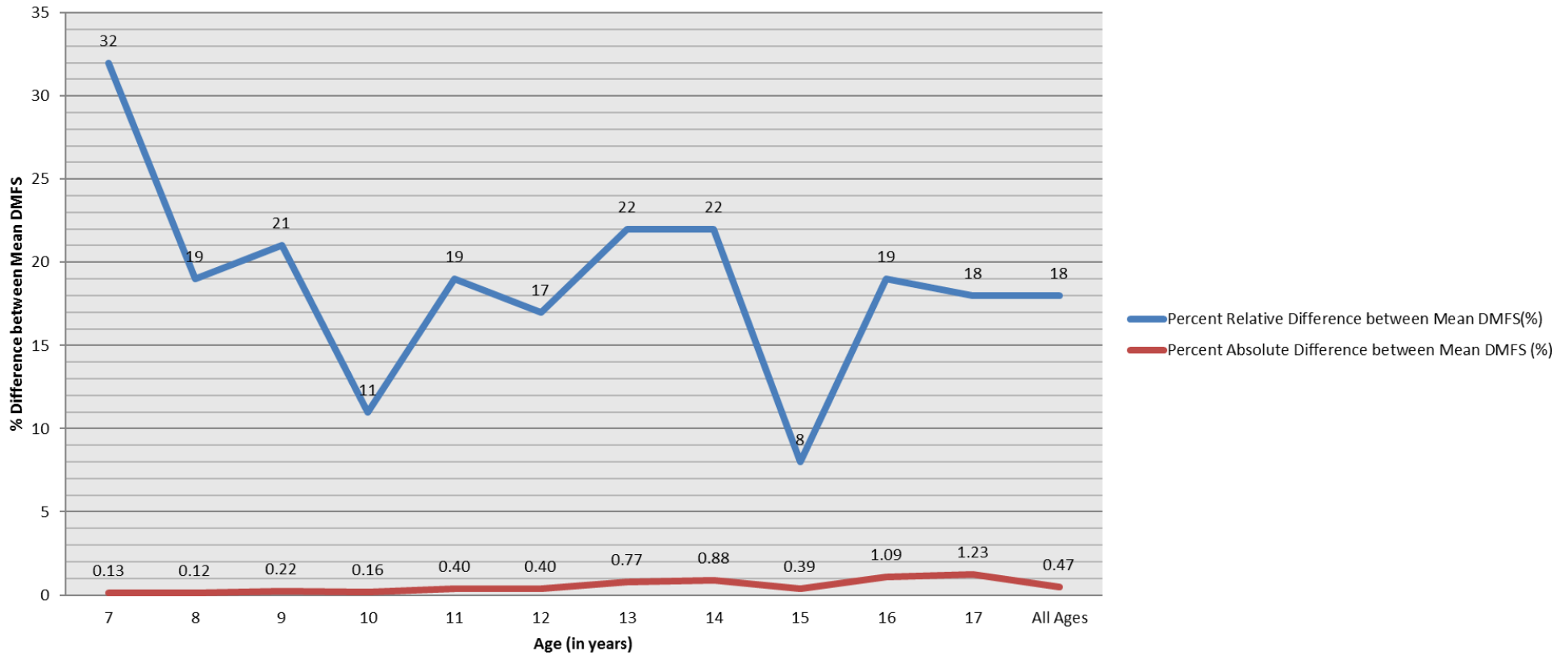
Percent Relative Difference between Mean DMFS vs. Age

Spotlight on Fluoridation in Calgary, Alberta, Canada

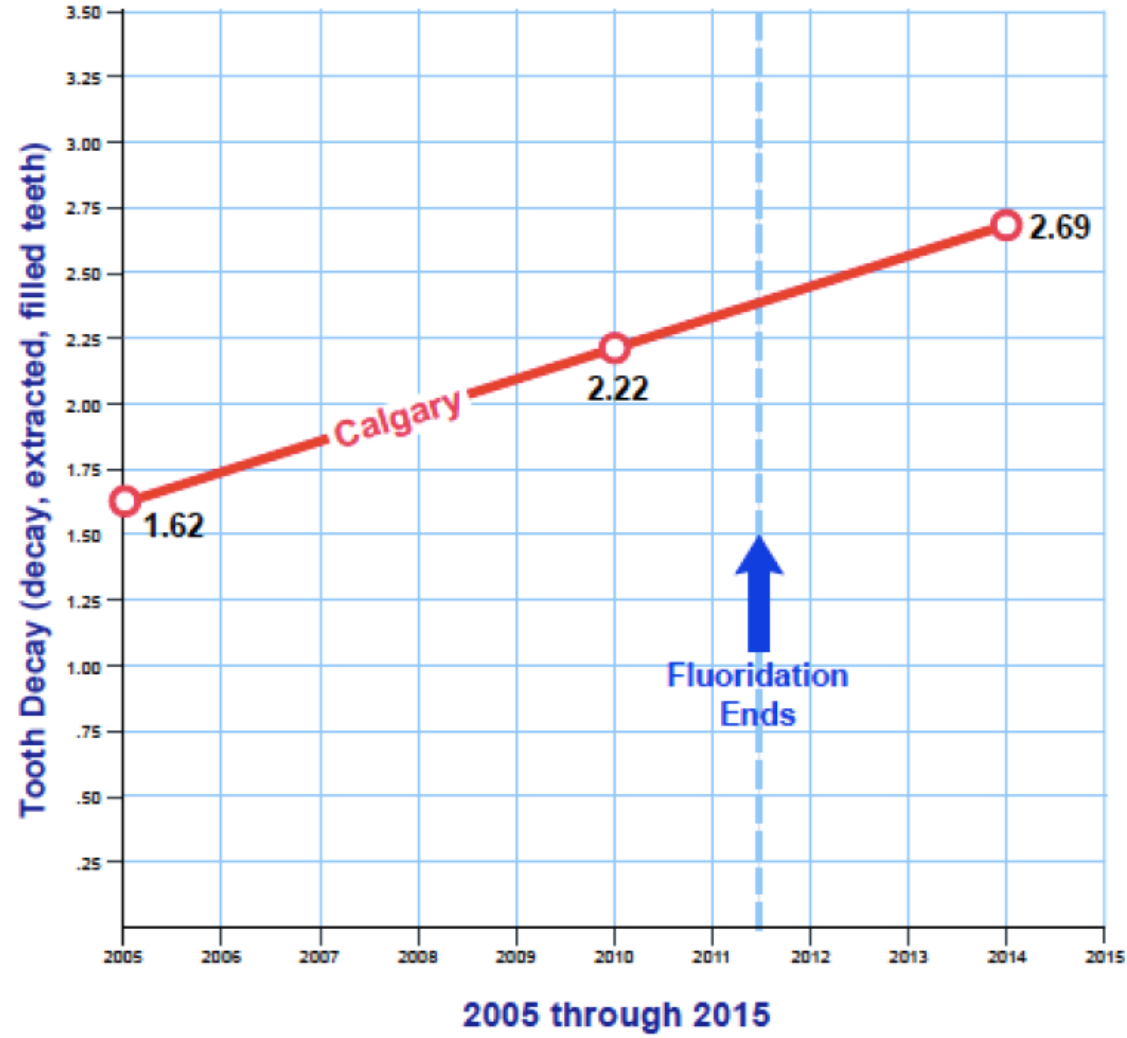


In 2011, Calgary stopped water fluoridation. In February 2019, the Calgary City Council and pro-fluoridation lobbyists directed the University of Calgary's O'Brien Institute for Public Health to conduct a review of fluoridation.

The O'Brien Institute published their report in July, highlighting the neurotoxic risk posed to the fetus by fluoride.

On July 22, the city council voted 13-1 to **cancel** O'Brien's presentation. It was eventually shown to the council.

38.7% of Canadians have fluoridated water (as opposed to 74.4% of people in the US). Fluoridated Edmonton has significantly **HIGHER** decay rates than Calgary.



What about bottle-fed babies?

Human breast milk is very low in fluoride. (.004 ppm f vs .7 ppm– bottle fed baby can get greater than 250 x the level of mother's milk!)

How can you possibly control the dosage??

SUBJECT **Office of Arts and Culture Agenda Item # 23-2601 on November 8, 2023: FY 2023-24 Cultural Organizations Program Contracts**

On November 8, 2023, City Council will consider the Fiscal Year 2023-24 Cultural Organizations Program (COP) contracts with 52 Dallas-based non-profit arts and cultural organizations. The Cultural Organizations Program contracts with cultural organizations with budgets ranging from \$100,000 to over \$10 million to provide an annual season of programming for residents and visitors of Dallas, and the contracts total \$6,255,278. The following page lists the organizations with their recommended contract amounts.

The COP Guidelines, eligibility, scoring, and review process are aligned with Dallas Cultural Plan goals and are approved annually by City Council; following guideline adoption, information sessions are conducted, and organizations apply through an online grant system. The applications are scored by resident panels composed of at least 60% ALAANA (African, Latinx, Asian, Arab, Native American) individuals. Following rigorous review of scores and past funding amounts, the FY 2023-24 funding amounts were unanimously recommended by the Arts and Culture Advisory Commission.

For FY 2023-24, 52 non-profit organizations are recommended for over \$6.25M funding. COP is funded through a combination of the General Fund and Hotel Occupancy Tax. The funding allocation for COP this year includes an 11% or \$636,911 increase due to the growth of the Hotel Occupancy Tax percentage. Seven organizations are recommended for their first COP contracts. Of these, five have annual budgets under \$500,000: Arts Mission Oak Cliff, Flamenco Fever, Orpheus Chamber Singers, OutLoud Dallas, and Ballet North Texas. The other two, Uptown Players and Forest Forward, have budgets between \$1M - \$5M.

SUBJECT **Dangerous & Aggressive Dogs Audit and Ordinance Amendments**

Dallas Animal Services (DAS) requested an audit of its Dangerous and Aggressive Dog Investigation and Determination Process. Based on the audit the following was recommended:

- Set a realistic overall target for completion of the investigation and determination process.
- Develop formal policies and procedures for ensuring owners comply with the requirements for owning dangerous and aggressive dogs.
- Complete the reporting of dangerous and aggressive dogs in the Chameleon system and implement information system internal controls, such as validity, logical access, accuracy, and completeness.
- Recommend the City Council consider technical revisions to Dallas City Code, Chapter 7, Animals, Article V-a. Aggressive Dogs which include:
 - In Section 7-5.15, describe how the noncompliance hearings will be held or remove the words “Noncompliance Hearing,” from the title of the section.
 - In Section 7-5.16 (c), change the responsible party to the Municipal Court.

In response DAS has created and implemented procedures (*DAS-WKI-201.SAF.1*) to outline the investigation and determination process. The process details in part by each stage from the beginning of the process to the determination made by the Director. At each stage parameters are placed to outline the required steps to be taken and time frame for each process.

A second procedure was developed (*DAS-WKI-204.SAF.1*) to outline the owners' requirements for owning a Dangerous and or Aggressive Dog[s]. These policies and procedures have been approved and provided to the appropriate staff.

DAS recently developed and has begun the documentation and tracking of Dangerous and Aggressive Dogs in the Chameleon database system. This allows DAS to track cases through the various stages of the process to ensure accuracy, validity, completeness and timeliness of the process.

The Dallas City Code, Chapter 7, “Animals,” establishes ownership requirements for dogs determined to have injured or threatened a person (dangerous) and dogs determined to have injured another domestic animal or livestock (aggressive).

The City Auditors identified the aggressive dog program as ineffective, because the ordinance needed to ensure owners comply with its requirements, in part due to the current language in the Dallas City Code, Chapter 7, “Animals.”

City Auditors proposed technical changes to Dallas City Code, Chapter 7, “Animals,” pertaining to the aggressive dog hearing requirements.

Two (2) sections of Dallas City Code, Chapter 7, Article V-a, “Aggressive Dogs” create the expectations for compliance court hearings that are not operating as intended due to incomplete language adopted for the ordinance in 2018. Specifically:

- Section 7-5.15 Requirements for Ownership of an Aggressive Dog; Noncompliance Hearing:
 - Currently, this section includes no details about how the noncompliance hearing will be held. Without details, no hearings are held.
 - Amendments made to the requirements for ownership of an aggressive dog; noncompliance hearing; compliance timeframe; financial responsibility; noncompliance hearing requirements; municipal court actions and notifications
- Section 7-5.16 (c) Attacks by an Aggressive Dog:
 - Provides details about how a hearing will be held in municipal court, but incorrectly states the decision will be made by the Director of Dallas Animal Services. Court decisions must be made by the court and cannot be made by a department director.
 - Amendments made to clearly define the role of the municipal court and that of the Department Director.

During further evaluation of Chapter 7, “Animals,” it was recommended the following sections be amended to align with legislative updates made to the Texas Health and Safety Code:

- Section 7-5.5, Requirements for a dangerous or aggressive dog; noncompliance hearing:
 - Amending to include changes in days for compliance requirements, financial responsibilities
- Section 7-5.6, Attacks by dangerous dog; hearing:
 - Amending language and time requirements for disposition
- Section 7-5.12, Definitions:

- Amending to add the definition of a secure enclosure as defined by Texas Health and Safety Code Chapter 822, Subchapter D (4)
- Section 7-5.13, Determination as an aggressive dog:
 - Amending to add language on possession and ownership
- Section 7-8.1, Violations; criminal and civil penalties:
 - Amending to include Sec. 7-5.15 (a)

In providing the recommended ordinance amendments for Chapter 7, “Animals,” which are attached and presented for your review and consideration, DAS has complied with all City Auditor recommendations relative to the Audit of Dangerous and Aggressive Dogs Investigation and Determination Process.
