Upcoming Agenda Item: Al-Powered Camera Technology Contract

The purpose of this memorandum is to inform the City Council that on December 10, 2025, an agenda item authorizing a contract for Al-powered camera technology will be considered by City Council.

This item authorizes a three-year contract with a one (1) one (1) year renewal option with City Detect Inc. for an estimated amount of \$2,556,000, subject to appropriations, for the deployment of 100 Al-enabled data collection units. These units will be mounted on 50 Sanitation brush and bulky waste collection trucks, with cameras positioned on both sides to capture curbside property conditions as part of regular collection routes.

The Department of Sanitation Services, in partnership with Code Compliance Services, will leverage this innovative technology to enhance operational efficiency and better serve the Dallas community.

This technology will provide Sanitation with data on customer participation in the brush and bulky item collection service, which varies by season and location, allowing staff and equipment resources to be better aligned across the city. This will promote more efficient service delivery, reduce unnecessary mileage, and support long-term rate stability for customers. For Code Compliance the technology will provide for automated, citywide visual scans every 30 days, producing real-time, actionable data on conditions such as illegal dumping, graffiti, and structural deterioration. Rather than relying solely on reactive enforcement or complaint-based inspections, this tool will help proactively identify areas in need, allowing staff to focus time and resources where they're most needed.

Beyond direct sanitation and code enforcement applications, the system supports data-informed planning, neighborhood outreach, and grant reporting. The result is a more efficient, service-first approach to community upkeep and education.

Funding for this technology was approved by the City Council in the FY25-26 budget.
