Handgun Prohibition Notice for Meetings of Governmental Entities

"Pursuant to Section 30.06, Penal Code (trespass by license holder with a concealed handgun), a person licensed under Subchapter H, Chapter 411, Government Code (handgun licensing law), may not enter this property with a concealed handgun."

2. deliberating the purchase, exchange, lease, or value of real property if deliberation in an open meeting would have a detrimental effect on the position of the city in negotiations with a third person. [Tex. Govt. Code § 551.072]
3. deliberating a negotiated contract for a prospective gift or donation to the city if deliberation in an open meeting would have a detrimental effect on the position of the city in negotiations with a third person. [Tex. Govt. Code § 551.073]
4. deliberating the appointment, employment, evaluation, reassignment, duties, discipline, or dismissal of a public officer or employee; or to hear a complaint or charge against an officer or employee unless the officer or employee who is the subject of the deliberation or hearing requests a public hearing. [Tex. Govt. Code § 551.074]
5. deliberating the deployment, or specific occasions for implementation, of security personnel or devices. [Tex. Govt. Code § 551.076]
6. discussing or deliberating commercial or financial information that the city has received from a business prospect that the city seeks to have locate, stay or expand in or near the city and with which the city is conducting economic development negotiations; or deliberating the offer of a financial or other incentive to a business prospect. [Tex Govt. Code § 551.087]

7. deliberating security assessments or deployments relating to information resources technology, network security information, or the deployment or specific occasions for implementations of security personnel, critical infrastructure, or security devices. [Tex. Govt. Code § 551.089]
8. deliberating cybersecurity measures, policies, or contracts solely intended to protect a critical infrastructure facility. [Tex. Gov't Code § 551.0761]

History and Mission

The Commission on Disabilities was established in 2021 with a mission to make recommendations on issues pertaining to the full spectrum of needs, rights, and privileges of people with disabilities. The Commission on Disabilities advises the Mayor, City Council, and City departments about issues of importance to people with disabilities, recommending policies and practices to the City regarding the concerns of people with disabilities, and encourages understanding among people with various disabilities to meet the needs of Dallas' diverse community. (City Code 2-152.3 Chapter 2).

Duties and Functions

Pursuant to Section 2-152.3 of the Dallas City Code, the Commission on Disabilities shall be responsible for advising and making recommendations to the Mayor, City Council, City Manager, Department Directors, and the individual designated to the mayor to head the mayor's initiative on disabilities pertaining to the full spectrum of needs, rights, and privileges of people with disabilities. The subjects to be addressed by the Commission on Disabilities include, but are not limited to the following listed below:

- Provide employment opportunities for people with disabilities.
- Address accessibility issues.
- Enhance the quality of life for Dallas residents who have disabilities.
- Address issues pertaining to alcoholism and drug abuse.
- Take full advantage of all federal, state, and local funding opportunities.
- Ensure adequate housing for people with disabilities.
- Ensure accessible communications for people with disabilities.

FY 2025 Objectives and Accomplishments

 - Included brightly colored zigzag stripes over a black background
- Redesigned in 2021 with input from the disability community
- Each color represents a different type of disability:
 - Red – physical disabilities
 - Gold – neurodiversity
 - White – invisible disabilities/disabilities that have not yet been identified
 - Blue – emotional and psychiatric disabilities
 - Green – sensory disabilities (i.e., deafness, blindness, etc.)

Quality of Life and Awareness FY24 Accomplishments

The Commission on Disabilities in its 2024 Annual Report centered its 2025 goal around advancing the quality of life for people with disabilities in Dallas. In fulfillment of that goal, the Commission achieved an important outcome during this last year.

First, advancing quality of life for people with disabilities requires they have avenues to access and voice their concerns to local government leaders. On May 27, 2025, Daisy Fast, Director of the Office of Customer Experience and 311 (CCX/311) briefed the Commission on Disabilities on proposed changes to the City Council Chamber accommodation process with the goal of enhancing accessibility. Proposed changes included new signage, a second public comment station in the back of Chambers, and new accessible floor decals for designated accessible spots in the first row of seating. The Commission not only shared its valuable expertise and insight, but also collaborated with staff as they worked with CCX/311 to finetune signage language and review floor decal options. On August 4, 2025, then-Vice Chair Gay Revi, Technical Advisory Panelist Dr. Priscylla Bento, Daisy Fast, representatives from CCX/311 and Facilities and Real Estate Management (FRM), and staff viewed the implemented changes in Council Chambers. This is an example of the Commission on Disabilities contributing to real-world accessibility improvements that advance equal access and make a tangible difference in the lives of residents.



The Commission on Disabilities reached another important outcome related to a pressing need identified in its 2024 Annual Report—increased awareness and resources

for people with disabilities. On that note, the Commission recognized it was crucial to elevate awareness of disability rights among leadership at the City of Dallas. The Commission followed through on its goal of addressing this need through City Council's recognition of July 2025 as Disability Pride Month. Council Member Adam Bazaldua honored the Commission during City Council's meeting on June 25, 2025 by reading the official Disability Pride Proclamation, which recognizes the invaluable work undertaken by the Commission on Disabilities to raise awareness of disability justice. It was also an important milestone in the City of Dallas to continue ensuring visibility of the needs of people with disabilities in the work of local government.

Proclamation

WHEREAS, The Americans with Disabilities Act (ADA), enacted on July 26, 1990, was a landmark law ensuring civil rights protections to people with disabilities, requiring equal access, reasonable accommodations and freedom from discrimination; and

WHEREAS, The City of Dallas acknowledges the barriers faced by people with disabilities, including societal attitudes and discrimination, and reaffirms its commitment to fostering a community that offers equal opportunities and respect for all and celebrates the equal rights and dignity of people with disabilities by reasserting our unwavering commitment to continue building a community where all residents are afforded the opportunities, independence, and respect they deserve; and

WHEREAS, On December 8, 2021 the Dallas City Council adopted Ordinance No. 32070, establishing the 15-member Commission on Disabilities and since its inaugural meeting the Commission has continued to advise the Mayor, City Council, and City departments on accessibility, and promoting full civic participation of residents with disabilities, exemplifying the spirit of Disability Pride Month and Dallas's dedication to building an inclusive city for all; and

WHEREAS, The City of Dallas appreciates the invaluable effort of local disability rights activists, organizations, and advocates who work tirelessly to advance the rights, independence, and well-being of people with disabilities, and to create a more inclusive and accessible world for all; and

WHEREAS, The City of Dallas recognizes the importance of improving access and inclusion for all of our residents, neighbors, and visitors and demonstrates this commitment, which works to ensure city services, facilities, and communications are accessible to people with disabilities.

NOW, THEREFORE, I, ERIC L. JOHNSON, MAYOR OF THE CITY OF DALLAS, do hereby proclaim July 2025 as

DISABILITY PRIDE MONTH

in Dallas, Texas.

FY 2025 Recommendations for the City of Dallas

Based on all the areas that have been discussed throughout 2025, the Commission on Disabilities recommends that the City of Dallas:

- Commemorate July 2026 as Disability Pride Month by requesting staff seek department, City Manager, and City Council approvals to raise the Disability Pride Flag and hold a flag-raising ceremony to honor the occasion.
- Prioritize accessibility when holding local, national, and international events to ensure an inclusive experience for visitors and that investments made benefit residents in the long-term. As an example, the City of Dallas installed audible crosswalk signals in the vicinity of the Hyatt Regency Dallas when the American Council of the Blind hosted its 64th Annual Convention on July 10, 2025. Advancing accessibility will become especially important as Dallas and North Texas host the FIFA Men's World Cup in the summer of 2026.
- Continue making City Hall accessible for residents and visitors with disabilities ensuring municipal government is open and inclusive for all. The City of Dallas made important progress in this area by improving the City Council Chamber accommodations process, and the Commission recommends additional accessibility improvements including enhanced wayfinding and further accessibility improvements to public restrooms at City Hall.
- Develop a plan to ensure compliance with web content accessibility standards based on WCAG 2.1 AA as the technical standards cities the size of Dallas need to comply with. Because web content is often the medium through which residents learn of City programs, services, and activities, it is important content is accessible, compatible with assistive technologies, and available in other alternative formats.

FY 2026 Proposed Objectives and Accomplishments

The Commission on Disabilities will continue to support and advocate for education, housing, employment, and transportation for people with disabilities. The goal of the Commission for FY 2026 is to focus on the below six key cross-cutting objectives and accomplishments.

1. Advance Human and Civil Rights for Persons with Disabilities

- a. Support and participate in the Human Rights Day and UDHR commemorative event by the City of Dallas and Human Rights Dallas, ensuring inclusion of disability rights as a focus area.
- b. Coordinate briefings and make advisory recommendations on how the Commission on Disabilities can advance the needs of people with disabilities by taking on a human rights-centered approach to its work, while also remaining focused on issues including addiction and others.

2. Promote Disability Awareness, Education, and Civic Inclusion

- a. Plan and support a Disability Pride Month event in July 2026 to recognize the contributions and lived experiences of persons with disabilities.
- b. Partner with external organizations to recognize Disability Employment Awareness Month (October 2026) through public education and outreach.
- c. Host an accessibility awareness session for City departments to highlight barriers, best-practices, and inclusive design.
- d. Increase Commission visibility by participating in City-hosted events across multiple areas of Dallas and provide access to Commission-developed resources.

3. Expand Employment Opportunities, Housing, and Workforce Inclusion

- a. Collaborate with employers, workforce partners, and City departments to advise on inclusive hiring, accommodations, and retention practices.
- b. Explore employment models and systems that advance access to work for persons with disabilities.
- c. Improve access to safe, affordable, and accessible housing as well as community resources through collaborative needs assessments, roundtables, and understanding how the City of Dallas Office of Fair Housing protects housing choice.
- d. Develop a better understanding and provide advisory recommendations on workforce development programs for people with disabilities, including City-led and those of external partners.

- e. Enhance awareness of workplace inclusion, such as through collaborative employment fairs, and make recommendations to the Mayor and City Council on disability inclusion best practices.

4. Understand Accessibility of Infrastructure and Across City Departments

- a. Understand accessibility issues related to sidewalks, including whether existing ordinances require updating based on departments' guidance.
- b. Partner with the City's ADA and sidewalk teams to review how barriers are identified, mitigated, and make potential recommendations to improve the process.
- c. Understand from the City's ADA team the process of facility reviews, how barriers are identified and prioritized, and how upgrades are scheduled based on prioritization and funding.
- d. Receive an update from the Dallas County Elections Department on available accessible voting methods for people with disabilities.
- e. Develop a better understanding of key City of Dallas departments whose work intersects with the ADA, including the below list, and make advisory recommendations on how to enhance accessibility throughout departments' programs and services:
 - i. Office of Economic Development and its workforce development programs;
 - ii. Office of Emergency Management and Crisis Response's Master Emergency Operations Basic Plan;
 - iii. Department of Convention and Event Services and accessibility for visitors;
 - iv. Department of Parks & Recreation's Therapeutic Recreation Program;
 - v. Dallas Public Library and accessible programming (ASL, braille, etc.);
 - vi. Dallas Police Department and Samuel Allen's Law;
 - vii. Office of Housing and Community Empowerment's Home Improvement and Preservation Program;
 - viii. Dallas Fire Rescue's Inspection and Life Safety Education Division;
 - ix. Dallas Water Utilities and its Operation WaterShare program; and
 - x. Office of Customer Experience and Engagement/311's work to advance web content accessibility.

- f. From partnerships with City Departments, track engagement and joint activities.

5. Strengthen Community Engagement and Data-Informed Advocacy

- a. Define charters, workplans and deliverables for selected goals the Commission intends to drive toward in FY26.
- b. Prepare and publish quarterly progress reports (i.e., internal to Commissioners) tracking each key activity status, risk/gap, and next steps.
- c. Conduct community listening sessions or forums to gather input directly from persons with disabilities.
- d. Support the use of online feedback tools or surveys to identify accessibility challenges and service gaps.
- e. Increase accessibility of City facilities, public information, and civic engagement opportunities.
- f. Use community input to inform Commission recommendations, policy guidance, and annual reporting.

6. Enhance Transportation and Mobility Access

- a. Participate in a ride-along with DART on routes that intersect with the North Texas FIFA World Cup footprint to identify potential accessibility improvements and provide feedback for DART's consideration.
- b. Engage with DART during Board meetings to address transportation accessibility, including paratransit performance.
- c. Review transportation-related ADA concerns and emerging mobility access issues, such as transportation network companies.

Texas Open Meetings Act (TOMA)

In general



- “Every regular, special, or called meeting or session of every governmental body shall be open to the public”
- Applies to city council and boards and commissions
- Meetings must be noticed
- Notice must be posted online and on the city’s electronic bulletin board
- Action taken in violation is voidable



Governmental bodies



- Mandatory for every governmental body
- Governmental body includes city council and boards or commissions



Meetings



- Meeting means “deliberation between a quorum of a governmental body...during which public business or public policy...is discussed”
- Deliberate and discuss are synonymous
- Deliberate includes verbal or written exchanges



Walking quorum



When a board member

- knowingly engages in one communication among a series of communications about public business in which the members engaging in the individual communications constitute fewer than a quorum of members but the members engaging in the series of communications constitute a quorum of the members.
- knew at the time the member engaged in the communication that the series of communications:
 - involved or would involve a quorum; and
 - would constitute a deliberation once a quorum of members engaged in the series of communications.



Walking quorum examples



- conducting secret deliberations;
- email communications;
- voting over the telephone; or
- deliberating through a series of closed meetings of members of less than a quorum.



Notice Requirements



- A governmental body shall give written notice of the date, hour, place, and subject of each meeting held by the governmental body.
- Notice must be given at least three business days before the date of the meeting
- Notice must be sufficient to inform the public of the subject matter to be addressed during the meeting.



Additional Notice Requirements



- The meeting location must be accessible to the public as well as:
 - Be in or near the boundaries of the City;
 - Be without special access requirements that prevent public from entering;
 - Provide space for the public to attend; and
 - Provide visual or audio accommodations if requested in advance.



Videoconference



- City officials, city staff, and members of the public may attend an open meeting by videoconference.
- The person presiding over the meeting must be present in a location open to the public.
- City officials, city staff, and members of the public must have both an audio and video feed available in order to participate remotely in an open meeting.
- A city official is considered absent for any portion of an open meeting where the audio or video feed is lost.



Open microphone speakers



- Agenda must give notice of open microphone speakers.
- Open microphone session is *deliberation*.
- The chair or three board members can place an item on the agenda for a subsequent meeting.



Other rules



- A governing body may not adjourn and start a meeting again the same day.
- Governmental body must vote in public.
- No anonymous or secret ballots.
- What if we “forgot to post” an item?
 - It cannot be discussed, except to say: “Would staff please add this to the next agenda.”



Closed Meeting (Executive Session)



Cannot go into closed session unless:

- a quorum first convenes in open session;
- during which the presiding officer publicly announces that a closed meeting will be held; and
- identifies the section under which the closed meeting will be held.

The item must comply with the notice requirements.

Closed meeting may be called for such matters as:

- Attorney consultation (§ 551.071).
- Deliberations about real estate (§ 551.072).
- Economic development considerations (§ 551.087).

Any vote regarding the closed session item must occur in open session



Closed Meeting: Who May Attend?



- Only a governmental body's members have a right to attend a closed meeting.
- Except that the governmental body's attorney must attend closed meetings under the attorney consultation exception.
- Although a governmental body may include others in a closed meeting if they are essential to the matter under consideration, or necessary for the full communication of attorney-client communications, it may not admit a person whose presence is against the interests of the governmental body.



Recordkeeping



- Governmental body must keep minutes or tape recording of the open meeting.
- Minutes must:
 - State subject of each deliberation; and
 - Indicate the vote, order, decision, or other act taken.
- Record of meeting must be available to the public.
- Public is allowed to make audio/visual record of the open meeting, but governmental body may reasonably regulate manner and location.



TOMA Exclusions



- A quorum of a governmental body is permitted to gather without violating TOMA in certain circumstances such as:
 - a social function
 - regional, state, or national convention or workshop,
 - ceremonial event,
 - press conference, or
 - a candidate forum, appearance, or debate to inform the electorate.



TOMA Enforcements



- A civil lawsuit to force officials to comply with TOMA, enjoin officials from acting, or void actions taken in an illegal meeting.
- Any action taken found in violation of TOMA is voidable.
- Certain persons may may bring an action by mandamus or injunction to stop, prevent, or reverse a violation or threatened violation of this chapter by members of a governmental body
- Certain persons may sue for damages, attorney fees, and exemplary damages.
