**WHEREAS**, the Texas Department of Transportation (TxDOT) will provide reimbursement to the City of Dallas for material and labor cost incurred related to the construction of traffic signals at the following intersections: Lancaster Road (State Highway (SH) 342) at Ledbetter Drive (State Loop (SL) 12), Ledbetter Drive (SL 12) at Cockrell Hill Road, Ledbetter Drive (SL 12) at Pastor Pryor Drive, Robert B. Cullum Boulevard (SH 352) at Grand Avenue/Al Lipscomb Way, Robert B. Cullum Boulevard (SH 352) at Metropolitan Avenue, and Robert B. Cullum Boulevard (SH 352) at Martin Luther King Jr. Boulevard, and retiming of directly impacted signals in the area related to the construction; and

**WHEREAS**, TxDOT will reimburse 100 percent of labor and material cost, in the amount of \$662,218.50; and

**WHEREAS**, the City of Dallas desires to enter into an agreement with TxDOT to receive cost reimbursement for material and labor cost incurred for traffic signal improvements.

**Now, Therefore,**

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:**

**SECTION 1.** That the City Manager, or the City Manager's designee, is hereby authorized to execute an agreement with the Texas Department of Transportation through a 2022 Highway Safety Improvement Program grant from the U.S. Department of Transportation Federal Highway Administration (CSJ No. 0048-01-070, etc., Assistance Listing No. 20.205) in the amount of \$662,218.50 to provide cost reimbursement for material and labor incurred by the City related to the construction of traffic signals at the following intersections: Lancaster Road (SH 342) at Ledbetter Drive (SL 12) (CSJ No. 0048-01-070), Ledbetter Drive (SL 12) at Cockrell Hill Road (CSJ No. 0581-02-160), Ledbetter Drive (SL 12) at Pastor Pryor Drive (CSJ No. 0581-02-161), Robert B. Cullum Boulevard (SH 352) at Grand Avenue/Al Lipscomb Way (CSJ No. 0197-01-014), Robert B. Cullum Boulevard (SH 352) at Metropolitan Avenue (CSJ No. 0197-01-015), and Robert B. Cullum Boulevard (SH 352) at Martin Luther King Jr. Boulevard (CSJ No. 0197-01-016), and retiming of directly impacted signals in the area related to the construction, and all terms, conditions, and documents required by the agreement, approved as to form by the City Attorney, or the City Attorney's authorized designee.

**SECTION 2.** That the City Manager is hereby authorized to establish appropriations in the amount of \$662,218.50 in the TxDOT HSIP Signals Reimbursement Lancaster-Ledbetter Fund, Fund F9GB, Department PBW, Unit 70GB, Object 4820.

**SECTION 3.** That the Chief Financial Officer is hereby authorized to receive and deposit funds in the amount of \$662,218.50 in the TxDOT HSIP Signals Reimbursement Lancaster-Ledbetter Fund, Fund F9GB, Department PBW, Unit 70GB, Revenue Code 6506.

**SECTION 4.** That the Chief Financial Officer is hereby authorized to disburse funds in the amount of \$662,218.50 from the TxDOT HSIP Signals Reimbursement Lancaster-Ledbetter Fund, Fund F9GB, Department PBW, Unit 70GB, Object 4820, Program TPF9GB25.

**SECTION 5.** That the City Manager is hereby authorized to reimburse the granting agency any expenditures identified as ineligible and notify the appropriate City Council Committee of expenditures identified as ineligible not later than 30 days after the reimbursement.

**SECTION 6.** That this contract is designated as Contract No. PBW-2025-00028615.

**SECTION 7.** That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
