WHEREAS, the City of Dallas completed a Comprehensive Dredge Management Plan in 2013 to quantify dredging needs across the City; and

WHEREAS, the City of Dallas Water Utilities Department and Dallas Parks and Recreation Department have subsequently identified funding to proceed with the dredging design of 8 sites as the first phase of implementing recommendations from the Comprehensive Dredge Management Plan; and

WHEREAS, engineering services are required for the investigation, preliminary design, permitting, development of construction plans and specifications, bid phase services and construction observation for dredging improvements at these sites to restore stormwater storage capacity and basin functionality; and

WHEREAS, Pacheco Koch Consulting Engineers, Inc., 7557 Rambler Road, Suite 1400, Dallas, Texas, 75231, has submitted an acceptable proposal to provide these engineering services.

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the proposal submitted by Pacheco Koch Consulting Engineers, Inc., in the amount of \$692,237.51 be approved and the consultant be authorized to perform the required engineering services.

SECTION 2. That the City Manager is hereby authorized to execute a contract with Pacheco Koch Consulting Engineers, Inc., approved as to form by the City Attorney, to provide engineering services for dredging improvements to restore stormwater storage capacity and basin functionality at eight locations within the City of Dallas, in an amount not to exceed \$692,237.51.

SECTION 3. That the Chief Financial Officer is hereby authorized to disburse funds in an amount not to exceed \$692,237.51 to Pacheco Koch Consulting Engineers, Inc., in accordance with the terms and conditions of the contract:
