• No minimum off-street parking ratios required for any lot with some portion within 2,640 feet of a light rail or streetcar transit station.

CPC recommendations:

• Except for uses located in an MD-1 Modified Delta Overlay, in existence on 2025 [at passing of this ordinance]: No parking required when located within structures designated as a Recorded Texas Historic Landmark, State Antiquities Landmark, National Historic Landmark, local historic landmark, or local historic district, except that alcoholic establishments, restaurants, and commercial amusement inside and outside, if located within 300 feet of a single-family or duplex use, may have a different parking ratio established by an SUP for the purpose of determining if any parking is required to make the use more compatible with the surrounding area.

Except for uses located in an MD-1 Modified Delta Overlay, in existence on 2025 [at passing of this ordinance]: No parking required for any use when located within structures designated as a Recorded Texas Historic Landmark, State Antiquities Landmark, National Historic Landmark, local historic landmark, or local historic district.
