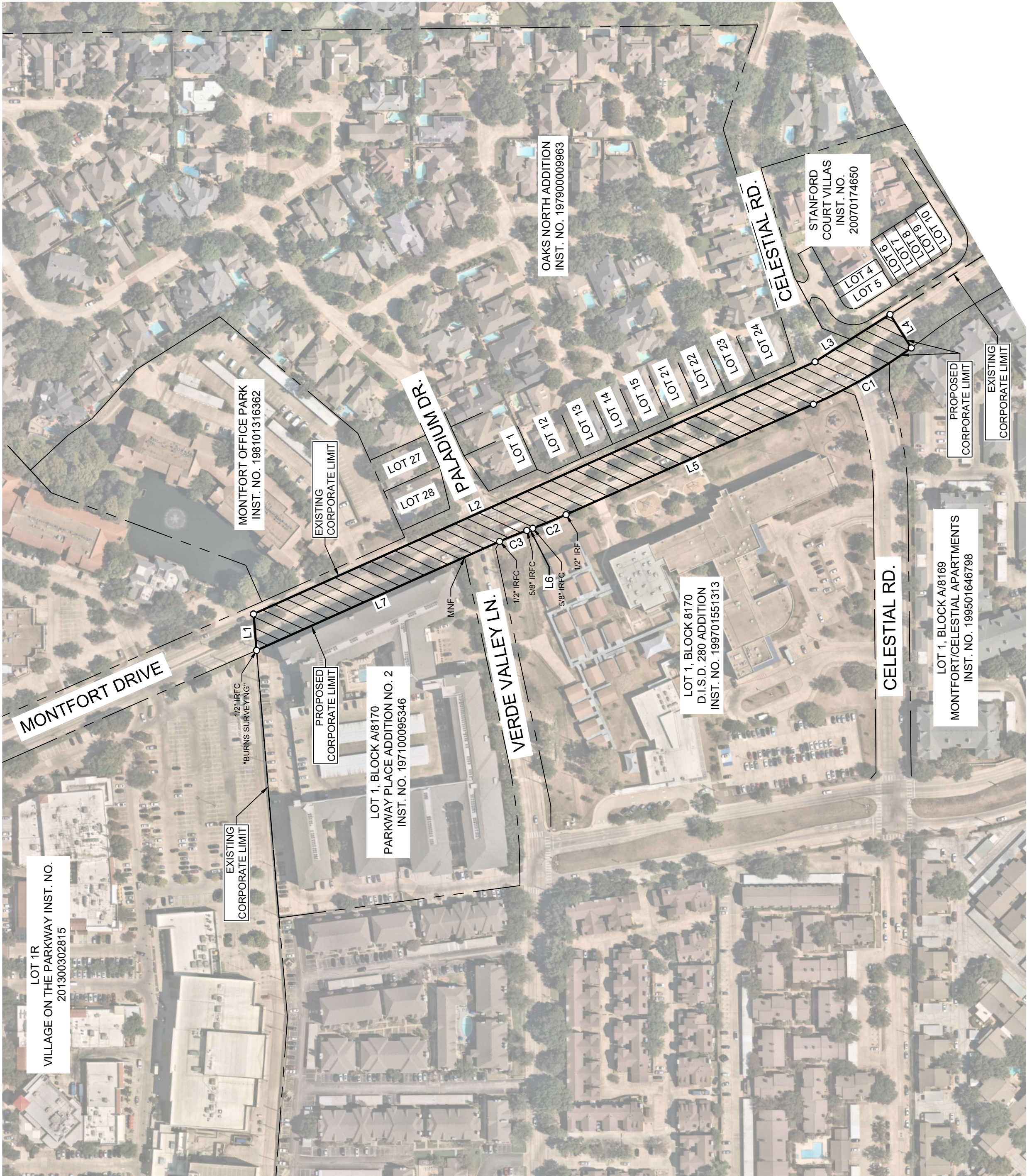

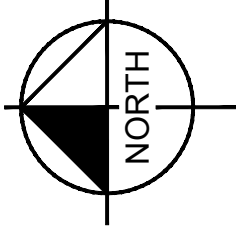

LEGAL DESCRIPTION

BEING a 2.1282 acre (92,704 square foot) tract of land situated in the Allen Bledsoe Survey, Abstract No. 157, and the Thomas Garvin Survey, Abstract No. 524, Dallas County, Texas, and being a portion of Montfort Drive, a variable width right-of-way, and being more particularly described as follows:

COMMENCING at a 1/2-inch iron rod with cap found for the northwest corner of Lot 1, Block A/8170, Parkway Place Addition No. 2, an addition to the City of Dallas, Dallas County, Texas according to the plat recorded in Instrument No. 197100095346, Deed Records, Dallas County, Texas;

THENCE North 85°12'22" East, along the north line of said Lot 1, a distance of 505.02 feet to a 1/2-inch iron rod with "BURNS SURVEYING" cap found at the **POINT OF BEGINNING**;

THENCE North 85°12'22" East, a distance of 68.72 feet to a point for corner in the existing corporate city limit line as shown on the Town of Addison Boundary Drawing prepared by Garcia & Associates, dated April 11, 1997;

THENCE South 24°11'23" East, along the said corporate city limit line, a distance of 1,158.82 feet to a point for corner;

THENCE South 32°18'04" East, continuing along the said corporate city limit line, a distance of 167.13 feet to a 5/8-inch iron rod with "KHA" cap set for corner;

THENCE South 57°41'56" West, a distance of 74.77 feet to a 5/8-inch iron rod with "KHA" cap set for corner in the west right-of-way line of said Montfort Drive, and being the beginning of a non-tangent curve to the right with a radius of 1,040.00 feet, a central angle of 11°43'26", and a chord bearing and distance of North 29°54'55" West, 212.43 feet;

THENCE along the said west right-of-way line, the following six (6) calls:

In a northwesterly direction, along said non-tangent curve to the right, an arc distance of 212.81 feet to a 5/8-inch iron rod with "KHA" cap set for corner;

North 24°03'12" West, a distance of 510.11 feet to a 1/2-inch iron rod found for corner, being the beginning of a tangent curve to the right with a radius of 1,040.00 feet, a central angle of 03°43'07", and a chord bearing and distance of North 22°11'39" West, 67.49 feet;

In a northwesterly direction, with said tangent curve to the right, an arc distance of 67.50 feet to a 5/8-inch iron rod with cap found for corner;

North 20°20'05" West, a distance of 12.17 feet to a 5/8-inch iron rod with cap found for corner, being the beginning of a tangent curve to the left with a radius of 960.00 feet, a central angle of 03°17'54", and a chord bearing and distance of North 21°59'02" West, 55.26 feet;

In a northwesterly direction, with said tangent curve to the left, an arc distance of 55.27 feet to a 1/2-inch iron rod with cap found for the northeast corner of Lot 1, Block 8170, D.I.S.D. 280 Addition, an addition to the City of Dallas according to the plat recorded in Instrument No. 199701551313, said Deed Records;


