**WHEREAS**, on May 25, 2022, the City Council authorized (1) a three-year service price agreement for the maintenance and repair of butterfly valve actuators for the Water Utilities Department with Machining and Valve Automation dba MVA Services, Inc. in the estimated amount of \$1,413,250.00 and (2) a three-year master agreement for the purchase of butterfly valves, parts and actuators for the Water Utilities Department with Municipal Valve & Equipment Company, Inc. in the estimated amount of \$1,631,000.00, Mueller Co., LLC in the estimated amount of \$436,000.00 and Macaulay Controls Company in the estimated amount of \$40,000.00, by Resolution No. 22-0808.

**Now, Therefore,**

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:**

**SECTION 1.** That the City Manager is hereby authorized to execute a service price agreement with Municipal Valve & Equipment Company, Inc. (332290) in the estimated amount of \$772,000.00 and Machining & Valve Automation Services, LLC dba MVA Services (VS0000070562) in the estimated amount of \$707,000.00, approved as to form by the City Attorney, for the maintenance and repair of butterfly valve actuators for the Dallas Water Utilities Department for a term of three years, in the total estimated amount of \$1,479,000.00. The amount payable pursuant to this service price agreement may exceed the estimated amount but may not exceed the amount of budgetary appropriations for this service price agreement during its term. Payments made to Municipal Valve & Equipment Company, Inc. and Machining & Valve Automation Services, LLC dba MVA Services and shall be based only on the amount of the services directed to be performed by the City and properly performed by Municipal Valve & Equipment Company, Inc. and Machining & Valve Automation Services, LLC dba MVA Services and under the service price agreement. The City Manager is further authorized, in the City Manager's sole discretion, to exercise an option to extend the agreement for six months by filing a notice of extension with the City Secretary's Office.

**SECTION 2.** That a master agreement for the purchase of butterfly valves, parts and actuators for the Dallas Water Utilities Department is authorized with Mueller Water Products, Inc. dba Echologics LLC, Mueller Co LLC, Henry Pratt Company, LLC (VS0000071560) in the estimated amount of \$523,500.00, J&S Valve, Inc. (VS0000036556) in the estimated amount of \$435,000.00, and Macaulay Controls Company (168609) in the estimated amount of \$59,400.00, approved as to form by the City Attorney, for a term of three years, in the total estimated amount of \$1,017,900.00. The amount payable pursuant to this master agreement may exceed the estimated amount, but may not exceed the amount of budgetary appropriations for this master agreement during its term. The City Manager is further authorized, in the City Manager's sole discretion, to exercise an option to extend the agreement for six months by filing a notice of extension with the City Secretary's Office.

**SECTION 3.** That the Purchasing Agent is authorized, upon appropriate request and documented need by a user department, to issue a purchase order for butterfly valves, parts and actuators for the Dallas Water Utilities Department. If a written contract is required or requested for any or all purchases of butterfly valves, parts and actuators for the Dallas Water Utilities Department under the master agreement instead of individual purchase orders, the City Manager is hereby authorized to execute a contract, approved as to form by the City Attorney.

**SECTION 4.** That the Chief Financial Officer is hereby authorized to disburse funds in an estimated amount of at least \$2,496,900.00, (subject to annual appropriations), but not more than the amount of budgetary appropriations for these agreements during their term to J&S Valve, Inc., Macaulay Controls Company, Machining & Valve Automation Services, LLC dba MVA Services, Municipal Valve & Equipment Company, Inc., and Mueller Water Products, Inc. dba Echologics LLC, Mueller Co LLC, Henry Pratt Company, LLC from Agreement No. DWU-2025-00027970

**SECTION 5.** That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
