WHEREAS, on January 12, 2022, the City Council authorized a professional services contract with Lockwood, Andrews & Newnam, Inc., for engineering evaluations, preliminary design, development of construction plans and specifications, bid phase services, construction administration and start-up associated with non-potable water system improvements at the Central Wastewater Treatment Plant, in an amount not to exceed \$3,397,000.00, by Resolution No. 22-0161; and

WHEREAS, additional services are required for engineering evaluations, preliminary design, development of construction plans and specifications, bid phase services, construction administration and start-up associated with non-potable water system improvements at the Central Wastewater Treatment Plant; and

WHEREAS, Lockwood, Andrews & Newnam, Inc., 8350 North Central Expressway, Suite 1400, Dallas, Texas 75206, has submitted an acceptable proposal to provide these additional services; and

WHEREAS, Dallas Water Utilities Department recommends Supplemental Agreement No. 1 to Contract No. DWU-2021-00017047 be approved, and that said Contract be increased by \$1,109,430.00 from \$3,397,000.00 to \$4,506,430.00

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the proposed Supplemental Agreement No. 1 to the professional services contract be accepted and that Contract No. DWU-2021-00017047, between the City and Lockwood, Andrews & Newnamman, Inc., be revised accordingly.

SECTION 2. That the City Manager be and is hereby authorized to execute Supplemental Agreement No. 1 to the professional engineering services contract with Lockwood, Andrews & New<u>namman</u>, Inc., approved as to form by the City Attorney, to provide additional services required for engineering evaluations, preliminary design, development of construction plans and specifications, bid phase services, construction administration and start-up services associated with the non-potable water system improvements at the Central Wastewater Treatment Plant, in an amount not to exceed \$1,109,430.00, increasing the original contract amount from \$3,397,000.00 to \$4,506,430.00.

SECTION 3. That the Chief Financial Officer is hereby authorized to disburse funds in an amount not to exceed \$1,109,430.00 to Lockwood, Andrews & Newnam, Inc., from the Wastewater Capital Improvement Fund, Fund 4116, Department DWU, Unit PS42, Object 4111, Program 721110, Encumbrance/Contract No. CX-DWU-2021-00017047, Vendor VS0000075003.
